At least 11 people were killed and nearly 200 injured on Wednesday when two Los Angeles commuter trains collided after one struck an automobile left on the tracks in what authorities called an aborted suicide attempt by a "deranged" man.

Police and fire officials said the man slashed his wrists and stabbed himself in the chest shortly before parking his Jeep Cherokee on the tracks. But he jumped clear at the last moment and watched as the two high-speed trains smashed together and derailed in a fiery wreck.

The man was identified by police as Juan Manuel Alvarez, 25. He was found wandering the scene after the predawn accident, muttering: "I'm sorry, I'm sorry," according to a local television report. Police said the man, who was uninjured in the crash, was arrested and would be charged with atleast 10 counts of murder.

Los Angeles County District Attorney Steve Cooley said decisions about charging the suspect would be made by Friday

Glendale Police Chief Randy Adams said Alvarez admitted parking on the tracks with the intention of killing himself, but apparently changed his mind and fled as one of the commuter trains bore down on

his Jeep.
"He was very distraught and upset and realised that he caused a major disaster," Adams told a news

The commuter trains also struck a parked freight train, sparking a brief fire. The collision occurred just after 6 a.m., near a shopping strip at the edge of an industrial area near Glendale, north of downtown Los Angeles.

About 125 people hurt in the train wreck were hospitalized, and 60 others were treated for minor injuries and released, fire officials said. Ten people initially reported dead included a sheriff's deputy and a train conductor. An 11th body was retrieved from the wreckage in the evening, said Francisco Oaxaca, spokesman for Metrolink.

Metrolink, the Southern California commuter rail service that operates the train tracks, said it was the worst accidentinits 13-year history.

The impact sent passengers flying through the trains and landng on top of one another. Firefighters found bleeding passengers walking dazed amid a tangle of twisted wreckage and scattered shoes, briefcases and gravel. Some survivors were pushing others in shopping carts taken from an adja-

## Rice confirmed despite Democrats' criticisms

Condoleezza Rice won confirmation as secretary of state Wednesday despite blistering criticism from Senate Democrats who accused her of misleading statements and said she must share the blame for mistakes and war deaths in Iraq.

The tally, though one-sided at 85-13, was still the largest "no" vote against any secretary of state nominee since 1825.

Rice was sworn-in seven hours later by White House Chief of Staff Andrew Card in his West Wing office. Her designated replacement as national security adviser, Stephen Hadley, held the Bible. Bush planned to attend a ceremonial swearing-in Friday at the State Department.

Separately, a Senate committee narrowly voted to send Alberto Gonzales' attorney general nomination to the full Senate, Jim Nicholson and Michael Leavitt won confirmation as the new secretaries of veterans affairs and health and human services respectively as President Bush's second-term Cabinet fills

Rice, Bush's national security adviser for four years and perhaps his closest adviser on the war and terrorism issues that dominated his first term, becomes the first black woman to be America's top diplomat. She succeeds Colin Powell, a former Army general who clashed privately with some of the strongest hawks in Bush's inner circle.

As a metropolis, Baghdad is divided over Sunday's watershed general election, as Shia Iraqis express their determination to vote while Sunni neighbors turn away in disenchant-

"If I don't vote in the elections, I will go to hell," says Mohammed Ali Kadumi, 56, a tailor in the bustling, mainly Shia shopping district of

Kadamiya. Shia religious authorities in the holy city of Najaf "issued a fatwa (religious edict) to take part in the elections, so I have to, "he says.

Down the street, smartly dressed gold merchant Hassan al-Awadi, 28, says he backs the front-running Shia list, the United Iraqi Alliance. "It's the best for Shias, but I also

expect most Sunnis to take part," he says, playing down Sunni leaders' calls to boycott the election. Like most of Iraq's longoppressed Shia majority, who make

lation, grocer Jawad Qassem, 48, is also optimistic. The elections mean democracy and freedom, and it's an order from Najaf to vote, so I will go to the polling station with my sons and my brothers, I hope all the problems will
