Hundreds line up to resist move to shift gas plant from Ashuganj

All-party Action Committee formed to cancel decision to shift NGL Fractionation Plant of Rupantarito Natural Gas Company to Koilastila, Sylhet by March 10

Hundreds of people came down the Dhaka-Sylhet highway here on Wednesday to protest a decision to shift the NGL Fractionation Plant of Rupantarito Natural Gas Company from Ashugani here to Koilastila in

Part of the highway from Ashuganj toll plaza to Sunarampur village were crowded with people from all walks of life including political figures, teachers and students of different schools and colleges and businessmen to express their solidarity with the resistance movement called by the All-party Action

Led by the Action Committee convenor Md Isa Khan, people lined up by hundreds near Ashuganj toll plaza forming a human chain.

Later, they held a rally at Ashugonj Rail Gate field with the Action Committee convenor Md Isa Khan in the chair

A month-long programme was announced from the rally to prevent shifting of the plant. They expressed their firm determination to resist the evil move 'even by shedding their

The speakers demanded of the authorities concerned to cancel the decision of shifting of the plant by March 10, otherwise, they declared to forge a tougher agitation including hartal (strike). They declared to stop the Ashugani Power Plant and the Zia Fertilizer Company Limited.

Drivers ply their vehicles with great risk along the portion of the highway, but the Roads and Highways Department (RHD) did not take any step to save lives and people's property.

Ignoring the issue, work along the aforementioned part of the highway had been progressing. The RHD undertook the project at a cost of Tk 50 lakh. Forty per cent of the work had already been completed, according to the RHD sources.

When contacted with the RHD executive engineer, he told The Daily Star about lack of provision for extension of the highway in the project profile.

Checkpoint in Kutchbihar by India has created lots of problems for hundreds of Bangladeshi passport holders intending to visit India for treatment or for reunion with their

Local people have demanded reopening of the route immediately through bilateral talks of high officials of both the countries.

Chilahati Land Customs Checkpoint here became inoperative due to the Indian Immigration authorities' unilateral decision on June 28, 2002. The international transit route had been in use for the outgoing and incoming travellers of both the countries during the 1953-2002 period. Every year thousands of people used to travel through the route, according to locals.

A large number of Biharis (Urdu speaking people) living in Saidpur Railway City face problems to meet their relatives in India. They had come to Bangladesh as refugees after partition of the sub-continent in

Chilahati Land Customs Checkpoint officials tried to persuade their Indian counterparts to reopen the route but in vain

The BSF members along with about 200 hundred Indian people were erecting the barbed wire on 'No Man's Land' near Anwarpur village at around 8 am on the day. Being informed, local villagers and the BDR 'jawans' intervened. As a result, the BSF stopped erecting the illegal fence temporarily.

According to the BDR sources, the BSF also started erecting barbed wire fence on the 'No Man's Land near Kashinagar village on Wednesday. The BSF stopped erecting the fence due to

According to the BDR sources, the BSF also attempted to erect barbed wire fence on 'No Man's Land along Border Pillers No 2019 (85) and 2019 (95) in Azampur, Akhaura on February 6. The BSF also tried to erect barbed wire fence near Border Piller No 2018 (45) and 2018 (55) at Rajapur village in

Following the BDR protest, the BSF stopped erecting the fences.

Two villagers named Jahangir Alam, 50, and Farid Mia, 39, of Anwarpur told this correspondent that the BSF along with Indian villagers tried to erect barbed wire fence on 'No Man's Land' here on several occa-

However, the BDR already sent a letter to the BSF to stop erecting illegal barbed wire fence on 'No Man's Land.

A move is underway to hold a BDR-BSF flag meeting, according to official sources in the BDR.
