"Under the circumstances, the government announces enforcement of ban on all activities of Jagrata Muslim Janata Bangladesh and Jama'atul Muhjahideen. Their so-called leader Dr Asadullah all Galib has already been arrested. Meanwhile, police has been ordered to intensify their activities to arrest JMJB leader Bangla Bhai, the press-note read.

Explaining the background of the tough government stance, the press-note said in the recent past several incidents of attacks, bomb attacks and blasts have been carried out on different social, cultural and religious functions and several branches of Brac and Grameen Bank in different areas of the coun-

It said the incidents prompted the government to intensify police vigil all over the country, resulting in the red-handed' arrest of a number of suspects in Bogra, Joypurhat Sirajganj, Gaibandha, Moulvibazar, Gopalgani, Dhamrai and Savar, The police operations also led to seizure of explosives and 'objectionable
