BB unveils step to check volatile call money market

NBFIs won't be allowed to borrow more than 15pc of paid up capital from July 1

The non-bank financial institutions (NBFIs) will not be allowed to borrow more than 15 percent of their paid up capital from call money market with effect from July 1, 2005.

The Bangladesh Bank in a circular yesterday imposed the restriction to minimise risks of the NBFIs and check bullish trend in the call money market. The NBFIs heavily depend on call money market for short-term funding.

UNB adds: Under the circum stances, the central bank advised

such borrowers to utilise alternative long-term funding sources such as credit line, mortgage-based securitisation and asset securitisation to avert asset-liability mismatch in the

The call money market has been witnessing volatility since mid-January with the rate hitting as high as 70 percent. Bangladesh Bank officials considered the rates abnormal taking into account the wide difference of the range--from a normal 7 percent to an abnormal 70

Dealers said mainly fundstrapped institutions, particularly the leasing companies, jacked up the rates while the commercial banks having excess liquidity took the advantage to have a windfall.

The overheated market, however, corrected down over the period of time, they added. The private banks vesterday lent money highest at 25 percent while state-run banks at 11 percent.

The central bank, at bankers' meeting recently, warned commercial banks of stern legal and administrative actions to stop them from taking the fund-strapped banks and non-bank financial institutions for a

Some banks allegedly behaved abnormally and took advantage of the unruly market to make it overheated, the central bank pointed

Belying the central bank's warnings, the call money rates again went up in last couple of days, registering a maximum of 40 percent on Monday

Siemens plans cost-cutting in mobile phones division

German electronics giant Siemens said on Tuesday it was planning to cut costs in its phone mobile handsets division, where it is losing both money and market share.

Siemens said in a statement it was planning "triple-digit" millions of euros (dollars) in cost-cutting in the division, without specifying further.

Nevertheless, the group had not yet decided the fate of the division. Possible options include a sale, restructuring, closure or coopera-

tion with a partner. Siemens, which runs its business year from October to September, booked operating loss of 143 million euros (189 million dollars) in its mobile handsets division in the three months to December.

Local railway sleeper cos seek govt help to tap export potential

Embargo on log transportation

Rangamati timber traders form human chain today

Timber traders and tribal tree planters of Rangamati will form a human chain in the town today demanding reopening of log transportation from Asking the government to meet

The leaders blamed the state minister for patronising a 'syndicate' run by his son Jahirul Islam Choudhury, owner of Ankhi Enterprise in Chittagong, who imported some 10 to 12 lakh cubic feet logs. By stopping TP they have taken timber traders hostage, and they are now trying to gain huge profit from selling the imported logs at local market.

India plans biggest tax reform

India will push ahead with its mostambitious tax reform ever next month even if some of its 28 states fail to sign up, the head of a committee of state finance ministers said in reports Tuesday. Asim Dasgupta, chairman of the

panel, said Value Added Tax (VAT) will come into force April 1, although several states including the mostnonulous Uttar Pradesh are hesitant about signing up, reports said.

"Make no mistake about it. VAT will not be deferred, irrespective of whether Uttar Pradesh joins, Dasgupta said after a marathon meeting of state finance minister late Monday, the Press Trust of India reported.

Uttar Pradesh has 120 million people.

The tiny eastern state of Jharkhand has also said it is not ready to join VAT while western Rajasthan and central Madhya Pradesh are expressing doubts.

The tax, agreed at a meeting of state finance ministers in New Delhi in June, is designed to cut multiple layers of other taxes, boost revenues, reduce inter-state barriers to trade and make accounting more transparent.

Lake City Concord opens

Tk 4.5 lakh apartments available

A leading real estate company yesterday inaugurated a satellite township on the outskirts of Dhaka city, offering the cheapest apartments in Bangladesh.

Concord Real Estate & Development Ltd offers a 450square-foot apartment at a price as low as Tk 4.5 lakh at the township named 'Lake City Concord' located at Namapara, Khilkhet.

The Tk 4.5 lakh-apartments are the cheapest in Bangladesh. A 1,500-square-foot flat, which is the largest in the project, is priced at Tk

Concord Real Estate, one of the few companies that started real estate development in late 1970s yesterday handed over 330 flats of the township, which will have 18 buildings, 16-storey each, upon its completion by 2008

Because of being affordable for middle class people, the company has already been able to sell 2,000 out of 3,400 apartments in the township, 1.5 km east of Khilkhet bus stoppage and beside Rajuk's Purbachal housing project.

At a function at the project site, State Minister for Expatriate Welfare and Overseas Employment Md Quamrul Islam and Chairman of Concord Group SM Kamaluddin inaugurated the first phase of the township.

Addressing the function, the state minister, also an MP from khilkhet locality, said as burgeoning population shrinks per capita land to only 16 decimals, the land-strapped country must explore vertical expansion for housing solution.

"Private sector must lead in real estate business for providing housing solution for common people," he said. Referring to certain statistics, Islam said the private sector companies have so far handed over 80,000 apartments.

Amid growing demand, the annual turnover of real estate industry hits Tk 7,500 crore. The industry also contributes Tk 750 crore to the government exchequer n terms of taxes, he said.

Talking on possible link between filling of low-lying areas on outskirts of the capital and water-logging in Dhaka, he said the government through a master plan should identify and demarcate the low-lying areas so that investment of real estate companies is not put at risk.

"Unless the government demarcates low-lying areas, developers cannot take up projects on the fringes of the city, which is needed to provide living places for teeming urban population," he said.

At the function, Concord Group chairman said the company has used, for the first time in Bangladesh, 'aqua-bio compact system' in the project to manage numan and other wastes. Reinforced concrete block

masonry has been used in the building, a technology used in US, Canada and other developed countries, to withstand earthquake "Installment for a flat is as low as
