Corruption in OMS dealership alleged

OMS (Open Market Sale) of rice has failed to bring down its price in different markets here even after 17 days of its launching. Alleged politicisation in alloting OMS dealership, bribery of food officials and black marketing of rice are the main reasons behind the failure. According to wholesale rice traders, coarse rice is being sold here at Tk 18 per kg and fine rice at Tk 24 per kg. An OMS dealer of Bhaina in the town, Siddik Mosharaf Hossain brought an allegation of bribery against Magura Sadar Upazila Food Controller (UFC) to the Deputy Commissioner (DC) and the district OMS committee president. According to the allegation, the UFC is giving DO (Delivery Order) letters to the dealers of Magura Sadar upazila and municipal area in exchange of Tk 5,000 as bribe. He further alleged a few unscrupulous dealers in connivance with the UFC are selling OMS rice in black markets. When contacted with Magura Sadar UFC Habibur Rahman, he denied all the allegations brought against him.

Killing protested by erecting highway blockade

Road communication on the Rangpur Bogra highway was disrupted for eight hours as transport workers erected barricade on it protesting murder of a driver and hijacking of his car on Sunday night. Car driver Abul Kalam Azad was strangled by unknown assailants at Kalitola bridge. The assailants were travelling by the car in guise of passengers, according to police. They rented the car from Shawdhin Renta-Car of D B road telling their intention to visit Bogra.After the murder, the criminals fled away with the car. Police recovered the body from a roadside paddy field on Monday morning. But they are yet trace the missing car. The body was sent to morgue

Rabbani murder: Deposition of 5 PWs recorded

The Divisional Speedy Trial Tribunal, Chittagong on Monday heard five more prosecution witnesses (PWs) in connection with the sensational murder of Korean Export Processing Zone (KEPZ) managing director and former port chairman Commodore Golam Rabbani.

Tribunal judge Hasan Imam heard deposition of 23 out of 49 PWs so far. He fixed March 12 and 16 as the next dates of hearing, according to court sources.

Five PWs who gave deposition are: Sub-inspector Jafar Ali Khan first Investigation Officer, Dr Md Ashiqur Rahman Bhuiyan, on-duty doctor of the emergency ward of Chittagong Medical College Hospital (CMCH), Lt Col Dr Tapan Kanti Das, who conducted the postmortem of the victim at Combined Military Hospital, Sub- inspector Mo Faruque, who attached the movable property of absconding accused and Sub-inspector Mahbubul Alam record keeper of First Information

The tribunal will hear three more PWs on next two schedules. Commodore Rabbani came under attack by armed criminals on the busy Muradpur Road on April 11 last year. He was going to KEPZ on board a microbus. He was rushed to the CMCH first and then to Combined Military Hospital (CMH) Dhaka. He died at a Bangkok hospital after fighting for life for 13 days.

Nine rivers need dredging in Barisal region

Four launch stations closed down due to accumulation of silt in riverbeds

Four launch stations have closed down because of accumulation of silt in 30 kilometre area of waterways in greater Barisal region.

New shoals have emerged in the erbeds of Kirtonkhola, Arial khan, Kalabadar, Shikarpur, Hizla, Naya Bhanguni, Sugandhaya, Sandhaya and Meghna as the intensity of current of rivers decreased considerably, according to Bangladesh Inland Water Transport Authority (BIWTA), Barisal Port authority and launch owners'

The rivers need immediate dredge ing, according to BIWTA Deputy Director Md Saiful Islam, also Port and Transport officer of Barisal. But it cannot be done due to fund constraints, he added.

The launch stations which have been closed are Bara Machhua of Mathbaria in Pirojpur, Kasherhut of Muladai, Bhabanipur and Dhamura of Wazirpur upazila in Barisal

Navigability has been lost along three-kilometre area from Torki to Hosnabad in Gournadi upazila, fourkilometre area from Saheberhut to Tungibaria and Saheberhut to Lahurhut, half-a-kilometer area from Barisal launch ghat to fishing port, twokilometre area from Dapdapia launch ghat to Mridhabari in Barisal Sadar upazila, four-kilometre area from Char Nainda to Raiapur, two-kilometre area from the eastern part Bholanath Char to its western part in Mehendiganj upazila, four kilometre area from

Tengramari to South Vuterdia, five

kilometre area from Mallikour to Madhayerchar in Babuganj upazila, kilometre area from Mahishakhola to Showla and Badartuni in Hizla and Muladi upazilas, one kilometre area from Banaripara town to launch ghat in Banaripara upazila and one kilometre area from Wazirpur town to launchghat.

The Deputy Commissioner of Barisal sent three letters to the concerned ministries and departments on different occasions for taking immediate steps to dredge the rivers. He sent a letter on December 29 last year and two other letters on January 8 and February 9 this year.

This situation is not only hampering river transportation, but also threaten ing the environment.

Militancy: Police trying to arrest imam of mosque in Nilphamari

Activities of Islamic Jihad increased at Vogdaburi and other villages in last six months

Domar police is trying to arrest an 'Imam,' Muslim priest, of Patoarypara Ahle Hadith Mosque in Vogdabari union for his alleged involvement in the activities of an extremist group named Islamic Jihad.

Police launched the operation following a confessional statement made by Islamic outfit, Azizul Islam of village Sundarkhata in Panchagarh who was arrested recently.

While on remand, Azizul mentioned the name of Ibrahim Mia as his close associate.

However, police could not arrest him as yet, but recovered important documents and receipt books of illegal toll collection by searching his house, a source in Domar police told The Daily Star.

Local people alleged that Ibrahim had been engaged in collecting illegal toll in name of Islamic Social Development Fund for a long time. He also threatened them for their failure to comply with his order. He collected the money to carry out extremist activities, they added.

According to people, the activities of Islamic Jihad increased at Vogdaburi and other villages during the last six months.

Patwari Para Ahle Hadith Mosque committee members told newsmen, Ibrahim took leave for four days after Azizul's arrest. But he

did not turn up even after 10 days of unauthorised absence.

He might have taken shelter in the mosque six months ago to carry out his outlawed activities, people apprehended.

Ibrahim hailed from Kaligani village of Deviganj upazila in Panchagarh.

Grameen Bank client 'beaten'
