

#### 6 houses looted in one night in Kushtia

Six houses were looted from six houses at village Sariaduli in Daulatpur upazila by a gang of bandits on Monday night.

According to family sources, bandits numbering 15 stormed into the house of Matiur Rahman and looted cash. ornaments and goods worth Tk 50,000. The same gang looted cash and ornaments worth Tk 2 lakh from the houses of Sabul, Ahad Sardar and three other unidentified persons.

# AL won't back candidates with criminal record

After announcement of nomination for the Mayor post, local Awami League (AL) has finalised the list of AL candidates for the 41 ward commissioner posts in the upcoming Chittagong City Corporation (CCC) election.

However, their names would be made public after ruling BNP announces its ward commissioner candidates, AL sources said.

Though local body elections are not held on party basis, political parties back their men.

"There will be no criminals in the list of AL candidates this time", claimed a top AL leader in the city when his attention was drawn to election of some "listed criminals" belonging to the party as CCC ward commissioners in the polls held in

He however said being on the police list does not mean a person is a terrorist or criminal till he is declared so by court. Many innocent

due to political vengeance, he said. Among the AL-backed 38 incumbent CCC ward commissioners, there at laeast are four persons on the police list of criminals.

There are 17 criminal cases including three for murders against Mamunur Rashid Mamun of Shulak Bahar ward, five against SM Shahiudllah of Bakalia and two against Mohammad Hossain Hiron of Pahartali ward. Another commissioner --Md. Aslam of South Halishaharis reportedly a 'godfather' of smugglers.

SM Shahidullah is now behind the bar and Mamunur Rashid is

escaping arrest. Mohammad Hossain was acquitted in one murder case (Sramik Dal leader Safi murder) and is on bail in the other case, police sources said.



Blindness is no barrier for Md Kamal Hossain and Iqbal Hossain. They are appearing at SSC (Secondary School Certificate) examinations at Brahmanbaria centre in the town.

They are helped by their aides, who tell them the questions and write answers as per dictation. They hope to good results like other students.

Kamal and Iqbal are students of Brahmanbaria High School, an old and famed institution in the town and stay at Alatunnesa ABC Student Hostel in the town, run jointly by the Social Welfare Department and Assistance For Blind Children (ABC) an NGO. There are ten students at the hostel. When contacted, ABC Hostel teacher Abdul Wahid, who is also blind said another blind student from the hostel-- Babul Miagot "A" in SSC examination last year. Blind students of the hostel are doing good at classes and in public examinations, he said.

English Second Paper examination was progressing. When he visited Room No 5 at the centre, he saw an English teacher of Nagor Darwani High School under Sadar upazila named Walliullah on duty there where students of his school sat for examination.

According to official rule, no teacher can work as invigilator in any hall where students of the same school sit for examination.

At once, the UNO relieved assistant hall superintendent Abdul Jobbar Haidary from his duty

However, he did not take action against the hall superintendent who is also headmistress of the school.

Sources said this arrangement was done to save the MPO of teachers of Nagor Darwani High School, which did bad results in consecutive

## UNOCAL'S SOUTH PAD IN HABIGANJ Land owners demand proper compensation

About 250 families in Karimpur in Nabiganj upazila in Habiganj have demanded proper compensation and fair price of their lands to be acquired for gas exploratory work by US oil company Unocal.

Survey work in the area has already been completed and about 50 acres of land will be acquired for setting up Unocal's South Pad, sources said.

The site is near the Bibiyana Gas Field and the selected lands are adjoining the Sunamganj-Aushkandi and Syedpur-Inatganj roads.

The landowners at a press conference at Sylhet Press Club Tuesday evening alleged that certain quarters in the administration are trying to deprive them of proper compensation and fair price of their lands and

They also threatened tougher

agitation, if needed, to realise their demands.

In a written statement they said, "We are proud of being the owners of lands fof national importannce. We are also ready to sacrifice valuable ancestral houses and lands for that

"But we want fair price as per law and proper compensation".

Some officials are trying to "cheat" us in the name of acquisition, which would be resisted at any cost, they warned.

All the families in the area will have to leave their ancestral homes. Some officials are now out to pay a 'nominal price' for the lands, they alleged.

Even, the price offered is 'far below' the price paid when Bibiyana Gas field was set up near a river bank in the area in 1997.
