#### Yakub placed on 8-day remand

A Dhaka court yesterday put Mohammad Yakub, one of the five prime accused in the April 2, 2004 Chittagong arms and ammunition haul case, on an eight-day remand.

Sub-Inspector Ramiz Uddin of Mirpur Police Station produced Yakub before the court of Chief Metropolitan Magistrate, Dhaka with a 10-day remand prayer.

With the permission from Criminal Investigation Department (CID), Chittagong, who are in charge of investigating the case, and Chittagong police, Mirpur police submitted the remand prayer for interrogating Yakub in the Chittagong arms haul case and two other cases filed against him with a Chittagong police station.

Mirpur police arrested Yakub from a house at Lalkuthi in Mirpur on Thursday.

Yakub, vice-president of the Bangladesh Road Transport Federation, allegedly supplied the trucks used in the smuggling of the arms and ammunition and was absconding since the largest ever ammo haul in the country in April last year from Chittagong Urea Fertiliser Limited area.

Police sources hinted that Yakub will be interrogated by the Joint Interrogation Cell.

# EC voter list and databases can be manipulated

The Office of the Comptroller and Auditor General (CAG) has found some technical and management glitches in the Election Commission's (EC) computer system including the program that maintains the voters database.

The EC has no effective security mechanism to protect the database from manipulation, said the CAG

According to the report, factors like lack of a policy on computer use, scarcity of passwords and the software concerned having no tolerance est make the database vulnerable.

"These loopholes make the districts' databases vulnerable to manipulation any time," it mentioned and recommended initiating measures to address the weaknesses.

"There is an apprehension also about the efficacy of the EC's management system due to the shortcomings in the existing computer system," it said.

The EC spent Tk 5.3 crore to set up its computer system. The expenditure was met from a UNDP-funded project

named Strengthening the Election Commission for Improvement in the **Electoral Process** 

Before the 2001 general elections, the EC decided to go for development and updating of a website, Central Database System (CDS), District Database System (DDS) Election Result Updating System (ERUS), EC Administrative System (ECAS), Union Parishad Election Information System (UPEIS) and Personal Management Information System (PMIS) using the information technology. It appointed seven consultants to complete the tasks.

But only the DDS, ERUS, UPEIS and the website were developed and their operations have not been satisfactory, the CAG office pointed out.

Meanwhile, a foreign and two local experts have left the project.

Quoting the project authorities, the report said the experts assigned did not complete the CDS, ECAS and PMIS. Records preserved by the authorities showed Tk 97.26 lakh was spent on IT hardware and software, Tk 2.66 crore for foreign experts and Tk 1.49 crore for local

## Graft-ridden Rajuk resumes audit

Rajdhani Unnayan Kartripakkha (Rajuk) has initiated an 'internal audit' aborted 10 years ago by an office order, sources said.

The internal audit 'abandoned for mysterious reasons' is set to provide unprecedented insight into the massive financial irregularities that have gripped the semiautonomous city planners.

Rajuk's responsibilities include overall development of city planning, as well as zoning, approving building plans, monitoring and governance.

Inside sources said Rajuk has


sold thousands of residential and commercial plots over the last 10 years, converting vast areas of the city's periphery into housing projects. The huge amount it earned from these dealings was deposited in over 50 separate bank accounts.

But an official source said with a recent disappearance of over 200 classified files from Rajuk, it is suspected that files on those bank accounts have also gone missing.

"Those who are working here for several years know about the existence of the accounts with different banks, but we do not know how much money is lying there or

## Kolkata Test nicely balanced

Indian batsmen Sachin Tendulkar and Rahul Dravid built on Anil Kumble's effort with half-centuries to put the second Test against Pakistan in an intriguing position here on Friday.

Tendulkar scored a solid 52 before falling to a dubious decision and Dravid hit an unbeaten 54 as India recovered from a shaky 23-2 to reach 133-3 at stumps on the third day of fluctuating fortunes for an overalllead of 147.

Skipper Sourav Ganguly (four) kept Dravid company when bad light stopped play 11 minutes before the scheduled close.

Tendulkar was given out caught behind off seamer Abdul Razzaq by West Indies umpire Steve Bucknor, standing in a record 100th Test.

TV replays later suggested that

the ball had missed the bat. The umpiring decision angered a section of the 35,000-strong crowd which jeered Bucknor. Leg-spinner Kumble earlier claimed three scalps in seven overs

during a Pakistani collapse which saw the tourists lose their last eight wickets for 112 runs on a slowturning Eden Gardens pitch.


