

# One robber to die, 2 others get life

A Dhaka court yesterday sentenced a robber to death and two others to life in jail for killing Abdus Salam of Savar in June in 2001.

while Rafiqul Islam and Abdul Aziz were given life in jail. Judge Kamrul Islam of the Fourth Additional District and Sessions

The convict with death is Ayub Ali

Judge's Court handed down the verdict in presence of the convicts. The court also fined the convicts with lifers Tk 20,000, in default, to suffer a one-year more imprison-

The convict with death can appeal to the High Court against the verdict within seven days from the date of receipt of the judgement copy, the judge said.

Earlier, the prosecution and the defence completed their arguments and the court recorded statements of 13 prosecution witnesses.

In the case filed with Savar Piolice Station, it has been alleged that a gang of robbers entered the victim's residence at about 2:00am on June 25, 2001 and made attempt to rob. But the residents and neigh-

bours woke up and chased them. Then the robbers hurled bombs on them which left Abdus Salam dead on the spot. Three of the robbers were caught red-handed when they were trying to flee.

The three were handed over to Savar Police and victim's younger brother filed a murder case against them the same day. The investigation officer pressed charges against them on January 10, 2002.

## SC stays HC order

The Appellate Division yesterday stayed for six weeks a High Court order that allowed production, marketing and selling of soft drinks Hunter

The HC had directed the government to permit the Crown Beverage Limited for its production, marketing and selling of Hunter and Crown.

After hearing an appeal petition filed by the government against the HC order, Chamber Judge of the Appellate Division Justice Amirul Kabir Chowdhury passed the stay order. Earlier, the Narcotics Department

seized about eight lakh canes of Hunter and Crown, and cancelled the license issued to the Crown Beverage Limited for production, marketing and selling hunter and crown

Shamima Islam, Managing Director of Crown Beverage Limited, had filed a writ petition challenging the government order and sought permission for production, marketing and

selling their produced soft drinks. A HC bench on March 15 had directed the Crown Beverage Limited to produce Hunter and Crown and to sell the seized canes to only the licensed bars of the country or export them abroad within one month. The HC also ordered the Narcotics Department to issue a new license to the Beverage Limited within two
