## India hints at readiness to attend anytime

UNB, Dhaka

India has indicated to the Maldives its readiness to attend the twicepostponed Saarc summit in Dhaka any time convenient to other members of the seven-nation organisation, which also includes Pakistan, Sri Lanka, Nepal, Bhutan and

"We discussed when the 13th Saarc summit could be convened. Both India and the Maldives are ready to meet at any time conveto other leaders," visiting Maldives President Maumoon Abdul Gayoom said at a press conference in New Delhi yesterday.

'We hope that dates convenient for all will be identified soon," said Gayoom, who held discussions with Indian Prime Minister Manmohan Singh and other Indian leaders during his six-day visit, a PTI report SEE PAGE 15 COL 3

## BNP men grab lion's share

True to its tradition, Rajuk yesterday allocated most of the 100 residential plots in Banani and Uttara to ministers, lawmakers, ruling party leaders and their relatives, prompting critics to term the allotment 'a bid to set up two more BNP villages

The list of beneficiaries, published in several newspapers yesterday, shows that all the 50 allottees in Uttara and 46 of the 50 in Banani are ruling party men and their relatives.

The list comprises of 19 ministers, 52 ruling coalition MPs, the mayors of Rajshahi and Barisal, two advisers to ministries, a son of the president, sons of ministers and ruling coalition lawmakers, BNP leaders and the pro-ruling coalition vice chancellor of National University and chairman of University Grants Commission.

#### TENGRATILA FIRE Charge framed

## against Bapex MD

Petrobangia has framed a charge against the managing director of Bangladesh Petroleum Exploration and Production Company Limited (Bapex) for his alleged neglect behind Tengratila gas fire accident.

Petrobangla on Tuesday also asked MA Based, MD of its subsidiary organisation, to clarify his

position in seven days, sources said. After receiving Based's statement, Petrobangla, the state-run oil, gas and mineral corporation, will form a one-member committee to review the entire matter, service rule and recommend next course of action.

The Energy and Mineral Resources Division, on the basis of an enquiry committee report, had earlier asked Petrobangla to take action against Based.

## 26,348 project cars in unauthorised use

## Establishment ministry suggests action against misuse by 43 govt organs

The establishment ministry has accused 43 ministries and divisions of using a total of 26,348 vehicles violating the existing rules for the use of public transports.

The ministry in a report suggested action against those responsible for the misuse and steps to identify the reasons why the ministries and divisions did not return the vehicles on completion of different development projects.

The report says the vehicles

should have been returned to the establishment ministry endorsed central transport pool within three weeks of the completion of the projects. But the ministries and divisions have not returned the vehicles and are still using them.

"The existing rules do not allow such usage," the establishment ministry said in its report submitted to a parliamentary standing committee yesterday. The ministry also suggested amendment to the public transport rules, if necessary.

Reviewing the report, the parliamentary standing committee on the recommendations for proper

Talking to reporters after the meeting, Committee Chairman Sardar Shakhawat Hossain Bakul said the committee observed that there should be proper rules for using public vehicles as the ministries and divisions need to use these vehicles.

The report says 615 development projects were implemented from 1997 to 2004 under 43 ministries and

#### Dawn-to-dusk hartal today

Hartal curtailed in Dhaka, Gaibandha, cancelled in Ctg

The main opposition Awami League (AL) and its left-leaning allies enforce a dawn-to-dusk hartal today across the county, except for eight hours in the capital and six hours in the tornado-hit Gaibandha district, keeping Chittagong City out of the

programme.

The members of the 14-party opposition line-up called the shutdown as a part of its ongoing simultaneous movements demanding an immediate resignation of the fourparty coalition government to pave way for an early general election.

The hartal has been shortened by four hours, from 6:00am to 2:00pm, in Dhaka metropolis to facilitate a demonstration called by the family

## Govt may lose 60m euro German grant for power

Bangladesh is on the verge of losing a German grant of 60 million euro earmarked for two power projects of (RPCL), as a High Court (HC) injunction has stopped a German audit to unearth corruption in the projects.

The deadline for a decision on this grant, which is tagged with a condition of this audit, expires

According to the Economic Relations Division (ERD) sources, the government expects Germany to extend the deadline till the sixmonth HC injunction expires in

"We have not formally requested

Germany to extend the deadline yet, but we hope this grant will not be cancelled," said an ERD source.

While the government was willing to cooperate with Germany in this regard, a business lobby involved in the corruption has so far succeeded in stopping the audit as well as deteriorating the government's relationship with Germany, said an official.

Germany provides grants and loans in health, private sector development, power transmission and solar power.

The business lobby that dominates all affairs of the RPCL through its German consultant, Lahmayer Bangladesh, apparently convinced a section of government policymakers

to ditch German aid, be it a grant or

"The RPCL is now resorting to raising funds from the Palli Bidyut Samities (PBS) and has approached the Islamic Development Bank (IDB) to finance two over-priced projects to be awarded to a particular company on a term that will favour the business lobby only," said

an RPCL source. Following a report in The Daily Star in January last year on corruption in the German funded first ohase of 450megawatt Dhaka North Power Project (DNPP), the German government made an initial review and recommended that an auditor should independently review the SEE PAGE 15 COL 4

## BTTB launches cellphone, legal questions remain

The government commercially launches its cell phone service today without a valid licence, which may prompt filing of lawsuit leading to possible suspension of the service. The telecoms watchdog trans-

ferred ownership of the licence to Teletalk Bangladesh Ltd, a stateowned company, in clear violation of the telecoms law. It had earlier issued the licence to Bangladesh Telegraph and Telephone Board (BTIB) to run the mobile phone "A license and any right acquired

thereunder, wholly or partly, shall not be transferable, and such transfer, if any, shall be void," says Section 37(1) of the telecoms act. This legal

The BTTB had planned to launch

the mobile service, but donors objected to the state telecom operaof its incompetence. The Executive Committee of

National Economic Council (Ecnec) accordingly on September 17, 2002 segregated the proposed cellular mobile from BTTB's portfolio and asked it to be operated by an inde-But a defiant BTTB decided to go

on its own and obtained a cellular hone operating licence alongside the radio frequency from Bangladesh Telecommunication Regulatory Commission (BTRC) on September 1, 2004. The BTTB also claimed the state-

Prime Minister Khaleda Zia vesterday said her government is updating the national health policy as part of its relentless effort to enhance the quality of healthcare to ensure people's access to improved

"Access to healthcare is a basic right of the people," she said while inaugurating the most modern hospital with a call for the private sector to supplement government

"It is not possible on part of the government alone to ensure this rights of all citizens due to resource constraints, but medicare facilities can be provided through setting up newhospitals," she stated.

The 450-bed world-class Apollo Hospital in the Basundhara housing enclave will have over 60 speciality medical departments to provide all high-end medical services.

Holdings Limited, the 38th branch of worldwide hospital chain in Dhaka is equipped with world's latest technologies.

The prime minister in her speech said that it is possible to create modern treatment facilities in the country through private initiative. Khaleda listed the incentives

introduced by her government for setting up modern, specialised and referral hospitals in Bangladesh. "The referral hospitals can now

import necessary equipment dutyfree. Taxes have been reduced on some lifesaving medical items," she

"We have a new infrastructure guideline that paves the way for building quality hospitals by foreign investors," she said, hoping that entrepreneurs from home and abroad will come forward in a big way to set up more hospitals in the

She lauded the decision of Apollo Hospital authorities to keep 10 percent beds free of charge for the poor and hoped that others would

The PM urged the authorities to keep fees for treatment of various complex diseases and tests to a

She told the audience that the government is formulating laws to ensure the standard of service in the private hospitals. "A policy would soon be announced for private hospitals, clinics and diagnostic centres," she said.

She also informed that appointment of foreign doctors in exchange for technology transfer to the foreign-invested hospitals is being considered by the government, which, she hope, will help enrich local doctors' experience.

## 7 killed, over 100 hurt in nor'wester

5,500 houses damaged

At least seven people were killed and over 100 others injured, including women and children, as a nor'wester lashed over different parts of the country yesterday.

Hundreds of houses and trees as well as standing crops were damaged by the tropical storms. Many parts of the country also experienced a downpour.

Electricity supplies and telecommunications were snapped in many

In Natore, at least five people were killed when the nor wester lashed over 50 villages, razing hundreds of houses, damaging crops

and uprooting trees in the after-

Four people were killed in Kholabaria Laksmipur village and one Diar Kazipur. Their identities could not immediately be known. Villagers said the nor'wester damaged around 5,000 houses,

leaving many villagers injured. In Manikganj, an unidentified woman was killed and several people were injured as the nor'wester hit Daulatdia, Manikganj sadar and Ghior upazilas in the evening. Besides, the nor'wester damaged

more than 500 houses. Waterways in the district remained suspended for about half an hour. SEE PAG 15 COL 8


#### 'Dhaka fully committed to protect HR' Response to US report
