Stop import thru' direct purchase to curb money laundering

Dhaka Customs House urges authorities

Import through direct purchase is linked to money laundering, said Dhaka Customs House, urging authorities to stop the practice Direct purchase through the

airfreight unit at Zia International Airport (ZIA) is encouraging those who are involved in money laundering, the customs house said in a letter to higher authorities.

Policy makers should take stern steps to stop the system as it is seriously affecting the national interest, recommended the letter.

common practices in importing goods under direct purchase, Dhaka Customs House sources said, adding that 63 percent of the goods imported through the airfreight unit is under direct purchase. Importers open letters of credit (L/Cs) for importing only 37 percent goods through the unit.

A section of importers are evading a huge amount of tax by mentioning unusual low prices for imported goods than their actual prices in the global market and this practice continues for long. The customs house sometimes releases Preparing invoice locally and goods after collecting even 20 to 30 times more duty on prices men-

tioned in the invoice. "One can raise question how payment is made for importing through direct purchase when customs house collects duty at such higher rates. The answer is the payment is made through money laundering," said the letter.

While going abroad through ZIA, an outgoing passenger can carry a maximum of US\$5,000 officially. Some big incidents of foreign currency smuggling were detected at ZIA recently within a very short span of time. It can be easily perceived that moneylaundering incidents were going to take place to pay for goods imported under direct purchase, said the letter.

Stopping direct purchase through the airfreight unit is essential, although there is a risk of revenue income decline of Dhaka Customs, it mentioned.

However, there will be no risk of revenue earning reduction or the risk can be minimised if the direct purchase is stopped simultaneously across the country, the customs house recommended after carrying out an internal inspection

The customs house suggested imposing initial restriction on

some selected products such as wristwatch, spectacles, mobile phone sets and spare parts of these items, cosmetics, readymade garments and motor parts. All goods imported through direct purchase need physical inspection, which is also a time consuming process.

It is necessary to amend the existing import policy to stop direct purchase as article 7.7 of the Import Policy Order 2003-06 allows importers to import goods through direct purchase after the nonresident Bangladeshis pay for these, the customs house sug-

AMENDMENT TO LAND LAW

Bankers tell law minister

Top bank officials yesterday said marginal farmers will face difficulty to receive agricultural loan from banks due to newly amended law relating to land registration and

The bank officials expressed their concern when they met Law Justice and Parliamentary Affairs Minister Moudud Ahmed at his office in

The Registration Act, 1908 and The Transfer Property Act 1882 were amended in December last year, which will be effective from July 1,

Top officials from 12 banks told

the law minister that it will be difficult for the marginal farmers to bear the costs of property transfer fees following the amendment to act.

Farmers to face difficulty

Moudud assured the bankers that if necessary the government will reconsider the amendment to give relief to marginal farmers. However, the bankers hailed the

other aspects of the amendments to the land registration and property transfer act.

Khondkar Ibrahim Khaled, managing director of Pubali Bank, told the meeting that the new amendment will stop the practice of taking loans from different banks by mortgaging the same land with fake documents

The law minister said there will be no chance of making fake documents since, according to the new amendment, the pictures of both the land buyers and sellers will have to be attached to the land deeds while selling land

"Loan default rate will be reduced as the new amendment has made land registration mandatory for receiving loans," Moudud added.

According to the amendment, Tk 500 registration fee is applicable for property worth up to Tk 5 lakh, Tk 1000 for property that values between Tk 5 lakh and Tk 50 lakh and Tk 2000, if the property is worth

Orascom plans to start submarine cable business

Middle Eastern mobile phone conglomerate Orascom Telecom yesterday announced ambitious plans to deploy two submarine cable networks to link major telecommunications hubs across the Mediterranean and the Arabian Sea.

The 1,300 kilometre long and 10 gigabits per second (Gbps) capacity Mediterranean cable system will connect Annaba of Algiers in Algeria with Marseilles in France to link North Africa with Europe. The cable network will also have a branching

unit to link Tunisia in future. The second segment of Orascom's 1,200 kilometre long and 20 Gbps submarine cable will connect Pakistan's Karachi with Fujairah in United Arab Emirates, according to a press statement posted on the telecoms giant's

official website. In 2002 the Pakistan government granted a 25 years non-exclusive license to Orascom to build and operate a private submarine cable landing station and sell capacity to

licensed operators in Pakistan. Orascom's entry will trigger competition in the international bandwidth business in the North African and the Middle Eastern markets as the SEA-ME-WE4 submarine cable network's commercial launch will coincide with Orascom's Besides, part of the SEA-ME-WE4 cable is also being deployed from Karachi to Marseilles

via Fujairah. Orascom Telecom operates GSM networks in Algeria ("Djezzy"), Egypt ("MobiNil"), Pakistan ("Mobilink"), Iraq ("IraQna"), Bangladesh ("Banglalink"), Tunisia ("Tunisiana"), Congo Brazzaville ("Libertis"), Democratic Republic of Congo ("Oasis") and Zimbabwe ("Telecel Zimbabwe").

Akbar sees sharp decline in piracy as ports adopt int'l security code

Shipping Minister Akbar Hossain yesterday said the image of Bangladesh in the global shipping arena has improved remarkably after implementation of International Ship and Port Security (IPSP) Code.

And piracy and pilferage at the ports have also come down significantly, he added.

The minister's claims came just two days after a foreign flagged vessel, Swissco-12, carrying submarine cables was attacked twice by armed pirates near Kutubdia chan-

"There is a trend in international arena to identify the ports of Bangladesh as piracy-prone ports by mentioning many trifling incidents as 'piracy' and 'armed robbery'," the minister said while speaking as chief guest at a seminar on 'Maritime Security' at the auditorium of Chittagong Port Training Institute.

"The present government is determined to keep the inland, coastal and international shipping routes safe and pollution-free and that's why the IPSP Code has been implemented at Chittagong and Mongla ports," the minister said. He said making of two high-

speed patrol boats to strengthen the security system in the port channels is underway. Besides, procurement of an aircraft in this connection is also under process, he added.

Chittagong Port Authority Chairman AMM Shahadat Hossain chaired the seminar organised by International Maritime Organisation (IMO). IMO representatives Gurprit S Singhota and Frank Wall and Director General of Shipping Captain AKM Shafiqullah also spoke at the function. About 60 officials from different port-related organisations are taking part in the five-day seminar.

Shadow of Wolfowitz hangs over WTO amid US-EU bargain fears

Former US defence official Paul Wolfowitz's appointment to head the World Bank has added a fresh twist to the election of the new director general of the World Trade Organisation, diplomats said yester-

Developing countries have raised concerns about the United States and European Union tacitly sharing out the top posts at the major international financial institutions, including the WTO.

The concerns were raised as the leadership race at the Geneva-based trade body, which involves a European and three developing country candidates, shifted up a gear Monday.

Kenyan ambassador Amina Mohamed, who is overseeing the selection process, began one-onone meetings with representatives of each of the 148 member states to try to determine which candidates have a chance of commanding a consensus in the trade body.
