The Project Executing Agency (PEA) and The National Centre for Jute Diversification (NCJD), India signed an agreement to implement a project titled 'Small scale entrepreneurship development in diversified jute products' in the city yesterday.

SK Das, executive director of NCJD, and Md Fazlul Huq of the PEA signed the agreement at the International Jute Study Group (IJSG) headquarters.

Financed by the Common Fund for Commodities, the Netherlands, the project involving 3 million US dollars will be implemented in Bangladesh and India in the next three years under the supervision of the IJSG.

Three to die in Narayanganj

A Court here sentenced three persons to death and awarded punishment to two others in various terms in two sensational murder cases under Bandar and Narayanganj police stations.

According to a press release, Suja, 28, and Raja, 25, were sentenced to death and boatman Jalil, 35, was awarded six years impriscase. The murder took place in

Paper mills gutted in N'ganj fire semi-pucca Israr Paper Mills, a

Around 500 metric tons of paper pulp and other valuables were gutted in a mysterious fire that broke out in a paper mills at Tarabo under Rupganj Police Station in the early hours of yesterday.

According to fire service sources, the fire broke out at a

sister concern of Sonali Paper

and Bond Mills, at 4.00am. Quoting the security staff, the sources said a group of robbers numbering eight to ten committed robbery in the mills and looted staff's clothes and valuables.

Before leaving, the robbers set fire to the mills, the sources added.

The flame quickly spread and gutted the paper pulp.

Firefighters from Demra and Narayanganj Fire Services extinguished the blaze after

nearly eight hours. The loss caused by the fire is

being assessed.

The owner of the paper mills was not available for comment on the cause of the fire.
