Worried depositors crowd postal banks: Panic withdrawal

Hundreds of worried depositors crowed postal savings banks in Nilphamari, Gaibandha and Rangpur vesterday to check their accounts following reports of defalcation of crores of Taka by postal employees.

In Nilphamari, the amount defalcated from depositors' accounts at the Head Post Office may cross Tk 10 crore, according to sources in the probe team. A guarter having political backing is allegedly trying to save some of the persons involved in the scam

At Syedpur, people reportedly attacked the house of a postal employee involved in the scam.

Our Nilphamari correspondent reports: Bail petitions of accused Assistant Post Master Mir Nural Islam Munna and Ledger Operator Ahmedul Islam Raju were rejected again yesterday by court.

Yesterday was the first working day after reports of defalcation appeared on newspapers

Several hundred depositors were seen crowding the Nilphamari Head Post Office all day long to know about their accounts

Earlier, the probe body detected that Rangpur Postal Inspector Abu The Sadar thana OC, who is also the investigation officer (IO) of the Taher Md Shamsuzzaman withdrew case, has gone on leave for four days about Tk six lakh through forgery from the post office. is risky due to a lack of sufficient screening facilities at blood banks. Blood collected from professional donors is also of lower

quality and often infected with derms of diseases, it was dathered from sources at blood banks. At least 50 per cent of the total

blood collected in the city is from professional donors and most of them are sick or drug addicts. They are often seen sitting on the pre mises of the blood banks and sell blood only to buy drugs.

According to the sources, the blood of professional donors contains inadequate blood cells and harmful microorganisms and chemicals like HBsAg (Hepatitis B

virus antigen) In Rajshahi Medical College Hospital (RMCH) blood bank, at least 30 per cent of the collected blood is from professional donors, 50 per cent from relatives of patients and the rest from voluntary

RMCH blood bank chief Dr Mosaddek Hossain said that they collect and supply blood after screening tests under the Safe Blood Transfusion Programme. The tests include HIV (virus of AIDS), HBsAg, HCV (Hepatitis C virus) and VDRL (test for syphilis).

bags were collected in the hospital. Of those, HCV positive was found in 44 bags, HBsAg positive in 33 bags and VDRL positive in eight bags. However, no HIV positive was found in any of the blood bags. Private blood banks do not have

any screening facility, the sources said. Some of the owners of blood banks admitted that usually they do any go for screening test of donors' blood. They all said screening tests cost about Tk 450 and they are to give Tk 90 per bag to professional donor

Per bag screened blood should sell at no less than Tk 700, which most buyers cannot afford," said an owner of a private blood bank. Private blood banks usually sell blood at around Tk 350 per bag. There are six private blood

banks in the city and each sells about 200 bags of blood a month. But men at private blood bank usually tell buyers recipients that they have performed screening tests and their blood is safe, it is alleged.

Shyamol died in Rab torture, claims WP



ANTI-SMOKING LAW Bidi output falls, workers face job loss in Barisal

Production of Bidi in Barisal region has come down by about fifty percent and at least 20,000 workers have become unemployed after enactment of the law banning smoking at public places, according to sources in the industry.

The jobless workers held several demonstrations in the city in the past week demanding relaxation of the law till their rehabilitation.

The anti-smoking law took effect on March 26. Now smoking in transports and at public places are rarely seen.

Niranjan Dey, an official of Karikar Bidi Factory, said in last one week, about forty million Bidi sticks were produced, but not even half of those were sold. As a result, workers have not been given any new work order in the current week.

Haider Ali Khan, Managing Director of Sultani Bidi Factory, told this correspondent that 6000 workers of his factory were given only two days' work last week and their work in the coming week is also uncertain.

Bidi produced last week are yet to be sold, he added.

Bidi factory workers usually work on daily basis under master roll and they remain unemployed if work is not given.

Leaders of the Bidi Sramik Union said if the trend of slide in production continues, about three million out of fifty million workers would become jobless within a short period.

Different trade unions of Bidi factory owners and workers have decided to hold a grand rally at Paltan Maidan in Dhaka on April 20, where they will demand relaxation of the law and alternative programmes for rehabilitation of jobless workers.
