Justice Bimalendu Bikash Roy Chowdhury, a former advisor to a caretaker government, passed away at a hospital in Kolkata yesterday at the age of 70.

Born at village Bakila in Hajiganj, Chandpur, in 1935, Justice Chowdhury was the fifth Mohanta Maharaj of Shree Shree Kaibalyadham Ashram in Chittagong.

He started his law practice in the then Dhaka High Court in 1962 and joined the High Court as an additional judge in 1985. He retired from the appellate division of the Supreme Court in 2000.

Chittagong Metropolitan Sessions Judge Md Anwar Hossain fixed April 23 for the next hearing.

Meanwhile, another accused, Nurul Absar, son of Haji Zafar of Kuttapara, surrendered to court yesterday. He appeared in person before court during the hearing yester-day and prayed for bail. The court, however, rejected his appeal and put

him into jail custody. Of the 43 accused in the case, 15 including Nurul Absar have so far been arrested. Fourteen accused are on bail, while as many others have been absconding.

Sources said six of the accused surrendered to court last month but police are yet to arrest the most wanted Hafizur Rahman Hafiz. Din Mohammad, Abul Kashem Modhu and Haji Mohammad Sobhan.

On Sunday, 13 accused including Nurul Absar submitted a petition seeking exemption from the case but Public Prosecutor Abdus Sattar opposed their appeal. The court ejected the petition. Those who sought to be exempted are Nurul Absar, Sheikh Mohammad, Mujibur Rahman Bulu, Ejahar Mia, Akbar Ali, Fazal Ahmad, Ataur Rahman, Sanwar Hossain Chowdhury, Dildar Hossain Chowdhury, Badsha Mia, Mohammad Jahangir, MdAktar and Abdul Aziz. Police retrieved a huge cache of sophisticated arms and ammunition loaded in 10 trucks on April 1 last year. The Criminal Investigation Department (CID) pressed charges on June 13 the same year after an investigation.

'Cop tried to blackmail businessman'

A police constable along with three others tried to enter the house of a businessman at Haji Abdullah Lane in the city on Saturday night in order to blackmail him, according to preliminary investigation. The residents of the house beat

up Constable Mohammad Shaheen of Rajarbagh Police Lines suspecting him of trying to do anything wrong. But two youths Kader and Rashed managed to flee.

The constable went to the house of Shahedul Hasan in Kotwali and tried to blackmail him accusing him of involvement in hundi business, police said.

Local people also beat him up and later handed him over to Kotwali Police.

The constable was now undergoing treatment at Dhaka Medical College Hospital (DMCH) under police quard.

Meanwhile, Shahedul filed a case with the police station accusing the constable and the three local youths of attempting to commit a robbery in his house

The High Court (HC) yesterday served a rule on the government ordering it to explain why the transfer, stand-release and suspension orders on Chittagong City Corporation (CCC) Secretary Mostafa Kamal should not be declared illegal. The court also stayed the government orders for three months. The rule came after Chittagong Mayor Mohiuddin Chowdhury in a writ petition filed with an HC division bench

challenged the three government orders. The court ordered the six respondents, including the establishment and LGRD secretaries, to reply to its rule in four weeks. The establishment ministry issued

the transfer orders of Mostafa Kamal on July 14 last year but the mayor did not release him. The ministry later in another order stand-released the secretary on September 5 the same year, but the mayor again refused to release him. The mayor had told the ministry that it was he who could release the CCC secretary and that the ministry had no authority to do this. The establishment ministry finally

suspended the secretary on April 3. The suspension orders that followed the announcement of the CCC

election schedule were issued with malafide intention to harass the petitioner (Chittagong mayor) during the election period, alleged the petitioner.

"How will the corporation run during the election period if they take away CCC staff this way?" the petitioner said.

Talking to reporters, petitioner's counsel Barrister Tanjib-ul Alam said the establishment ministry has no authority to stand-release or suspend the secretary while he is serving the city corporation.

The establishment ministry had transferred CCC Chief Executive Officer (CEO) Abul Bashar after the mayor asked for this on May 18. The ministry, however, appointed no new CEO although it transferred him nine months ago. The CCC secretary has also been serving as the acting CEO, as the post has been lying vacant

since then Barrister Rokanuddin Mahmud and Advocate Hari Shadhan Dev Barman also moved for the petitioner.

PRE-FEASIBILITY STUDY Tata happy with progress UNB, Dhaka

The Indian industrial giant Tata Group is expected to come up with its prefeasibility study on the proposed billion-dollar investment plan in Bangladesh by the month end. Executive Director of Tata

Power S Ramakrishnan, leader of a four-member delegation of the company, said this after a meeting with State Minister for Power lobal Hassan Mahmood yesterday at the Bangladesh Secretariat.

During the meeting, the Tata delegation briefed the state minister on the progress of the study and discussed other aspects of the planned investment.

The Tata Group plans to invest about US\$ two billion in the country to set up a giant steel mill, a 1000 mw power plant and a fertiliser factory.

Praising the cooperation from different government quarters in going ahead with their investment plan, Ramakrishnan said, "Our study is proceeding in an appropriate manner and we're quite happy to receive good cooperation from

BLAST AT CONFECTIONERY Explosive substance was not PHOTO: STAR used: Experts STAFF CORRESPONDENT

Explosive experts vesterday confirmed that the Saturday's blast at a confectionery shop at New Elephant Road in the city was not caused by any explosive substance or device.

"Although we are yet to ascertain the cause of the blast, we are sure that no explosive substance sparked off the blast," said Deputy Commissioner of South Division of Dhaka Metropolitan Police Mazharul Hoque. The blast at Rina Confectionery left at least 35 people injured and some 15

shops gutted.

Atop police official investigating the blast suspected that the explosion might have occurred in a gas pipeline at the upper portion of the shop and then caused simultaneous blasts of the compressors of an air-conditioner and refrigerators in the shop.

The explosive experts from law enforcement agencies and the Department of Explosives inspected the spot yesterday.

The explosive experts from Rapid Action Battalion (Rab) also talked to the injured employees of the confec-tionery shop at the Dhaka Medical College Hospital (DMCH) yesterday to know the nature of the blast.

Sources in the Fire Service and Civil Defence said they would form a committee today to find out the cause of the blast and the extent of the damage

Hospital sources said five critically wounded people are now undergoing treatment for their burns and the others were released after treatment.
