

BURI TEESTA IRRIGATION PROJECT

Water reservoir leased for fish cultivation

The Bangladesh Water Development Board (BWDB) has leased for fish cultivation the vast water reservoir of the Buri Teesta Irrigation Project in Jaldhaka upazila, depriving thousands of farmers of promised facilities.

The project is the second largest in the district after the Teesta Irrigation Project at Dalia in Dimla upazila.

Initially, the project was drawn for providing irrigation facilities on 29,000 acres of land in Domar, Dimla and Jaldhaka upazilas.

The Chairman of the then East Pakistan WAPDA, G A Madani inaugurated the project in 1963. It included a major barrage on the Buri Teesta and a 36,696 feet long main canal. The main canal consisted of four branch canals. Branch Canal-1 was 23,200 feet long while Canal-2 was 64.300 feet long and Canal-3 was 64,300 feet long and Branch Canal-4 was 322.000 feet long.

A vast water reservoir was constructed on 1,270 acres of

Since its commissioning, 18,000 acres of land were brought under irrigation from water of the reservoir till 1990, according to sources in the BWDB.

While visiting the project area on Friday, this correspondent found the dried up canals although sufficient water existed in the reservoir. Farmers under this project were seen irrigating IRRI-boro fields in a traditional

way.

The farmers informed that Nilphamari BWDB authorities had leased out the water reservoir to an influential person allegedly backed by the ruling party.

The vast reservoir on 1,217 acres of land was leased at only 84,000 taka per year whereas a

acres of land is usually given lease at more than one lakh taka, locals

The lessee paid only 4,20,000 taka for the reservoir on a five-year term, they said.

However, the lessee was not available there on the day for his comments. When contacted, Nilphamari

BWDB Executive Engineer Yasin Ali told this correspondent that because of 'misplanning', the BWDB authorities declared in 1991 that the project would not Referring to the BWDB deci-

sion, he said that the width of the main irrigation canal was abnormally large. There is also 'misplanning' in making the reservoir as water of the reservoir does not flow towards the farmers' lands, rather it comes to the reservoir from their lands.

The Executive Engineer further

informed that in the ongoing IRRIboro season, this project provides irrigation facilities to 247 acres of land. In the last aman paddy season, the project provided irrigation to 2,717 acres of land, he added

Refuting the WDB official's claim. Suiat Ali, a farmer at village Golna told this correspondent they are not receiving 'a single drop' of water from the project.

President of the Movement for Implementation of Buri Teesta Irrigation Project Golam Mostafa who is also president of Jaldhaka Press Club, pointed out that as per claim of the BWDB official, 18,000 acres of land were brought under irrigation system each year till

Then how could they declare the project ineffective showing planning errors,' he posed a ques-

He demanded quick measures to make the project effective.

9-year girl accused of possessing heroin

A nine year-old girl has allegedly been implicated in a case under Narcotics Control Act in Khulna

The case was filed by Inspector Shajahan Talukdar of Khulna office of Narcotics Control Department.

Farzana was picked up by Inspector Shaiahan Talukder on April 19 from West Senpara under Daulatpur thana.

She was allegedly beaten by the Inspector at his office and later sent to court, showing her arrested for possessing twelve packets containing heroin. Sub-Inspector Amirul Islam of Daulatpur thana said yesterday that a case was recorded against the girl before sending her to court. She was sent to Khulna district jail on the same day (April

But Farzana's father Liaquat Ali alleged that Inspector Shajahan Talukder implicated his daughter her

Liaquat Ali said that he had filed a petition on March 20 with the Metropolitan Magistrate's court accusing Inspector Shajahan Talukder of looting Tk 26,200 by breaking the lock of his house on March 12 on the plea of search During search Inspector Shaiahan also ransacked all rooms, damaging valuables.

Liaquat Ali said that he named four persons including Shajahan Talukder as accused. Three other accused are Deputy Inspector Shahriyar Sharmin, Constable Jalil and 'informer' Shushil.

GANGRAPE, MURDER OF GARO WOMAN

Killers yet to be nabbed

Police failed to arrest any of the culprits involved in the gangrape and murder of Garo women Anjali Rama one and a half months after the incident.

Anjali Rama, 30, wife of Palinus Rangdi of Guchchagram village under Durgapur upazila in the district, was gangraped and killed on the night of March 9.

Police recovered her body from near Bijoypur white clay mine. Anjali was a day labour working in a ceramic

Her husband filed a murder case with Durgapur thana.

Netrakona Police Superintendent Abu Nasar Mohammad Khalad while talking to this correspondent said police are trying to arrest the killers.

When contacted, Officer-In-Charge (OC) of Durgapur thana Abdur Razzak said they have identified three suspects involved in the gangrape and murder. They are Sukol Rangdi of Guchchagram village and Nuru Mia and and Abdus Sattar of Shasarpar

Sukol has crossed the border and Nuru and Sattar are absconding, he said. Police raided the houses of Nuru and Sattar three times but failed to arrest them, he claimed.

JCD activist dies in custody

A Jatiyatabadi Chhatra Dal (JCD) activist of Bauphal upazila and an under-trial prisoner died at Patuakhali General Hospital following alleged torture by police and party rivals on Wednesday night.

The victim, Ramjan Ali alias Shakil, 24, was an accused in a case of lifting a motorbike at Bauphal Police Station (PS).

According to sources in Bauphal PS, party rivals caught and tortured Shakil at village Indrukul before sending him to the police station on April 15. The same day police sent him to local upazila health complex for treatment. Police sent him to the magistrate's court after his discharge from the hospital on April 17. From there he was sent to jail hazat. The jail authorities sent him to the general hospital at noon on Wednesday where he died at about 8 pm.

The same day the victim's mother Shahida Begum filed a case with Bauphal PS. She alleged that her son had been caught by party rivals from a meeting held at local Akbaria Senior Madrasa field. He sustained serious injury after they beat him with lethal weapons. They handed him over to police.

Police also tortured him at the hazat the victim's mother claimed

Withdraw partisan CMP commissioner: Mayor

Chittagong tense: Another labourer injured in Thursday's clash dies

Another labourer, critically injured during Thursday night's clash with police, died at Chittagong Medical College Hospital (CMCH) Friday

morning, raising the toll to two. Victim Md Shahabuddin, 35, was a ghat worker at Majheerghat in Doublemooring thana.

Earlier on Thursday night, labourer Md Shahjahan, 55, was shot dead and at least 25 others including three policemen were injured in the clash between labourers and law enforcers at Maheerghat in the city.

The clash had erupted following the arrest of Mahbubul Haq, president of Ghat Sramik League. Agitated workers set fire to a police van during the clash.

The killing of two workers created widespread anger among workers in Maiheerahat area

Chittagong Metropolitan Police (CMP) authority's alleged obstruction in holding of their namaj-ejanaza at Laldighi Maidan Friday afternoon fuelled the tense situation in Chittagong yesterday.

Awami League leader and Chittagong City Corporation (CCC) Mayror ABM Mohiuddin Chowdhury at a press conference at Chittagong Press Club yesterday alleged that the CMP Commissioner has created an "unwanted situation by siding with four-party alliance candidate and state minister for civil aviation and tourism Mir Mohammad Nasiruddin".

Mohiuddin, a Nagoric Committee candidate in the upcoming CCC polls, is trying to retain his mayoral post. Nasiruddin is vying for the post as a four-party alliance candidate.

Police on Friday filed three separate cases with Doublemooring thana in connection with the clash. In one of the cases, specific charges were brought against 28 labourers. Thirty 'unidentified' people were accused in another case.

Awami League sources alleged Shahabuddin died at CMCH following excessive bleeding.

"Police kept bullet-hit Shahabuddin handcuffed while he was being taken to hospital. This caused problem for doctors to provide him blood and saline," alleged an Al leader at the press conference.

namai-e-ianaza. "The two bodies were brought to Chittaogng General Hospital morgue in the morning for autopsy but it was done in the afternoon due

to police obstruction. Huge contingents of police and BDR had encircled the Laldighi Maidan where namaj-e-janaza for the two labourers were scheduled to take place in the afternoon, AL leaders alleged.

Police in the evening refused to hand over the two bodies. "Police even obstructed Mohiuddin Chowdhury at the morgue when he went there in the evening to receive the two bodies for janaza. After more than two hours' heated exchange of words, police handed over the two bodies to him (Mohiuddin) at 8.15pm on Friday and the janaza was held then, they

told the press conference. Janaza was held at around 9 pm Friday at the Laldighi Maidan without mike as police took away the

The bodies were sent to their village homes in Bhola, where they were laid to rest yesterday.

At the press conference, Mohiuddin Chowdhury condemned the police role on Thursday and Friday and said these were done either to spoil the CCC polls or reap benefit for Mir Nasir.

"Police, resorted to repression and arrest of the opposition leaders and activists at the instigation of Mir Nasir," he alleged.

He condemned the killing of two labourers and demanded judicial inquiry and exemplary punishment to the persons involved.

AL presidium member Ataur Rahman Khan Kaiser, former minister Mosharraf Hossain. Akhtaruzzaman Chowdhury Babu, Gono Forum leader M Kafiluddin, CPB leader Shah Alam and JSD leader Indu Nandan Datta were also present, among others, at the conference.

Mohiuddin also demanded withdrawal of CMP Commissioner Amjad Hossain before the May 9 Chittagong City Corporation (CCC) polls. "Through arrest, intimidation and

repression on opposition leaders and activists, the Commissioner has created a panicky situation in the port city ahead of the CCC polls. We think the main motive is to pave the way for the four-party alliance candidate," he alleged.

He said, "The CMP Commissioner has already made his intention clear to all of us and we believe the CCC polls will not be free and fair as long as this man remains there as Commissioner of CMP".

"We earlier complained to the Chief Election Commissioner about the CMP Commissioner and if necessary we will submit another complaint soon," Mohiuddin Chowdhury said.
