

Six killed, over 2,000 down with diarrhoea

In the worsening diarrhoea situation, six people died while 2,153 more fell sick from the disease across the country yesterday.

Number of deaths from the water-borne disease in last one month now rises to 18.

During the period, the disease spread among 50,406 people, exceeding last year's March 25 to April 25 figure by a small margin, health directorate sources said.

Experts warned of an early attack of the disease this year and said the situation would worsen with the onset of heat wave.

Meanwhile, raining in the evening yesterday brought a brief respite from the heat wave that was continuing for the last few days.

People ill with diarrhoea were from 89 upazilas of 29 districts. Of the dead, three died in Chandpur, two in Faridpur and one in Kurigram, health directorate sources said.

JOURNO BELLAL KILLING Charges pressed against four, 'mastermind' spared

Police yesterday pressed charges against four people -- three outlaws and one drug peddler -- under the Explosive Substances Act for the bomb attack at Khulna Press Club on February 5 killing journalist Shaikh Belaluddin and wounding three other newsmen.

Belal was local bureau chief of Dainik Sangram and president of Khulna Metropolitan Union of Journalists.

The officer-in-charge (OC) of Khulna thana submitted the chargesheet to the Court of Chief Metropolitan Magistrate.

The chargesheeted accused are outlaws Syed Iqbal Hossain alias Shadhin, Chowdhury Rafiqul Islam alias Hasan and Mirajul Islam alias Miraj, and drug peddler Goda Yunus. All are now in Khulna District Jail.

Sources pointed out, however, that the mastermind behind the bomb attack is not on the chargesheet of the case investigated by OC Iqbal. Shadhin and Goda Yunus had earlier made confessional statements implicating themselves and the two others in the crime.

Twelve people, including the four chargesheeted, were arrested as

## No subsidy for irrigation despite diesel price hike

Saifur tells Economic Reporters' Forum

The government has decided not to subsidise irrigation although it is going to increase diesel prices once again.

"It is not possible to provide subsidy for irrigation as it can create ways for misuse."

Finance and Planning Minister M Saifur Rahman a delegation of the Economic Reporters' Forum at his secretariat office yesterday.

The shallow tube-well engines are being used for various purposes -- from irrigation to transportation -- making it difficult to undertake a subsidy plan for irrigation, he said.

The minister, however, said only the deep tube-wells, fixed installed ones, can be considered for some subsidy on oil prices during the irrigation season only.

But the Agriculture Extension Department has failed to identify the deep tube-wells that are genuinely used for irrigation purposes, he said.

"The government is facing a huge loss due to the recent price hike of oil in the international market," Saifur said. "We have to adjust oil prices with the international market to avoid a loss."

The minister said the government is considering a withdrawal of "zero-tariff" imports in the next

budget.

The forthcoming budget will be a pro-people budget, not a pre-election one, the minister said, adding that the next budget will reflect a development strategy aimed at reducing dependence on foreign aid.

Avoiding a categorical reply on the question of the increase in interest rates, the minister said, "Foreign investors will not invest here if the macroeconomic stability is hampered due to expansionary measures by the government."

"For this we have taken a balanced policy and it will be reflected in the next budget," he added.

NBR cuts up 2 luxury cars on tax evasion

The National Board of Revenue (NBR) yesterday made into scrap metal a Mercedes Benz and a Toyota Corolla imported under false declaration for tax dodging.

NBR officials cut up the luxury cars for scrap at Kamalapur Inland Container Depot in the capital in line with a High Court ruling. NBR Chairman Khairuzzaman Chowdhury was present there at the time.

"We could have realised Tk 20 lakh to 50 lakh in duties against the two cars, but we preferred to dismantle them to set an example so that no-one dares to commit the crime in future," the chairman told The Daily Star.

Sources in the NBR said Steel Trading owned by Mohammad Anisul Islam brought the cars inside a container two years ago to Chittagong port under a false declaration that scrap metal was inside



### No compensation yet for relatives of Savar victims

Distraught crowds continued to throng the Spectrum Sweaters Industries Ltd. in Savar yesterday, hoping to receive compensation for relatives injured and killed in the April 11 collapse. Instead, once again, they have turned away empty-handed.

Centenarian Abdul Hamid of Jamalpur was one of the desperate. His son, Mizanur Rahman, 20, a knitting operator of the factory, died in the collapse.

"The authorities of the factory have frequently changed the date of disbursing compensation, and I have not received a single penny as of today," said Abdul. "If they continue to do so, I fear I will not receive the compensation, as I can not keep moving from Jamalpur to Savar thrice in a week at this age."

Hamid, reduced to tears in front of the collapse site, said officers from BGMEA told them to throng the factory premises to receive their compensation. "I could not come here to get my son's dead body, but I have to come here regularly to get compensation."

The delay in compensation has caused widespread despair among relatives of the dead and injured. Many of the injured, meanwhile, have been compelled to go to their village homes, without completing their medical treatment.

## Two businessmen gunned down

Unidentified criminals killed two cable traders and wounded a bystander in a hail of bullets, before setting ablaze one of the dead inside an office at the Banasree Housing Project in Rampura yesterday, apparently in a business feud.

Witnesses said a gang of eight stormed the offices of Crystal Cable Network in the project at about 12:45pm, opening fire on two of the

eight owners of the cable network -- Sayem Rahman, alias Mithun, 35 and Shariful Islam, alias Titu, 32.

After shooting Mithun once in the eye, they doused him with kerosene and set on fire, causing severe burns to his head, face and hands. Titu suffered three bullets in the back and the hand.

When the criminals had fled, police rushed immediately to the office and sent the wounded to the
