## Police yet to rescue abducted N'ganj trader

### Family members under threat to withdraw case

Police could not rescue a businessman of Siddhirganj under Narayanganj after 11 months of his abduction.

Earlier, the members of his family paid Tk four lakh in ransom to the kidnapers to buy his release. Enamul Haque Falun was kidnapped at Godnail on July 18 last year while he was returning home with Tk 70,000. Falun's wife Asmaul Husna and brother Mir Dildar Hossain at a press conference at Narayanganj Press Club yesterday said they are not sure

whether Falun is alive or not as 11 months of the abduction have already passed without any communication from him. A case was filed against 19 miscreants of Siddhirganj, including Bilas, on July 30 with Siddhirganj police station. They said police are not arresting the abductors although the kidnapers are roaming freely at Siddhirganj area. The miscreants are giving threats to us for withdrawal of the case, they added. Three dyeing factories of Falun family have been closed after his abduction, they said.

## Water Kingdom at Fantasy Kingdom next month

The Water Kingdom, an amusement in water through different rides, will be launched alongside the Fantasy Kingdom at Ashulia on the outskirts of the capital next month.

This was announced by S M Kamaluddin, chairman of Concord Group, at a press conference at Concord Centre in Gulshan yesterday. He said the entertainment in the Water Kingdom includes water ride, giant wave pool, family pool, virtual aquarium, stage concert, catwalk and fashion ramp, lazy river, and large waterspray.

"Here we have tried to keep the entertainment facilities under the affordability of all from top class to commoners," said the chairman.

A fee of Tk 275 has been fixed for all rides including entry into the Water Kingdom. A person will be able to stay there for the whole day with this charge, he added.

Through a slide show, Kamaluddin also described different rides and facilities in the Water Kingdom.

The entry fee for Fantasy Kingdom is Tk 120 and for Heritage Park Tk 60 excluding fees for each ride. At present, the Concord Group is operating four parks- Fantasy Kingdom, Fantasy World and Heritage Park in Ashulia, while Concord Amusement World in Chittagong.

Executive Director of Concord Entertainment Co Air Commodore (Retd) Rashid Ahmed was present on the occasion.
