Stop murder, repression on journalists

Processionists chant slogans, hold rally in Rajshahi

Journalist in Rajshahi under the banner of 'Human Rights

Journalist Council' yesterday held a rally and brought out a procession in the city protesting murder and harassment of jour-

nalists in the country. The processionists paraded the city streets carrying banners and chanting slogans demanding trial of the killers and security of

The rally held at Shaheb Bazer zero point was also attended by human rights activists, members of the civil society and representatives of professional groups. It was presided over by Jahangir Alam Akas, Rajshahi Bureau Chief of Daily Sangbad.

Speakers at the meeting said there has been no respite in attacks on journalists in different areas of the country despite protests and government assurances

Journalists do not belong to any political party or group. They serve the nation and the people but are attacked when any report goes against the interest of any vested group, he said.

Murders of veteran journalists Shamsur Rahman, Manik Shah and Humayun Kabir Balu, have not been tried despite assurances by the government on several occasions, they said.

There has been no let in in the attacks. The Metropolitan Press attacked during Pahela Baishakh celebrations in which senior staff reporter of local Bangla daily Natun Probhat Ziaul Haque Zia was injured.

The Ittafak's correspondent Prof Mojammal Haque was also assaulted by BDR personnel, they

The speakers demanded withdraw a cases filed by Rajshahi police against daily Janakhantho photojournalist Salim Jahangir.

Rajshahi Union of Journalist RUJ) General Secretary and daily Sangram Rajshahi Correspondent Sarder Abdur Rahman criticised the police administration, alleging that the attackers on the press club are not nabbed though they are often seen roaming around Boalia police

Rajshahi Press Club Vice-President Anwarul Alam Fatik said the attacks are a threat to the entire journalist community and demanded punishment of the culprits and government steps to check recurrence of such incidents.

Jahangir Alam Akas said attack on journalists increased in recent days, which has also tarnished the country's image abroad.

Illegal netting of fries adds to fish depletion

Violating a government ban, hundreds of fishermen are netting shrimp fries with current nets in rivers in Satkhira district, close to the Sundarbans.

Use of current net is also banned. But scores of fishermen, joined by their wives and children are seen catching the fries in Kalindi, Chunkuri, Kholpetua,

rivers every day.

Huge quantities of fries of other fishes, netted along with shrimp fries, are just destroyed, greatly hampering fish production.

During a visit to the areas, local people told this correspondent that nets is going on but neither the local administration nor the Fisheries Department has taken any step to

Some fishermen said they sell a shrimp fry at Tk one and a lobster fry at Tk 2 to Tk 2.5. The demand and price of naturally produced fries collected from rivers are higher than

On contact, an official of the Fisheries Department seeking anonymity said though netting of fries with current nets is illegal and a punishable, they are not taking any action because the fishermen are very poor and unemployed and they

those produced in hatcheries.

are maintaining their families with the meagre income from sale of

He however said, if netting of fish fries can be topped during March-July, fish production will double. Some sources also claimed that shrimp fries collected from rivers are also being smuggled to India. Organised gangs of smugglers are engaged in smuggling the fries, they

Members of Khulna Press Club demand an impartial probe into the incident and punishment of APS Nannu for this, he said.

Youth shot dead, 50 injured as villagers clash in Sunamganj

A young man was shot dead and 50 people were injured as rival groups clashed at Chhoara Nogdipur village in Derai upazila in Sunamganj district Friday evening.

Four of the injured have been admitted to Svlhet MAG Osmani Medical College Hospital in critical conditions.

Fifteen others were admitted to Derai Upazila Health complex. Police said the groups led by

Moklis Miah and Angur Miah had a long-standing rivalry

in the village. On Friday in the afternoon children of the families had an exchange of words while playing at a primary school playground in the

This drew people from both groups, who clashed using lethal weapons and firearms, police said quoting local people

Nine shots were fired during the clash, they said

One Ruhel, 22, belonging to Moklis Miah's group, was shot dead during the clash.

Both the groups filed cases with Derai thana. No one was arrested till filing of the report.

10 RU students hurt in clash with villagers

At least 10 Raishahi University (RU) students were injured, one of them seriously, in a clash with villagers at Binodpur Bazaar Friday night.

The injured students are Tashigul Islam Tashik, Bipul Biswas, Shubra, Raiin. Asraf Hossain Raju, Shahin, Biplob, Faisal and Mahmud.

Faisal, 2nd year student of Applied Physics and Bipul of Accounting Department were rushed to Rajshahi Medical College Hospital

Sources said the clashed broke out after a group of Litchi traders beat up Faisal and his two friends Tasik and Bipul on Friday night as they protested when the traders were shouting near their boarding house in Binodpur area near the university. The traders were led by Abdus Salm, Shourab and Kabir.

As the news spread, several hundred students from RU dormitories and private boarding houses nearby rushed to Binodpur and swooped on the trader's houses.

As clashes broke out villagers ioined the traders and beat up students. Amid clashes and chase and counter-chase, the students ransacked some shops and houses.

Police brought the situation under control at around 1.00am. Additional police have been

deployed in the area and at Binodpur market to avert further clashes. Police arrested Lichu trader

Khokan, 29, two businessmen of Chawak and Bazaar Road areas in the city. Sanjoy is from a rich family in the city.

Some sources claimed that the footage was sent to a person in some others participated in mock France, who is seeking political asylum there.

Police said Sanjoy Ghosh and Mizanur Rahman Khokan along with some others had gone to the house of Sanjoy's uncle Advocate Ashok Ghosh at Raipura village in Chandpura union in Barisal Sadar upazila on April 22.

Their activities and mock minority torture drew attention of local people, who informed police, the Barisal City Corporation (BCC) Mayor and some officials. Meanwhile the matter became known to intelligence personnel

Mizanur Rahman, Officer-in-Charge of Barisal Kotwali police station, in a press briefing on May 11 admitted going to the spot on May 6 along with Vishnu Gosh, another uncle of Sanjoy, for investigating the

Inclusion of five third class and five fourth class employees and two

leaders in 12 vigilance teams of Barisal Education Board to visit HSC examination centers has created resentment among teach-

ers and invigilators. Board sources said, 52 vigilance teams have been organised to visit different HSC examination centers this year. Forty of them comprise teachers and 12 comprise board officials and other staff, the sources

Clerical staff and Board's CBA leaders Shahidul Islam and Md five 3rd class and five 4th class

employees have been included in the 12 teams.

The sources said there was competition among Board employees to be in vigilance teams as each member gets Tk 80 to 200 as honorarium per day according his posi-

Last year, around Tk 50,000 was spent for vigilance teams.

When contacted, Barisal Board Chairman Principal Anwarul Huq admitted inclusion of lower class non-teaching staff in the teams and said board officials are entitled to take their personal staff during any

Formation of vigilance teams is absolutely under his jurisdiction and no body can ask for explanation, he
