Public Announcement

Request for Expression of Interest (EOI)

The Government of the People's Republic of Bangladesh (GOB) is implementing the program of economic reform and modernization of the banking sector. A key component is the privatization of the state owned Rupali Bank Limited (RBL), by divesting its government owned shares to an interested and eligible strategic investor.

RBL is the only state owned bank listed in the Dhaka and Chittagong Stock Exchanges. The successful strategic investor will be required to provide capital to strengthen RBL and develop it into a strong and progressive institution which can play a significant role in the banking system.

The Privatization Commission now invites eligible strategic investors, which have both the financial strength and the competence to operate RBL as a standard banking institution to indicate their interest. Interested strategic investors:

- Must be a banking or non-banking company or bank investment company or a fund duly formed under the relevant law of a sovereign country, which is a member of IMF/World Bank and Switzerland or an individual(s), who must have integrity, honesty, reputation, track record and financial integrity together with no conflicts of interest that is unacceptable to the supervisory authority in its country of incorporation and to the supervisory authority in Bangladesh.
- Must have an understanding and real business purpose for proposing to make the required investment in Bangladesh, which shall be demonstrated by past experience and track record.

The Expressions of Interest (EOI) must be submitted along with the following:

- Three years audited financial statements and Memorandum and Articles of Association (or Partnership Agreement) with certificates of their registration from country's statutory authorities of the business enterprise. The same information should also be provided for other enterprises, if the applicant is a member of a Group of Companies.
- Bank credit references from two banks for each individual member (of the applicant) with letter of authority for collecting and verifying all the above or any information provided.
- An indication of agreement in principle to the acquisition from the investor's home country regulator.
- An indication that the applicant, if selected, shall undertake to invest in its own name and not in the name of a nominee front company.
- An undertaking to the effect that the Strategic Investor will inject new capital proportionate to its shareholding amount required to bring Rupali's Capital Adequacy Ratio to 9% as per Bangladesh Bank guidelines.
- Further to above, if the applicant is an individual or group of individuals, he (they) must also provide the following:
 - Evidence of sufficient funds to finance the initial and subsequent investment in the institution with letter of authority for collecting and verifying any information provided.
 - Brief resume including National Tax Number, National Identity Card and past relevant experience of the applicant (the statutory person) and each member's individual net worth supported by bank statements with letter of authority for collecting and verifying any information provided.
 - Names of firms/companies or businesses in which the person and immediate members of his family have interests.

Currently, GOB holds 93.26% of the total issued share capital of RBL. In the proposed structure of the transaction, government will retain 26% of the total issued capital and offer GOB's remaining ordinary shares (67.26%) to strategic investor meeting the GOB's Fit and Proper Test (Eligibility Criteria) through a process of international competitive tender. A short-list will be prepared based on GOB's 'Fit and Proper Test', and only short-listed bidders will be contacted for taking part in the bidding process. Tender documentations will be dispatched following signature in a confidentiality agreement and payment of a non-refundable application fee equivalent to US\$ 2,000 in Bangladesh taka or in any freely convertible currency like US\$, Euro, etc. Only bidders who receive tender documents will be invited to perform due diligence on the bank.

The Privatization Commission reserves the right to accept or reject any application or annul the process without obligating itself to any person or entity.

Eligible and interested strategic investors may obtain further information at the address below between 0930 hrs to 1400 hrs on working days.

Expression of Interest must be delivered to the address below by July 20, 2005 by 1200 hrs. EOI may be delivered by hand/special messenger, courier service (both national and international) or registered postal mails. In all cases, acknowledgement of submission must be obtained. Electronic submission will not be permitted. Late submissions will be rejected.
