Pledges to hold free, fair elections

The government yesterday appointed Justice MA Aziz, a sitting judge of the Appellate Division of the Supreme Court, Chief Election Commissioner (CEC), ignoring the longstanding demand of the opposition and the civil society for a consensus appointment.

President lajuddin Ahmed yesterday morning made the appointment on the advice of Prime Minister Khaleda Zia, causing widespread resentment among the opposition parties whose demand for a CEC acceptable to all was turned down

The government maintains that there is no constitutional obligation to hold talks with the opposition on the issue

Aziz, whose appointment came a day after MA Syed's tenure as CEC expired on May 22, took his oath of office yesterday afternoon. Chief Justice Syed JR Mudassir Husain administered the oath

On entering his new office yesterday evening, MA Aziz told journalists that his first priority is holding elections in a free and fair manner. Asked about the criticism from the SEE PAGE 15 COL 7

The court prohibited gathering, congregation, picketing and laying siege to the entrance to any court. It also slapped a ban on boycotting or abstaining from attending any court on the basis of any decision of any Bar associations or Bangladesh Bar Council.

The court also imposed a moratorium on activities interfering with judicial work or operations of any court or hindering access of any person to the courts. No rally can be held or human chain formed or sit-in

demonstrations staged on the Supreme Court premises or any court premises in the name of any forum or the Bar associations.

Besides, no lawyer can circulate leaflets, put up banners or give statements to or publish them in any way through the press or any other media.

"This injunction shall particularly be binding upon all advocates practising in any courts of law in Bangladesh and further that in the event of any breach by anyone of this order, proper steps to enforce this order shall be taken including proceedings for contempt of court and in the case of advocates." the order savs.

"Such steps shall include making orders prohibiting them from appearing in court as advocates so long as they shall remain in contempt." said the order issued by the bench of Justice Md Abdul Matin and Justice AFM Abdur Rahman. However, the court says, "Any

person affected by this order may apply to this court for an order setting aside or varying this order." In case of such application, the attorney general will stand for the

order while four senior lawyers will act as amicus curie (friend of the court). They are Dr Kamal Hossain, Rafique-ul Hug, Mahmudul Islam and Ajmalul Hossain.

The chairman of Bangladesh Bar Council has been directed to circulate this order to its members and the Supreme Court registrar to circulate the order through the media.

One of the three bidders of Sirajganj 450 megawatt power project has withdrawn from the bid that opens Thursday, expressing its 'no confidence' in Bangladeshi bidding process citing examples of questionable handling of Meghnaghat-2

Bangladeshi Summit along with German Siemens, and Bagladeshi PHP group along with Indian Essar -- are participating in the bid. Genting, Summit and PHP were selected through request for proposals (RFP) five months ago.

The PMO officials through the power ministry managed these actions as the two officials had raised some questions about the faulty Meghnaghat-3 unsolicited negotiations. Genting also cited its shock at

Genting sources said the Power Cell tried to calm the Malaysian company saying that for the Meghnaght-3 project, there will be Swiss Challenge asking others to meet the offer of Cadogan-Manning. Seizes 30 unregistered cargo vessels, exempts passenger launches

Bangladesh Inland Water Transport Authority (BIWTA) has started fresh block raids on the Buriganga and Shitalakhya rivers to apprehend unregistered cargo vessels while passenger vessels, exempted from the block raids, are plying as usual although three consecutive ferry disasters recently claimed around 300 lives.

Tk 381cr diesel subsidy planned, despite nay of finance

The agriculture ministry plans to pump in an additional Tk 381 crore as diesel subsidy for irrigation in the next fiscal year, despite a strong reservation of the finance ministry about it.

Sources said the agriculture ministry will seek prime minister's intervention to resolve the issue.

The ministry also has decided to allocate Tk 600 crore in direct subsidy for fertiliser from its own coffers in FY 2005-06, following the current pattern

The government recently disbursed Tk 6,620 crore, the ministry's budget for the next three years, in advance for better programme planning and implementation. Of the sum, Tk 1,985 crore is earmarked as its budget for FY06, outlying a Tk 1,395 crore revenue expenditure and Tk 589 crore for development work.

But the ministry finds the budget, which does not allocate any subsidy for diesel used for farming, inadeguate. The resource constraints also have forced it to limit the next year's fertiliser subsidy, its officials said. "We wanted a bigger subsidy But the amount we have received for the next three years does not allow that." said one of them.

The current national budget initially allocated Tk 600 crore for fertiliser subsidy. In the revised budget, yet to be approved, the amount has been increased to Tk 614 crore, with Tk 376 crore for urea and Tk 271 crore for other fertilisers

and Tk 7 crore for sugarcane farm-The three-year budget of the ministry assigns Tk 650 crore farm subsidy for FY07 and Tk 700 crore for FY08.

TUG OF WAR ON DIESEL SUBSIDY

The agriculture ministry has for long been arguing with the finance ministry in favour of a diesel subsidy.

The finance ministry believes diesel subsidy is a waste, as many of the recipients use it for purposes other than irrigation. like running motorised boats and other transports.

The agriculture wing, on the other hand, argues that measures can be taken to ensure that the subsidy reaches only the true farmers, which would scale down the irrigation cost.

"Farm subsidy in our neighbouring countries is much higher than ours. Pakistan spends more than 300 million dollars and India as much as 10 billion dollars for this purpose," pointed out an official.

"Besides, as per the World Trade Organisation rules, there are much scope to increase agri-subsidy. They suggest it can be up to 10 percent of the agricultural GDP. Compared to that, the current Tk 614 crore farm subsidy is less than 1 percent," he went on.
