# Fuel price hike again

### Pricey diesel to hit farmers; inflation feared to spike further

Bowing to multilateral donors' insistence, the government yesterday increased the prices of diesel, kerosene and petrol only six months into the last price hike.

The price of petrol has been reset at Tk 35 per litre, raising it by Tk 2, diesel at Tk 26, marking a rise of Tk 3, and kerosene at Tk 25, pushing it up by Tk 2.

The price of octane, however, remains unchanged.

Until this latest hike, the prices of diesel and kerosene were the same. Now, diesel will cost Tk 1 more a litre than kerosene

Officials of the energy ministry said, after paying the import costs and duties, the actual cost of a litre of diesel comes to Tk 35 and kerosene Tk 38.

"If we had not adjusted the prices, Bangladesh Petroleum Corporation would have incurred a loss of Tk 2,075 crore this year due

to the wide gap between import cost and selling price. This price adjustment will help reduce the amount of that loss," said an official.

Explaining the reasons for the price hike, State Minister for Energy AKM Mosharraf Hossain told The Daily Star last night, "As per our energy pricing formula, price of petroleum products has to be adjusted every six months. It was not due to any pressure but to scale down the huge loss being incurred by the state-owned oil agency BPC that we have reset the prices.'

"Even after this price hike, BPC will incur an loss to the tune of Tk 1,200 crore this year. To avoid this loss, the government is considering lowering the duties on import of petroleum products," Mosharraf said, adding, "On an average the import duty on petroleum products now is 25 percent and BPC pays the government more than Tk 2.500 crore every year in import duties."

According to the minister, "The

rise in prices is but slight and therefore it will not make any negative impact on the inflation.

On diesel subsidy for farmers, he said he was not in a position to talk about it, adding the finance ministry could shed light on the issue. He however maintained that "As the irrigation season is over, I don't think this hike will affect the farmers,"

But Bangladesh Institute of

Director (BIDS) Dr Zaid Bakht was of an opposite view. "The fuel price hike will affect the inflation," he said, "And as the price of octane remains the same, while that of diesel, kerosene and petrol mostly SEE PAGE 15 COL 1

#### 50,000 marooned in Moulvibazar flashfloods

**Bloated ADP finalised**

The government has finalised a Tk 25,290 crore outlay, 10.62 percent higher than the current one, for the next fiscal year's Annual Development Programme (ADP) and non-ADP. Keeping the election in view, this

bigger development fund will be spent on 1,372 projects -- 516 of which are new and unapproved. In contrast, this year's ADP has only 330 new projects of the total 1.199.

The National Economic Council (NEC) at a meeting today chaired by the prime minister will approve the

The next year's ADP has been proposed at Tk 24,500 crore with Tk

17.000 crore in local currency component and Tk 7,500 in foreign currency. The non-ADP development funds of Tk 790 crore will be used through the revenue budget.

The new ADP includes Tk 2,045

crore block allocation against the

current Tk 1,812 crore. "The block allocation will be used to fund the unapproved 516 projects during the next fiscal year," said a planning ministry official.

Although the size of the current development funds was originally Tk 22,860 crore (with Tk 22,000 crore in ADP), this has been revised down to Tk 21,493 crore. The revision will also be approved by the NEC meeting today.

Believes opposition will accept him

New Chief Election Commissioner (CEC) MA Aziz yesterday said he favours an independent Election Commission (EC) secretariat but has not looked into his predecessor's proposals about reforms to the EC and electoral rules.

Immediate past CEC MA Syed proposed an independent EC secretariat free from government influence if elections are to be free "I do not know how far the gov-

ernment controls or influences the

Election Commission secretariat," Aziz told journalists replying to a query on reported influence of the government on the EC secretariat. But I believe it should be independent," the CEC continued.

About reforms, Aziz said reforms are a must to make the rules up-todate. "Reform is an ongoing process. There are no bindings that rules cannot be amended," he said.

The new CEC also spoke about the strong opposition criticism for his unilateral appointment and said he believes the opposition parties will eventually accept him.

The main opposition Awami League (AL) rejected his appointment, terming it an effort to politicise the Election Commission. Other opposition parties expressed their shock and frustration, and slammed the government for making the

# HC asks why not probe by judge

Blocks owners' disposing of assets

The High Court yesterday issued a rule asking the government why it should not be directed to form a commission headed by a sitting or a retired Supreme Court judge to inquire into the factory collapse in Savar, find the culprits and suggest measures to prevent such disasters in future.

The court also restrained the chairman, managing director and directors of the Spectrum Sweater Industries Ltd from disposing of their assets and properties

It asked them to show cause why they would not be directed to pay adequate compensations for rehabilitating the victims.

The court orders came following a writ petition filed by four injured workers and nine rights based organisations. The court yesterday issued the show cause notice on about 20 people asking them to reply in two weeks.

The respondents include the secretaries of the ministries of home, labour and employment, industries, food and disaster SEE PAGE 15 COL 1
