Indian enclaves in 2 dists 'safe havens' for criminals

Large scale hemp cultivation in enclaves in Dinajpur, Panchagarh

Most of the 12 Indian enclaves in Thakurgaon and Panchagarh districts are safe havens for crimi-

After committing crimes in Bangladesh, they take shelter in the enclaves because Indian authorities seldom take any interest in the people there, sources in Bangladesh administrations and BDR said.

Bangladesh police and BDR need Indian authorities' permission to enter the enclaves, they said.

Taking this advantage, these enclaves have become transit points for smuggling of drugs, arms and other goods. Hemp is now replacing crops and vegetables in many areas as this is much more profitable and has ready markets in Bangladesh, they said.

Even Bangladeshis take shelter in the enclaves after committing

The enclaves are Putimari, Daibata, Sharbari, Nataktopa, Balapara, Gaihata, Ghagraghata, Kotbazini and Shal, covering about 11.232 acres of land with a total population of 16.205. Most of the smaller enclaves are several kilometres inside Bangladesh.

According to enclave people, hemp is cultivated on large scale in about 10 of the enclaves in the two

Sources in Thakurgaon Department of Agriculture Extension (AED) also said there are about 1,120 hectares of cultivable land in Thakurgaon enclaves and 1,942 in Panchagarh enclaves.

Hemp cultivation started in the enclaves about four years back. It has doubled within the short period, the AED sources said.

Organised smugglers' syndicates both in Bangladesh and India provide the enclave people with inputs like seed and tertiliser for hemp cultivation and buy back the product at good prices.

Sources in Panchagarh AED said the lands are losing fertility due to continuous cultivation of

During a recent visit to Putimari, Daibata, Sharbari, Nataktopa, Garati and Singimari, local people said farmers who used to cultivate jute, rice and vegetables earlier now grow hemp. Some are however trying

maize, a new crop in the area. It was gathered that hemp is being cultivated on at least 2,180 acres of land in these enclaves.

As huge quantities of firewood are needed to dry hemp, producers procure the firewood mostly by stealing trees from Bangladesh territories under cover of darkness, they claimed. Greens are disappearing around the

Another reason of large scale hemp cultivation is that Indian authorities do not care to supply them seed, fertiliser and insecti cide for vegetable cultivation, they said. Besides, there are problems in marketing vegetables grown in

"We prefer hemp cultivation because the profit is assured,

unlike in case of vegetables", a resident at Putimari said.

When contacted a police official in Panchagarh said they know what goes on in Indian enclaves. "But we can not enter there to track down criminals or destroy hemp fields", he said seeking anonymity. The crimes include robbery, extortion and theft.

An official of 15 Rifle Battalion said they informed BSF that criminals hide in the enclaves and that hemp is being cultivated in large scale there. Only BSF can nab the criminals, he added.

But the enclave people have also allegations. They are deprived of all facilities including healthcare, education and water supply, which are supposed to be provided by the Indian govern-

There is virtually no administration in the enclaves.

The enclave people often move freely inside Bangladesh and avail all facilities to earn their livelihood people in Bangladesh

Corruption charge against Rangpur poura chairman

Ten ward of commissioners at a press conference here yesterday brought allegations of corruption and nepotism against Rangpur Municipality Chairman of Abdur Rouf Manik.

Idris Ali, panel chairman of the municipality, read out a written statement at the press conference, held at the District Council auditorium. He made as many as 10 allegations against the municipal chairman.

He said the chairman terminated 170 employees of the municipality and re-appointed some of them without approval of the municipal council.

Ward Commissioner Idris Ali alleged that the chairman selected contractors for repairing different roads without discussion with the council.

He also alleged that as per local government regulation, a municipal chairman is supposed raise agenda of any development project or programme at council meeting for approval, but he selected projects himself and invited contractors, ignoring the council.

The municipality with Tk 10 crore government funds is now repairing different roads in the town.

committee selected contractors were wrong and inappropriate.

He also claimed that the municipality is spending Tk 1.5 crore more than the estimate, which could be saved if work orders were not issued at 'inflated rates. When asked by this correspondent

later, Municipal Cchairman Abdur Rouf Manik denied all allegations brought against him. He said approval of the council is

not needed when a tender committee is formed beforehand as per the government guidelines. He said, "Being convener, I issued
