Hasina begins Europe tour June 18

Leader of the Opposition in Parliament Sheikh Hasina is expected to leave for London en route to France and Russia on June 18.

An Awami League official said that she would visit Strasbourg, France at the invitation of President of Parliamentary Assembly of the Council of Europe (PACE) Rene Vander Linden.

The visit is designed to familiarise the senior Advisory Council members of Association of Asian Parliament for Peace (AAPP) with history, structure and mechanism of the Parliamentary Assembly of the Council of Europe (PACE).

Hasina, a senior member of the Advisory Council of AAPP, will be in Strasbourg from June 20-24 and from where she would go to Moscow

Her schedule to go to Munich was changed because of election there in September.

The Awami League chief is expected to be visiting Moscow from June 25. The People's Friendship University of Russia will honour with a doctorate degree.

During her stay in Moscow, she is expected to meet the Russian Foreign Minister and deputies of Russian Parliament.

Hasina is likely to return home on June 29.

Awami League leaders Sheikh Fazlul Karim Selim, MP, Kazi Zafrullah, MP, Syed Abul Hossain, MP, former ambassador Mohammad Ziauddin and Mahmud Hassan will accompany her.
