Crimes down in B'baria as community policing pays

Community policing has improved law and order in the district and created enthusiasm among people seeing its success in a short time.

It was introduced on May 1, villagers often took place in differinvolving people from all walks of life.

Highway robbery, piracy on rivers, snatching and abduction both in rural and urban areas have become rare after introduction of community policing. This was stated at a law and order review meeting, held on June 20.

The meeting was told that in April, five murders, three incidents of dacoity, three of piracy, and 22 incidents of violence against women were recorded in different areas of the district.

In about fifty days from May 1 to June 20, four murders, two incidents of robbery and 21 incidents of violence against women were recorded, according to sources in police and the administration

On the other hand, tipped-off by members of Community Police, police nabbed 34 alleged

dacoits and another 57 for other crimes in 50 days from May 1. In April, they had nabbed 13 dacoits and 15 others for various crimes. Clash over trifles involving

ent parts of the district earlier This has virtually stopped as the members now quickly inform police if they apprehend any clash. Police takes action immediately. Four clashes involving villagers took place in April, but

there was none since May. Being close to the border Brahmanbaria was a transit point for smuggling. This has also been reduced drastically.

All classes of peoplestudents, teachers, workers, local elite religious leaders, workers and women are involved in community policing in each community in urban and rural areas. Their

They hold regular rallies in their areas, also attended by the SP and other police officials.

Besides law and order, the rallies discuss violence against women and children, dowry, child marriage, smuggling, drug control and anti-social activities and create awareness among people.

This has also helped a lot in creating good relations between police and people. The SP said about 50 such

programmes including 15 big public meetings were held in different areas of the district since May to create awareness and implore people to rise against crimes.

Health care, family planing tree plantation. fish cultivation and adult literacy were also discussed in the meetings. "The improvement in law and

order is the result of Community Policing", the SP said. "The situation will improve further if we involve more people number is about 12,00 now, in such activities", he added. according to Police

NILPHAMARI POSTAL SCAM: FRESH CASE AGAINST 7 **Defalcation of another** Tk 1.48 cr detected

Defalcation of more Tk 1. 48 crore from depositors' accounts by postal employees has been detected at Nilphamari Head Post Office.

A fresh case has been filed with Nilphamari thana after the detection by the probe body, sources said vesterdav

Seven postal employees have been charged in the fresh case filed on June 20 by Post Master of Nilphamari Head Post Office Torab Ali. They include the four sued in two cases filed earlier when misappropriation of Tk 2.84 crore was detected

The three others charged in the fresh case are Abdul Salek, now Assistant Post Master at Rangpur Head Office; Golam Nabi Sarkar, Assistant Post Master at Gaibandha Head Post Office and Azaharul Islam, Post Master at Kishoreganj Upazila Post Office.

They were postal operators at

Nilphamari Head Post Office earlier. The four others are Assistant Post Master at Nilphamari Head Post Office Mir Nural Islam Munna, Ledger Operator Ahmedul Islam Raju and postal operators Taslim Uddin and Liaquat Ali Khan, all charged in the previous two cases

also. They are in custody now. Golam Nabi Sarkar is under suspension now for his alleged involvement in a postal scamp in Gaibandha Head Post Office.

Sources at the Head Post Office here said the Tk 1.48 crore defalcation was detected during probe in the last one month in different sections by the second investigation team. The investigation is continuing, they said.

The first five-member probe body formed at the directive of Post and Telecommunication Ministry conducted its investigation from April 4 to May 19.

TK 21CR SOUGHT BY MINISTRY Barisal education board staff terms it 'extortion'

Employees of Barisal education board held a rally on the office premises yesterday protesting a decision by the education ministry to reaslise Tk 20.75 core from all the education boards in the country for distribution of computers in educational institutions.

The programme was called by the Inter-board Employees Union Federation.

Speakers termed the decision to realise money "toll collection" and said they will build tougher agitation if the ministry does not change its decision.

Sources said, the education ministry is seeking Tk 7 core from Dhaka education board, Tk 5 core from Jessore board, Tk 3 core from Rajshahi board, Tk 30 lakh from Barisal board. Tk 1.5 core from Comilla board, Tk 50 lakh from Svlhet board. Tk 2.5 core from Madrasha education board, Tk 50 lakh from technical education board and Tk 40 lakh from the National Curriculum and Text Book Board for distributing free computers to educational institutions.

Amtali-Kuakata road plan gathering dust

Funding uncertain after June 30

Re-construction of 25-kilometre Amtali-Kalapara part of Patuakhali Kuakata road has become uncertain due to alleged bureaucratic tangles.

The Tk 50 crore Danida assisted project is awaiting approval for about 10 months. The donors now say funds may not be released if the project is not approved by June 30, according to sources

The Patuakhali-Kuakata road development project, involving Tk 126 crore, was taken up considering prospects of tourism in Kuakata and fish farming in the areas nearby. There is bright prospect of private sector fish hatcheries in the area. and many prospective investors have shown interest following the road development plan.

The 30 kilometre road from Patuakhali to Amtali has been reconstructed at a cost of Tk 44 crore, provided by Danida.

After completion of Patuakhali-Amtoli portion of the road, Danida submitted a project in August last year for re-construction of the 25 km Amtali-Kalapara portion of the road.

But files on the project are still being shuttled among government departments, sources in Roads and Highways Department (R&H) here said.

They said the project proposal was sent to the communications ministry, with a note for approval

The ministry sent it to the Cabinet Committee on Purchase, which returned it to the ministry, seeking comments from the ERD and IMED as it involved foreign assistance. The ministry then sent it to ERD and then to IMFD

The ministry had assured the R& H department that the project would be approved by December last year, sources said while talking to this correspondent recently. Meanwhile, the donors also gave

letters to the ERD and the ministry to hasten the approval. Finally, a letter from the ERD reached the donors that the project would be approved by June 1 this year.

On June 13, the donors at a meeting told consultants that they would not release the fund if the project is not approved by June 30. Sources in the R&H said they do

not know why the approval is being delayed. The project will become uncertain if the approval is not given by June 30.

They said construction of three bridges on the road has been planned with local resources in view of assurance of development of the Patuakhali Kuakata road. This will establish direct road link between tourist spot Kuakata and Patuakhali Seeing the prospect of good communication, many investors have come up with plans for fishery and tourism projects in Kuakata, they said
