

NOAB-BSP demands cut in import duty on newsprint

Newspapers Owners Association of Bangladesh (NOAB) and Bangladesh Sangbadpatra Parishad (BSP) yesterday demanded reduction of import duty on newsprint to 5 percent from 25 percent as proposed in the budget for FY 2005-06.

The associations in a joint statement also demanded withdrawal of the rules of using 50 percent local newsprint in the newspaper industry and increasing the rate of government advertisements to save the industry.

The government has fixed the import duty of newsprint at 25 percent in the proposed budget. Besides, the importers have to pay 35 percent VAT and other charges on C&F (clearing and forwarding) prices, the statement said.

The statement, signed by NOAB

## AL lawmakers protest budget inside JS

The main opposition Awami League (AL) lawmakers yesterday staged demonstration inside the Jatiya Sangsad Bhaban carrying black flags in protest against the proposed budget for FY 2005-06 which they termed "anti-people."

The AL also enforces a dawn-to-dusk hartal across the country today as the government did not accept its 13-point amendments to the budget. AL's allies Jatiya Samajtantrik Dal (JSD) and National Awami Party (Nap) have extended support to the shutdown.

"We don't accept this budget of black money," the main opposition lawmakers chanted as they started a procession from the conference room of the leader of the opposition

in the parliament building at about 4:25pm.

The slogan-chanting lawmakers came out of the Sangsad Bhaban with the procession and held a brief rally near the South Plaza.

Earlier, the AL lawmakers attended a meeting of AL parliamentary party (ALPP) which was chaired by party General Secretary Abdul Jalil. Only 26 party lawmakers out of 57 attended the meeting held at the opposition leader's conference room.

AL chief Sheikh Hasina is now on tour in Europe while Deputy Leader of the Opposition Abdul Hamid in his constituency, Kishoreganj.

Briefing newsmen about the ALPP meeting, Faruk Khan, acting chief whip of the main opposition, said the party thinks

there is no other option but to observe today's hartal as the government has failed to accept their 13-point proposals.

On June 24, the Awami Central Working Committee (ACWC) formulated the 13-point proposal for the budget and announced the hartal programme.

The proposals include withdrawal of tax on salt, milk powder, diesel and kerosene, software export, SIM cards, and increasing the allocation for agriculture.

Addressing the rally in front of the parliament building, the AL general secretary termed the proposed budget a "trickery" and said people have also rejected the budget.

"The option for whitening the

## US chopper downed with 17 GIs on board

A US military helicopter that crashed during an anti-guerrilla mission in eastern Afghanistan may have been shot down and the fate of 17 US troops aboard is not immediately known, the US military said on Wednesday.

Initial reports indicated Tuesday's crash in Kunar province, which borders Pakistan, may have been caused by hostile fire in the operation against al-Qaeda mili-

tants, the military said.

The twin-rotor CH-47 Chinook came down in remote and mountainous terrain west of Kunar's capital Asadabad, US spokesman Lieutenant Cindy Moore said.

Kunar Governor Asadullah Wafa said it was hit by a rocket and a spokesman for the Taliban, Abdul Latif Hakimi, claimed the guerrillas shot down the aircraft in the village of Shorak using "a new type of

weapon" he did not describe.

"Initial reports indicate the crash may have been caused by hostile fire. The status of the service members is unknown at this time," the US statement said.

It said US and Afghan troops had sealed off the crash site to block any enemy movement toward or away from it and US aircraft were flying overhead.

"This is a tragic event for all of us,

## Dr Sitara laid to rest

Hundreds of mourners yesterday paid their last tributes to Dhaka University (DU) journalism professor Dr Sitara Parvin who was killed in a tragic road accident in the US on Friday.

After namaz-e-janaza at the DU Central Mosque, she was buried at the city's Banani graveyard.

Wearing black badges, hundreds of teachers, staff, students -- present and former, and journalists began to gather at the Department of Mass Communication and Journalism to pay last tribute to their beloved colleague and teacher Dr Sitara, daughter of former president Shahabuddin Ahmed and wife of DU journalism professor Ahaduzzaman Mohammad Ali.

At 11:50am, Sitara's coffin was brought to the department from

## Bhuiyan for tough laws against hartal, JS boycott

Local Government, Rural Development (LGRD) and Cooperatives Minister Abdul Mannan Bhuiyan yesterday suggested in parliament introduction of tough laws to stop frequent hartals and House-boycott by the opposition.

Blasting the main opposition Awami League (AL) for skipping parliament proceedings, the LGRD minister, also secretary general of the ruling BNP, said the AL MPs take all the remuneration and privileges as lawmakers but do not discharge their constitutional duties.

Terming it "a contempt of parlia-

ment" he said, "It cannot be allowed." Bhuiyan was discussing on the proposed budget.

"If a lawmaker remains absent for ten consecutive working days without your permission, his membership will be vacated and he will be disqualified to contest in the election for one term," Bhuiyan suggested to the speaker.

He asked the speaker to take initiative to formulate such a law to stop House-boycott in consultation with the other political parties if the main opposition party does not attend the discussion.

To stop frequent hartal, Bhuiyan requested the prime minister to enact a tough law against hartal and

the persons who enforce it for greater interest of the country.

He criticised the main opposition for enforcing today's hartal protest in the proposed budget.

On the reforms of the Election Commission, the BNP secretary general said the AL cannot benefit from this reforms "unless its own mentality is reformed". He, however, urged the AL to place its proposal on the reforms to the electoral laws, if any, in parliament.

He said the fairer the election will be, the more seats the BNP will win in future elections.

## 13 Jubo League men jailed for picketing

A Dhaka court yesterday sentenced 13 Jubo League leaders and activists to two years' rigorous imprisonment for carrying out an arson attack on a rickshaw during hartal hours on February 6.

Metropolitan Magistrate Mohammad Shafiqul Islam of the Speedy Trial Court-1 handed down the verdict in presence of the convicts.

The court cancelled bail petition of the Jubo League men of the Kotwali Thana unit and sent them to Dhaka Central Jail.

The convicts are Pir Mohammad, Mohammad Nadim, Ramzan Ali alias Robin, Khokon, Mohammad Jahangir, Murad, Parvez, Ayat, Hayat, Sharif, Pokra, Mintu, Pintu and Mohammad Akhter.

They have also been fined Tk 1,000 each and would have to serve out 30 days in prison if they failed to pay.

## 1,670 acres rail land gobbled up
