NSI excess sparks protest

Journalists demonstrate in dists demanding withdrawal of false case and punishment to culprits

Journalists across the country yesterday protested Thursday's attack on photoiournalists by the National Security Intelligence (NSI) personnel in Dhaka.

The NSI men's atrocities sparked angry demonstrations and rallies in several divisional and district headquarters

Nine lensmen of different national dailies were injured, three of them critically, when NSI men swooped on photojournalists in front of their Shegunbagicha office in the capital on Thursady.

The trouble ensued when Enamul Kabir of the Janakantha was on professional work, taking a photograph of graffiti on the newly painted boundary wall of the NSI office.

About 50 NSI men came on the street in front of their office, indiscriminately beat photojournalists who gathered there on information while crowds and policemen

The incident triggered demonstrations by journalists and photojournalists in Dhaka on Thursday and Friday, protesting the atrocities by NSI men

Journalists and photojournalists in Rajshahi staged angry demonstrations and held a rally yesterday in protest against Thursday's attack on their colleagues in Dhaka. The demonstrators, joined by other professionals and cultural activists demanded punishment to the NSI marched the city streets and shouted slogans demanding an end to repression on journalists in different areas of the country. Journalist leaders at the rally at Shaheb Bazar also condemned filing of case by NSI men against the photographers and demanded its immediate withdrawal

The speakers said the NSI men acted against the spirit of the Constitution by obstructing photojournalists from discharging their professional duties.

Prothom Alo's staff photojournalist in Raishahi Azhar Uddin chaired the rally, organised by Rajshahi unit of Bangladesh Photojournalists'

The rally was addressed by, among others, Rajshahi Rakkha Sangram Parishad Convenor Zamat Khan, Prof Dr Sujit Sarker of Raishahi University (RU), the Sonali Millat, Metropolitan Press Club Secretary Anisuzzman and the Samakal photo journalist Abdul Zabid Apu.

The government has not yet taken any action against the NSI men for their uncalled for and unprovoked action on photojournalists while they were doing their professional work. This shows the government's attitude as regards press

95 cops punished in Khulna for crimes

Ninety-five policemen of different ranks were given punishment in last 17 months in the district including Khulna city for their involvement in criminal activities.

According to sources in Khulna Metropolitan Police (KMP) and Khulna Range DIG office, seven policemen were dismissed while 87 were given departmental punish-

The sources said punitive actions were taken against 67 policemen last year under the Police Regulations of Bengal (PRB) Act, while 15 others were punished under the Police Ordinance. Of

them, five were dismissed and nine suspended.

Twenty-eight policemen were punished from January to June 30 this year. They include Additional Police Superintendent of Khulna Mofazzel Hossain.

Recently, cases were filed with Khulna thana and Dakop upazila court against 17 policemen in connetion with murders of fish trader Abdur Rob Munshi and a boy,

SI Naru Gopal of Sonadanga thana of Khulna city and Constable Uttam Kumar of the same police station were dismissed from service for rape in Gobarchaka area

No launch service for remote Patuakhali people for 2 months

About one-and-a-half-lakh people of shoal areas in six unions of Galachipa upazila are suffering a lot due to stoppage of launch service on Patuakhali-Char Montaz route for about two months.

The unions are Char Kajal, Char Biswas, Char Montaz, Chotto Baishdia, Baro Baishdia and Rangabali.

The launch service was stopped following a launch mishap in the Buragourango on May 15.

Launches were the only mode of transport for people of the unions. At present, people maintain link with the upazila headquarters and else-

where with small boats. Although local people have

demanded of the authorities to introduce sea boat service on the route, but their demand is yet to be implemented.

Ill-fated 'Prince of Patuakhali' having no route permit with a capacity of only 80 passengers met the accident when it was going towards Char Montaz from Patuakhali with over 300 passengers, about 100 maunds of potatoes and groundnuts on board. Officially the death toll rose to 65 while unofficially it was
