# Tengratila victims start 15-day agitation

## Rallies, processions from today to Aug 2, hunger strike on Aug 4 to realise 8-point demand

The Tengratila Dabi Aday sangram Parishad, a non-poliitcal forum of affected people of Tengratila gas filed area, has announced a fortnight long agitation programme to realise their 8-point demand. The programme began yesterday.

The demands include compansation from Canadian oil company Niko for all the affected people after inquiry and for the gas burnt out and environmental damage, supply of drinking water in the area, rehabilitation of the affected ments, shifting of Tengratila High School and Tengratila Primary School to safer places and assurance that such incidents will not take

The demands were put forward

at a press conference held at Sylhet Press Club Saturday evening.

The agitation programme includes view exchange meetings with professional groups and political leaders in Doarabazar upazila from today, processions and protest rallies in Doarabazar and Chhatak, Sunamaganj district town and in Sylhet city from July 25 to August 2, human chain and mass hunger strike at Tengratila on August 4, and laying a siege to Niko's local office on August 7. A podium will be built at Tengralita on August 5 to hold protest programmes

Nurul Amin, Joint Convener of the committee, read out a written statement at the press conference. also addressed by freedom fighter Azimuddin Master, Ruhul Amian and Hadi Ahmed Fuad

They said several thousand

families in the five villages have been affected by the fire from blowouts in the gas field on January 7 and June 24. Their croplands are now uncultivable, fruit trees burnt out and other businesses stopped They were given Tk 5000 per family as 'disturbance allowance with an assutrance that proper compensation would be paid after inquiry.

But as there were flaws in the probe, they informed the matter to the Environment Secretary, but to no effect, they said

Moreover, arsenic has contaminated the tubewell water after the blowouts, which has been admitted

Waterbodies in the area which were earlier full of fishes, are now deplete, they claimed. Education of children is being greatly affected. The pass percentage in this year's SSC examination in Tengratila High School was 58 against 86 last year due to the fallout effect, they said. The high school and the primary school have been shifted to temporary locations

Sixty-six shops at Tengratila bazaar near the gas field have been

During agitation, the Sunamgani Deputy Commissioner at a meeting assured them of preparing a fair list of the affected people. But he forgot everything when we stopped agitation, they said.

The authorities are now trying to use force against them in the name of controlling the situation, they also

Police charged batons on protesters when the Sunamgani Bachao Andolon, a citizens' body called a hartal, they further alleged.

## Illegal clinics, labs defy order to shut down business

Illegal clinics and pathological laboratories in Shyamnagar upazila are doing a brisk business defying Satkhira civil surgeon's order to shut

Satkhira civil surgeon (CS) Dr Abu Aziz Al Monsur, issued the order on June 22, after an investigation found that some clinics and pathological laboratories run them without legal documents and qualified doctors

The clinics are Shyamnagar Modern Clinic, Parents Nursing Home, Janani Nursing Home, Janaseba Clinic, Sirima Nursing Home, Sundarban Nursing Home, Danta Seba Clinic, Sagar Dental and Barisal Dental and the pathological centers are Bismillah Pathology, Shyamnagar Pathology, Shanti Diagonstic Centre and Popular Diagonstic Centre.

People are being cheated as the clinics and pathological centres lack registered physicians and trained laboratory technicians. Patients get wrong pathological reports from the clinics and pathological centres, according to sources in the CS

Patients are also being cheated by so-called doctors who pretend themselves as qualified ones. Although they have no academic qualification, yet they mention on their pads MBBS, MRCP, MCPS or

When contacted, the civil surgeon said he has already requested police to take action against the cheats but they are yet to respond to it. He further said he has nothing to do in this regard adding he already sent letters to the higher authorities to take measures against the cul-

## Free CMCH from ruling party goons

Journalists in Chittagong yesterday held a big rally and brought out a procession in the port city demanding immediate arrest and punishment of the persons involved in the physical torture on a journalist at Chittagong Medical College Hospital (CMCH) on Thursday.

Jahed Al-Amin, Staff Reporter of daily Naya Diganta, was critically injured when tortured allegedly by some activists of Jatiyatabadi Chhatra Dal (JCD) and interns at the CMCH when he was interviewing an acid-burnt house-wife from Chandnaish. He is now being treated at a private clinic.

At the protest meeting jointly organized by Chittagong Union of Journalists (CUJ) and Chittagong Metropolitan Union of Journalists (CMUJ), journalists vowed to continue the agitation until CMCH was freed from vandalism by a handful of 'so-called internee doctors and employees' having links with the ruling BNP and its student front JCD.

The protest meeting held on Chittagong Press Club premises was followed by a big procession that paraded different streets of the city. It terminated at the Central Shaheed Minar in the city.

Addressing the rally, journalist leaders alleged that a few internee doctors misbehave with patients

and visitors almost everyday. They in connivance with a vested quarter have imposed an undeclared ban on entry of journalists there. They harassed and manhandled at least ten journalists who dared to go there on professional work in the last one year and set up a bad instance of torturing journalists at a place where patients go for treatment, the journalist leaders said.

A case was filed with Panchlaish thana accusing ten internee doctors and a ward boy on Thursday night. However, none of the accused could be arrest so far. Protesting filing of the case, internee doctors threatened to enforce a strike at CMCH.

Presided over by CUJ President Mostaque Ahmed, the rally was addressed, by , among others, CMUJ President Shamsul Haidary, General Secretary Md. Shahnowaz, CUJ General Secretary Shahid UI Alam, Nazim Uddin Shymal and Mahbubur Rahman

Meanwhile, Hosne Ara succumbed to her acid burn injury at the CMCH Saturday night. She died before giving any statement, which may hinder trial of the gruesome

Hosne Ara's brother Ramzan Ali, with the legal support of Bangladesh Society for Enforcement of Human Rights, filed the case with Chandnaish thana. None was arrested in this connection till filing of the report yesterday evening.

### 8 criminals held in Tangail: Two pistols. knives recovered

Police in a drive on Saturday morning arrested eight criminals from an auto-rickshaw stand here. Two foreign-made pistols with bullets, five mechets and three knives were recovered from their possession.

Shaheed Khan, 30, of Boalee and Julhash Miah, 20, of College Para under Tangail Pourasabha.

Coastguards arrested timber trader Jafar Soudagar along with a truck laden with smuggled timber on May 26. Later, it was found that the truck had been carrying 100 cft additional timber which is beyond the permissible limit under transport

After interrogation on June 15, the cops were produced before a Magistrate's court, which sent them to jail. A departmental investigation was done under the supervision of Deputy Inspector General (DIG) of Khulna Range Sohorab Hossain. The investigation report submitted on July 4 said there was no evidence of involvement of the policemen in
