529 languishing in CHT jails without trial

Judge Courts in three hill districts yet to start functioning

Under-trial prisoners are languishing in jails in the three hill districts as judge courts are yet to start functioning even after completion of infrastructure facilities.

There are at least 529 accused held on charge of criminal offences who are now in Rangamati, Khagrachhari and Bandarban district jails.

Trial is being delayed for years as Magistrate courts in district headquarters, and courts of the Divisional Commissioner and the Additional Divisional Commissioner (AC) in Chittagong can not dispose of the cases as they are doing the judicial work in addition to their administrative work, sources said.

Buildings and all other infrastructure facilities were built long ago but the government is yet to appoint judges to begin functioning of the judge courts though a law in this regard was enacted by parliament in 2003.

Till now the government has not come up with a Gazette notification to start functioning of judge

The delay in trial causes sufferings not only to the accused but also to the plaintiff. It involved additional expenditure for the government also because, it itself becomes the plaintiff at times.

In absence of judge courts, the accused who can not afford to engage lawyers do not get assistance from the government's legal aid fund. This is an obstacle to getting justice, some lawyers told this correspondent.

The then Awami League government set up the establishments including Judge Court buildings and residences for Judges in three district headquarters in 1998. In Rangamati, the building built for official residence of the District Judge is now being

Chittagong Hill Tracts (CHT) Regional Council Chairman.

The delay in disposal of cases increasing the number of inmates in the three district jails, which now accommodate people much more than their capacities, sources in Rangamati and Khagrachhari district jails said. They are huddled in jails and are deprived of facilities

As of Monday (July 25), the number of accused was 196 including five women in Rangamati jail, 192 including four women in Khagrachhari and 141 including 10 women in Bandarban jail, according to sources in the

The convicts were 41 in Rangamati, 36 in Khagrachhari and 33 in Bandarban jails till July Some of the cases were sent to

Commissioner from Magistrate courts in the three hill districts, but there has been little progress in their trial. The rest are pending with the Magistrate courts. As per Section 9 of the

the court of Divisional

Prisoners Act 1894, an accused should be produced before court once in every 14 days

But this is often violated as the jail authorities lack administrative

legal and logistic support to produce the accused before court within the stipulated time, they said. Moreover the magistrate courts can not issue production

A high official in Rangamati Jail said, as per rule, they send lists of accused to the Magistrate court regularly, seeking 'production warrant' (court permission to produce an accused). But production warrant is issued for only a handful of them.

"We have nothing to do if the court can not give a schedule", he

KCC member hurt in bomb attack dies

A Khulna City Corporation (KCC) ward member who was critically injured in bomb attack at a tea stall near the Eastern Jute Mills gate on Monday succumbed to his injuries early yesterday.

Shahadat Hossain Sarder,40, also a leader of Bangladesh Jatiya Party (BJP) led by Naziur Rahman died while being rushed to Dhaka for treatment as his condition deterio-

A group of four outlaws hurled two bombs at the victim when he was drinking tea at the stall during power outage, according to eyewitnesses. One of the two bombs hit Shahadat from behind. He was mmediately taken to nearby Phultala Upazila Health Complex from where he was shifted to Khulna Surgical and Medical Hospital. But doctors advised to take him to Dhaka as his condition worsened.

The attackers ran away chanting slogans in favour of Purbo Bangla Communist Party (PBCP

Janajuddho), eye witnesses said. Two of Shahadat's close associates were also injured during the attack. They are undergoing treat-ment at Phultala Upazila Health Complex.

The victim's elder brother, Golam Mostafa Sarder, filed a case with Khanjahan Ali Police Station

According to police, Rana was severely injured after he sustained six bullet injuries during an encounter between police and his accomplices. He is now undergoing treatment in the prison cell of Shurawardy Hospital in Dhaka. His condition is critical, KMP officials said.

Rana was wanted in two murder cases and five criminal cases, police said

Thousands displaced by erosion every year: Birishiri Tribal Cultural Academy, 125-year-old church and two schools threatened

The five kilometre Shibgoni-Bijoypur pucca road, linking border ing villages with Durgapur upazila has become unusable due to erosion at many points by the Someshwary river. The erosion has increased after recession of flood

After devouring about 3000 acres of land and over 1500 homesteads in six villages, erosion is now threatening the Birishiri Tribal Cultural Academy, a non-government Primary Training Institute (PTI), a 125-year-old Baptist Church and two schools in

The homesteads have been devoured in Shibgonj, Dakumara, Kullagora, Khamarkhali, Boraiundh and Birishiri villages in Durgapur upazila in Netrakona district.

During a recent visit to the area

displaced ober 6000 people in the villages. They have left homes and moved to temporary shelters.

About 20,00 people in the bordering villages are now suffering as the five kilometre road link has been snapped at several points. Talking to this correspondent,

local people said they urged to the authorities several times to build a. Sumeshwary river protection dam from Shibgonj to Bijoypur, but no nitiative has been taken by any quarter so far.

Bibha Sangma, 60, former director of Birishiri Tribal Cultural Academy regretted that though Durgapur upazila is rich in mineral resources like china clay and coal, neither the authorities nor the people's representatives have taken any step to improve the communication system.

Subandu Sarker Pintu, Chairman of Durgapur Pourasava, of indigenous people is neglected by the government. The local people appealed to the authorities and even staged demonstrations for system, but to no effect.

MA Karim Abbasi, lawmaker from the constituency could not contacted for comment despite repeated attempts

Mohammad Alauddin, Executive Engineer of Netrakona Water Development Board (WDB) said they have prepared a project to protect Durgapur town but have none to protect the area from recurring floods and erosion by the Sumeshwary. Floods occur mainly due to onrush of water from across the border and the river's behaviour is almost unpredictable. It would be difficult to stop the flood and erosion as the river turns furious when waters roll down the Garo hills across the border, he said.

3 cops face villagers' wrath for excesses

Three policemen including a subinspector (SI) of Debiganj Police Station in Panchagarh district were briefly held by villagers for ransacking a house and assaulting three inmates at Khaturia Dorjipara village of Sonaroy union in Domar upazila on Monday.

SI Mostaq and constables Azirul and Nuruzzaman entered the village allegedly without informing the concerned police authorities. Later, Domar police with the help of Sonara Union Parishad (UP) chairman and members rescued the three.

SI Mostaq told newsmen he along with two constables were besieged by people when they went there to arrest Entaj Ali, a domestic help of Mozammel Haq of Natun Bandar area in Debiganj. He said they went there following a complaint lodged by Mozammel's son Mukta that Entaj had fled away from his master's house with money, gold ornaments and other valuables. Mozammel's other son Manik accompanied the policemen during the raid, Mostaq said.

However, local people alleged the policemen led by Manik raided Entaj's house on Monday. They assaulted his mother Rezia Khatun,60, and sister-in-law Sufia Begum,21. Being angry at them, they confined the policemen and informed it to Sonarai UP chairman and Domar police who rescued them, they said.

Asked by newsmen, Entaj said he had been working in Mozammel's house for about four years. He came home to see his ailing mother a few days ago. Because of his delay to return to his employer's house, they had lodged the false case against him, he said. During a visit to Entaj's house on
