Modhumoti Model Town project illegal

HC rules in favour of public interest litigation; orders not to affect plot buyers

The High Court yesterday declared the controversial Modhumoti Model Town project of Metro Makers Ltd at Aminbazar on the outskirts of battle between an environmentalist . Dhaka unauthorised, illegal and SEE PAGE 15 COL 8 : against public interest.

The project located in a subflood-flow zone is contrary to the Dhaka City master plan and not approved by the city planners, Rajdhani Unnayan Kartripakkha (Rajuk), adjudged the HC division bench of Justice MA Matin and Justice AFM Abdur Rahman.

However, since people have already purchased some plots of the 'model town', the HC bench directed that the third party interest of the buyers should not be affected

Fate of fresh voter list in doubt

The Election Commission (EC) appears to be in a quandary about preparing a fresh voter list for the next parliamentary election.
The EC finds 'misinterpretation

of law' in the preparation of the last four voter lists and is itself confused about the provisions of two laws regarding the voter list that put the making of a fresh list in doubt.

The EC prepared fresh voter lists in 1983, 1990, 1995 and 2000 without amending the Electoral Rolls Ordinance 1982 which Chief Election Commissioner (CEC) MA Aziz said were not done lawfully, but following a convention.

The EC is yet to decide about making a fresh voter list or revising the existing one. EC officials now believe if they have to make a fresh; sessions with poor participation SEE PAGE 15 COL 4

Study shows voter list grossly flawed

Two former advisers of the caretaker government yesterday described the Chief Election Commissioner's (CEC) holding dialogue with all political parties on the voter list as

They said the Election Commission (EC) should instead discharge its constitutional duty to prepare a correct voter list.

Addressing a roundtable discussion in the city, Professor Wahiduddin Mahmud and M Hafizuddin Khan, who served the caretaker governments of 1996 and 2001 as advisers, said the caretaker

government system is not the sole condition for free and fair elections rather a strong and independent EC is a must for credible elections.

At the end of the day, it is the EC that conducts the elections, and so, it should be strengthened and given complete independence, they said.

Brotee and Fema, two election observer groups, organised the roundtable at the Biam conference centre. During the programme, they placed reports on municipal and parliamentary by-elections held in


