Bid to 'grab' Tk 20 cr govt land in Sylhet city

IQBAL SIDDIQUEE, Sylhet

An influential quarter is allegedly trying to grab prime government lands worth about Tk 20 crore in Sylhet city in the name of a housing cooperative society.

Some officials in the land ministry are involved in the process for permanent lease of the three-acre lands covering plots (dag)No. 604/605/ 606/607 and 703/704/706 in Sadipur mouja near the Shahjalal Bridge, sources said.

Several proposals for setting up government establishments on the lands were cancelled by the authorities earlier.

In 1993, the land ministry had approved a proposal to set up a truck terminal on part of the land. But, it was cancelled as the then Sylhet Pourashava failed to make the initial payment.

As per rule, approval from the Prime Minister's office is needed for leasing any land over three acres in any metropolitan city.

The sources claimed that the group has made a good progress in leasing the land, showing that some expatriates are members of the housing cooperative society.

In the petition, the chairman of the so-called cooperative society claimed that there are 240 expatriates in the society and that if the land is leased to them, they would play a vital role in investments in the country.

But interestingly, the housing society was not registered with the cooperative department when the application for lease was filed on July 2 last year, the sources said.

Citing documents, the sources said the group managed registration of the housing society 25 days after filing of the lease application.

The application only mentioned that there are 240 expatriates in the housing society, but no other details. Moreover, the application lacked details on layout of the land and mode of payment, either in foreign currency or local currency, the sources said.

ing society has been approved by officials concerned and sent to higher authorities, the sources

The officials has also quoted a price of Tk 52.842 per decimal for lease of the land to the housing society, which is far less than its actual price.

Official records show that in 2001, the then Deputy Commissioner of Sylhet, considering commercial importance, had fixed the price of the adjoining land at Tk 80,648 per decimal.

The present price of land in the area is about Tk 7 lakh per decimal the sources said.

Sources feel that, if the authorities need at all to sell the land it should be disposed of through open tender, so that a proper price

JCD leader sued for 'looting' brickfield

A JCD leader, his two brothers and 20 others were sued yesterday on charge of looting a brickfield in at Chamra Bandar in Karimganj upazila in the district for non-payment of toll.

Following an order by Kishoreganj Police Superintendent Mallik Fakhrul Islam, Karimganj thana OC Anisur Rahman filed the case against JCD (Jatiyatabadi Chhatra Dal) leader Saiful Islam Sumon, his younger brothers Saddam and Sayem and

Police sources said the JCD leader had demanded a toll of Tk 1.5 lakh from Helal Uddin Manik, president of Kishoreganj Brick Field Owners' Association. But he declined.

On June 20, the JCD leader and about 20 people kept Manik and his workers hostage in the brickfiled on gunpoint and looted bricks, sand and other goods worth Tk 1.5 lakh and took those away in boats and trawlers.

They also threatened Manik that he will have to pay them Tk 2 lakh before resuming operation of the brickfield in the coming winter

Members of the Brick Field Owners' Association called on SP Mallik Fakhrul Islam yesterday and complained against the JCD leader.

The SP immediately instructed Karimganj thana OC to record a case and to take action. The case

Kaptai Lake braces for fall in fish production

Poor rainfall blamed: Ban on fishing extended by one month to allow natural breeding

The district administration yesterday extended by one more month the ban on fishing in the Kaptai Lake to allow natural breeding of fish.

Every year fishing in the lake is banned for three months from May to allow natural breeding during the monsoon. The ban ends on July 31. This year the ban has been

extended by one month due to poor rainfall in the area. This has been done following a proposal by the Bangladesh Fisheries Development Corporation

(BFDC), which leases the lake to BFDC sources said if the droughtlike situation continues for a week or two, natural breeding of fishes and their production will be greatly ham-"We extended the ban due to less

rainfall this year ", said BFDC official Md. Shoeb Ahmad. Each year, the BFDC earns about Tk.2.5 crore from 5,000 to 6,000

tonnes of fishes sold from the lake. Like in previous years, BFDC had a plan to release 32 tonnes of fish

ries in the lake this year. It started releasing fries in the first week of "But, we stopped after releasing only seven tonnes on June 8 due to

drought-like situation", Shoeb

The prospect of releasing fries any more is bleak as the monsoon is nearing an end, he said. The lake is usually filled up with

water from the Lushai hills in neighboring India. But this year the flow from the hills is lesser, he said. "We are afraid that the natural

breeding of fishes in the lake will be greatly affected this year due to less water in the lake", said Senior Scientific Officer Md. Alamgir of River Research Institute. He said that there were two natu

ral sanctuaries for fishes-- one in Longdu and another near the BFDC office. But these can not be called sanctuaries now due to deposit of silt for years, he said

10 Indians in CHT not freed after serving jail terms

At least 10 Indian nationals are languising in Rangamati and Khagrachhari jails for years after completion of their prison terms.

They can not return home due to lack of clearance from their government, according to sources in the jails.

The Home Ministry, acting on reports by the jail authorities, wrote months ago to the Indian High Commission in Bangladesh to take steps in this regard, but to no effect, the sources said yesterday.

Khagrachhari jail and four in Ranagamati jail.

Debu Das, now 26, completed four years' prison term in October 2003 in Khagrachhari jail. He was caught and punished for illegal entry into Bangladesh and possessing

Rangamati jail authorities said they are facing problems in maintaining them as the jail is already overcrowded. This is also a menta torture on them, the officials said.

Sakhawat told police during interrogation that he read up to class three. Police said he was involved in underworld activities since 1990 and responsible mainly for supplying arms, ammunition and bombs to party cadres assigned to hit a target.
