Govt mulls imposing LC margin again

In a bid to tackle the ongoing dollar crisis, the government is considering imposing LC margin again, Fund (IMF) condition.

The prevailing dollar crisis has made the government mull over imposing the LC margin, Finance Minister M Saifur Rahman told reporters after a meeting with Bangladesh Bank (BB) and the nationalised commercial banks

(NCB) yesterday. Saifur explained that BB used to tackle such situation imposing LC margin but due to the IMF condition for Poverty Reduction Growth Facilities (PRGF) programme the government was forced to withdraw the LC margin.

At the meeting the minister asked the NCB managing directors to be cautious about opening LCs

letters of credit) and not to open Cs for luxury items.

The BB and NCB officials informed the minister about the exchange rate situation, the current state of export-import trade and Bangladesh Foreign Exchange Dealers Association's (Bafeda) initiative to keep the greenback market stable

Earlier, Bafeda at a meeting on Tuesday attempted to fix the dollar price but failed due to the objection from some foreign and private banks. They are going to sit again soon to decide about the matter.

Bafeda took the initiative following an informal directive of the

Yesterday Saifur claimed that the current situation in the foreign exchange market was due to some small banks' reckless banking. They opened LCs for luxurious cars without considering if they would be

able to pay off for their LCs, he

observed Earlier in 2003, while the government introduced floating exchange rate, LC margin on all sorts of imports was withdrawn as a condition for the IMF's PRGF loan.

The dollar crisis deepened since the import volume marked a rise last year and taka began to depreciate against dollar, which in turn also shot up inflation rate.

Import selling rate of dollar rose 5.57 percent to reach Tk 66.39 per unit in July, which was Tk 62.89 in January. And in the inter-bank market the rate marked a 5.77 percent rise to reach Tk 64.95 in July from Tk 61.40 in January.

However, in exports and remittances the average buying rate of dollar was raised by 6.34 percent between January and July this year. The rate was Tk 61.43 in January. which rose to Tk 65.32 in July.

Fake medicine factory found

Mobile courts yesterday found a false medicine factory and collected Tk 1,06,000 in fines from food producers and traders and for selling products without expiry dates in the capital

The government recently formed the mobile courts to control the adulteration of foods following a series of reports in The Daily Star. The mobile courts have recently extended their jurisdiction over other malpractices.

A mobile court led by magistrate ABM Abdul Fattha raided seven foods producing factories, hotels and restaurants in the Kuril, Banani and Gulshan areas, and collected Tk 1,06,000 in fines.

The court fined Tk 25,000 to Bangla-German Foods Limited, Tk 12,000 to Shalinar Garden, Tk 10,000 to Shasly Fast Food, Tk 4,000 to Shadharan Khabar Ghar, Tk 10,000 to Amantran Restaurant Tk 25.000 to Sonali Hotel and Tk 20.000 to Café Jam Jam.

Lost memory, lost hope at DMCH

Fearing it will not receive payment, the Dhaka Medical College and Hospital (DMCH) often turns away unidentified patients brought to the hospital in an unconscious state. Many critically injured victims of

road accidents brought to DMCH are often shifted from ward to ward, without proper treatment. Some eventually die This reporter found a patient who

had been left in a corridor for five days without any treatment. He was ultimately driven away from the hospital, as no one came to identify him and pay the expenses for his Sometimes, however, if the bills

are small, relatives of other patients money for such unidentified

The Social Welfare Department of the DMCH also often provides

these patients with financial help and treatment. But it is not always possible to spend a large amount for one patient. Instead, the department is more often inclined to help a larger number of patients with small amounts for each, department officials said

Patients lying without treatment or turned away are an everyday scene at the DMCH, where most patients are poor and where the 1.700-beds are often filled.

Kodbanu, a 45-year-old woman with gangrene in her legs, a broken hand and fever, was left by unknown persons outside the emergency gate, where she remained for the whole day. She was then admitted to ward No. 19 (medicine ward). Later, the ward boys sent her to ward No. 9 (surgery).

After several more rounds of shifting from ward to ward, the hapless woman was left at the Emergency Department, spending the whole night without any care or

treatment. The next day, she was seen at the emergency gate for some time but later could not be Others have suffered a similar

fate. Two policemen and two commuters brought a woman of around 28 from Postogola under Shyampur Police Station on the night of July 30, admitting her to the neurosurgery ward with severe head injuries caused in a road accident. The unconscious patient was kept in the corridor without any treatment for four days.

Monsur Hossain, an attendant informed that a 55-year-old woman was admitted on Friday. She was left lying on a bed for four days, a saline apparatus hanging over her as if she was under treatment, he said. The woman died last Tuesday.

Assam on high alert after string of blasts

4 killed; oil, gas pipelines blown up

India's northeastern state of Assam went on maximum security alert yesterday after rebels triggered a string of blasts that killed four people and wrecked oil and gas pipeline, power lines and rail tracks, police

There were about a dozen attacks in the state at the weekend. a government spokesman said. Police believe they were carried

out by the outlawed United Liberation Front of Asom (Ulfa), the most dominant of more than two dozen rebel groups that have been fighting secessionist battles in the region for decades.
