Rebellion sees change in alliance nomination

PM picks Zafar, drops AL-deserter Siraj without parliamentary board meeting

BNP Chairperson Khaleda Zia yesterday in a dramatic move picked Shah Mohammad Abu Zafar as the ruling alliance candidate to contest Faridpur-1 parliamentary by-election, cancelling the nomina-

tion of Kazi Sirajul Islam. The decision came after the BNP high command's repeated bid to remove the severe rift in the district BNP failed as Zafar was determined

to contest the by-polls as an independent contender resigning from the party, sources said.

Zafar, the rebel candidate who was denied nomination by the BNP Parliamentary Board, was to announce his resignation from the party at a press conference in Dhaka yesterday afternoon. But the BNP high-ups prevented him from holding the conference

Baufal newsmen flee in fright

BNP cadres, OC join hands to gag protests

Most of the Baufal journalists have fled the upazila facing alleged threats from both the local BNP activists and the police to put a gag on protests against Tuesday's tortures on a trainee correspondent of the daily Jugantor.

After beating Jugantor correspondent Monjur Morshed black and blue, local BNP lawmaker Shahidul Alam Talukdar left Baufal for Dhaka Tuesday evening. Party cadres loyal to him then launched a

show of force, taking out antinewsmen processions and threatening their family members until late in the night, sources said.

The BNP men also looked high and low for Monjur, also a lecturer of Management at Engineer Faruk Talukdar Women's College, reportedly to force him to sign a statement denying his abduction and tortures.

They told Monjur's family that if he refuses to obey MP Shahidul, chairman of the college's governing body, he will lose the lectureship.

Cops raid office to nab Lahmeyer chief

The police yesterday raided the offices of Lahmeyer International Palli Power Services Ltd (LIPPS) to arrest its chief and his accomplices for sabotaging the Mymensingh 140megawatt (MW) Rural Power Company Ltd (RPCL) and committing subversive acts.

The government issued arrest warrants against LIPPS chief AZ Rezaul Haq, also known as Captain Reza, and more than seven of his accomplices, including Zahirul Islam, the chief of Sky Engineers which is also a venture of Captain

Urea in biscuits!

It is not only textile dye and burnt Mobil oil that bakery product producers use to adulterate their products. Urea fertiliser is also used in biscuits and bread to make them whitish and crispier for a longer time, it was revealed when the mobile court vesterday recovered urea fertiliser from two bakeries in old Dhaka.

A mobile court yesterday raided two bread and biscuit producing factories in the Lalbagh area and found a huge amount of urea fertiliser used in the bread and biscuits. The court first raided Titas Bread and Biscuit factory in Rajnarayan road in Lalbagh and found a pile of urea fertiliser, which they claimed contains ammonia.

The workers of the bakery told the court that they use the fertiliser to make the biscuits and bread crispy and whitish

The court later raided the factory of Master Food on the same road and found similar chemicals used in their products.

"I was just shocked to see the urea used in the bakery products. I had no idea that the situation is really so bad," said Md. Rokanuddoullah, the magistrate of the court.

The court issued warrants against the owners of both factories, Hazi Abdur Rahman and Humayun Kabir. The court also asked the office in charge of the Lalbagh Police Station to file cases against them under the Special Power Act-1974.

The court destroyed all the ureamixed biscuits, breads and cakes, and also asked the police to shut down the factories

PRO-BNP LAWYERS' CONFLICT

Huda's showdown with party cadres
