Severe power outage is badly affecting the country's tea production this year, industry sources said.

It is causing production loss to gardens and affecting quality of the sensitive crop, which may tell upon export of the major foreign exchange earner, they said.

Out of total 160 tea gardens in the country, 140 are in Sylhet region, which produce the major portion of quality tea. Most of the gardens are in Moulvibazar and Habiganj dis-

The Habiganj Palli Bidyut Samity and the Moulvibazar Palli Bidyut Samity supply power to tea gardens

On an average, power outage in the gardens continues five to six hours a day, and up to 10 hours at

The condition in gardens under hours a day. This involved a huge Habiganj Palli Bidyut Samity is worse as supply is interrupted twice or thrice a day.

Processing tea leaves in factories is seriously affected due to repeated power outage. Low voltage is another problem, which damages machinery, garden owners said while talking to this correspondent on Tuesday.

After plucking, processing of tea leaves involves withering, cutting, fermenting, drying and sorting to make it ready for packing and export. Accurate timing has to be maintained at each stage.

In 1997, a decision was taken at ministry level to supply additional 10 MW power to tea gardens. But it is yet to be implemented.

On the other hand, the Rural Electrification Board (REB) in 2000 cancelled setting up of a 10 Megawatt power plant at private initiative for tea gardens after selection of site at Shaistaganj in Habiganj district.

They did it on the ground that such a plant at Shaistaganbj would not be commercially viable, sources

Besides, a plan for setting up two 35 MW plants in Moulvibazar and Habiganj, taken up in 2002 by the government in 2002, is gathering

200 MT foodgrains for Bandarban projects 'stolen', probe says

Bandarban Municipality Chairman Mizanur Rahman Biplob has been suspended for corruption, misuse of government resources and neglect

A letter from the Ministry of Local Government and Rural Development (LGRD) to this effect, issued on July 28, reached the municipal office recently, official sources said yesterday. The action was taken as allegations against him were proved, they

The official letter said that a probe body investigated the charges and found that the allegations were based

Earlier, the Chittagong Hill Tracts (CHT) Affairs Ministry, after investigation, sent a letter to the LGRD ministry recommending action against him for the irregularity.

When contacted, Mizanur Rahman Biplob claimed that the action against him was politically motivated and that he would go to

The CHT Affairs Ministry, following allegations by Bandarban municipal commissioners, had ordered the probe. During investigation, it found that the municipal chairman misappropriated 200 tonnes of food grains allotted for development works.

The CHT ministry in a letter (No 1/03/2002/501(3) issued on May 6 this year also asked him to refund Tk 23 lakh, equivalent to the price of the misappropriated food grains. But he neither refunded the money not replied to the letter, the sources said.

The Local Government Division had also issued a showcause notice

on the Municipal chairman. The suspension order was issued as he did not reply to the showcause notice, the sources said.

They said the food grains were allotted against 48 development projects in the municipal area.

Investigation by a team led by a Joint Secretary level official detected that the projects were not implemented and the food grains were misappropriated, the sources said. Mizanur Rahman Biplob was

elected chairman of Banadarban municipality last year with Awami League support. Bandarban district Awami League

(AL) earlier sent a proposal to the party high command for action against Biplob for his alleged involvement in corrupt practices, AL sources

3 to die for killing in Satkhira

Three killers were sentenced to death in Satkhira while four rapists got life term rigorous imprisonment

Our Satkhira Correspondent reports: The Additional District and Sessions Judge's Court No 3 here on Monday condemned three persons to death for killing a Union Parishad (UP) member.

The convicts are Alhaj Nesaruddin Gazi, son of Ferazatullah Aksed Ali, son of Yar Ali and Kuran Gazi, son of Pachu Gazi of Baikari village in Sadar upazila. Of them Kuran Gazi is absconding.

Union Parishad member Abu Salek, son of Azihar Rahman of Baikari village in Sadar upazila was chopped to death by Nesaruddin, Aksed and Kuran Gazi on August 23, 1994.

Our Netrakona Correspondent reports: The District and Sessions Judge Court and Women and Children Repression Special Tribunal here sentenced four persons to life term RI for raping a minor

The convicts are Babul Mia, Abul Hashem, Abdus Sattar and Haresin Netrakona Sadar upazila.

Each of them was fined Tk 1.000. in default, to suffer three months

The four abducted a minor girl named Farida Akter, daughter of Ahimuddin at the same village on May 28 night in 1999. They took her to different places and raped her. After four months, the victim managed to flee and came back home.

The Tk 17.27 crore Patuakhali town protection embankment project has become uncertain due to alleged bureaucratic tangles. The project is awaiting approval for eight years

The project includes construction of 4.20 KM flood control embankment. eight sluice gates for drainage of water, 38 outlets, construction of one kilometre wall and installation of four power pumps

The project was designed to protect the town from flash flood and erosion and remove stagnant water. The project was taken up after the visit of the then agriculture minister

Majid-ul-Haque and Water Development Board (WDB) secretary to Patuakhali in 1997.

The water resources ministry okayed the project in 2001 but it is awaiting

approval by the ECNEC (Executive Committee of National Economic Council), WDB sources here said.

Most of the town is inundated even after a shower or a normal rise in water level of Patuakhali and Lohalia rivers during high tide.

The most vulnerable areas in the town are Puran Bazar, Katpatti, Nabab Para, Shimulbagh, Muslimpara, Adalatpara, College Road area, Sabujbagh Kalikapur and Jainkali, where boats ply alongside rickshaws during after high tide or rain, causing sufferings to about 50,000 people in these areas. The town is surrounded by Patuakhali river on the north and Lohalia river

on the east. Waters from the rivers surge into the town whenever they rise. "I cook (food) during low tide and feed my children and husband during

high tide", housewife Putul of Nabab Para joked while taking to this corre-

She said their house including the kitchen is inundated during high ties.

Fake magistrate caught while running fake mobile court

Town protection project okayed in 2001 gathering dust

Police arrested a fake magistrate and four others for running a so-called mobile court against sale of adulterated food and realising money from traders in Bhuapur in Tangail district.

According to Tangail police, five persons went to Bhuapur police station in a microbus on Monday at around 11:00 am

One of them introduced himself as a 'magistrate' and four others personified officials of Bangladesh Paribesh Sangrakhkhan and Manobadhikar Foundation.

They asked Bhuapur thana officer-in-charge (OC) to provide police for a 'mobile court' to launch a drive against sale of adulterated food and polythene in different markets in the upazila

The OC asked one ASI and three constables to accompany them

The so-called mobile court first went to Nikrail and Gobindashic markets and 'arrested' some traders for selling adulterated food and polythene bags but released them after realising Tk 16,800 as 'fine'.

Later, they went to Folda Bazar, did the same thing and realised Tk

The policemen with them became suspicious and informed the OC. The OC asked his men to arrest and bring them to the thana.

Brought to the thana, the cheats confessed to the wrongdoing.

Being informed, Tangail Police Superintendent Mirza Abdullah-hel-Baki rushed to Bhuapur thana and arrested the five.

He also closed Bhuapur thana

The cheats are Mohammad Shahjahan, 40, of Sariatpur district, Kazi Mohammad Solaiman, 50, o Comilla, Farid Uddin, 40, of Barisal, Abdul Awal, 30 and Mahmud Alam, 28, of Dhaka and Dulal, 30, of Munshiganj district.

The cheats admitted to police that they did the mischief earlier Dhaka, Tangail and Mymensingh and took money from traders.

Police also seized fake letters of some police officials including an AIG from their possession.

A case was filed under Speedy Trial Act with Bhuapur police station.

Belal was severely injured in bomb attack at Khulna Press Club on February 5 and succumbed to his injuries on February 11 while he was under treatment at the Combined Military Hospital (CMH) in Dhaka.
