'One baby in every 500 may develop cancer in Bangladesh'

One baby in every five hundred may develop cancer in the country, said a leading child cancer specialist at a press conference at the National Press Club in the city yesterday.

Prof M A Mannan of Bangabandhu Sheikh Muiib Medical University and Hospital said, "It's a good news that when we treat children with cancer, 54 per-

After the killing the law enforcers staged a drama of "crossfire" and tried to brand Masum as a notorious criminal, he added.

Mentioning a dispute with Igbal Hossain Likhon, chairman of Nilkomol union of Charfashion upazila in Bhola, he said Likhon might have a hand behind the murder.

"The accused are constantly threatening over telephone to kill me and my younger son if I file a murder case." Khaer said.

Speaking on the occasion. 120 structures demolished on bank of river Turag

The Bangladesh Inland Water Transport Authority (BIWTA) yesterday demolished 120 illegal structures including three pucca and 13 semipucca houses and 104 thatches on the bank of the river Turag.

During the drive led by Magistrate Mofidur Rahman in Shinnirtek, Horirampur and Jhohurabad areas in Mirpur, the eviction team didn't face any resistance from the grabbers, BIWTA officials said

Some 100 police personnel were deployed during the eviction drive yesterday.

Demolition of about 400 identified illegal structures that include semi-pucca houses and shops on the banks of the Buriganga and Turag rivers will be completed with today's drive, BIWTA sources said.
