Forged notes flood Tangail

Bank installs checking machine

Large scale circulation of forged 500 and 100 taka notes in Tangail district has created panic among the people and worried bankers as well.

Such notes are detected in large numbers in banks every day.

Often, quarrel takes place in urban and rural areas as people decline to accept 500 and 100 taka notes, fearing those could be

Sources in different banks said they get 4 to 5 forged 500 and 100 taka notes in a bundle of the currencies brought to banks for deposit every day. This is a great problem, they said.

The Manager of Sonali Bank's Tantagil district Sadar branch said 18 forged 500 taka notes were identified from bundles brought by

depositors on August 28

Identification machines have been installed at Sonali Bank's head office branch Zila Sadar branch to check forged notes. These notes are now being transacted at the two branches after checking with machines, he said.

Some bank officials said it is impossible for people to identify forged notes. "We feel embarrassed when forged notes are found in bundles (0f notes) given by VIP depositors in the counter", an official said seeking anonymity. Checking with machines also slows transaction, he added.

According to police sources, some organised gangs are involved in circulating forged notes through

They said they are trying to nab the main culprits behind the crime.

A four-day second high-level border conference between Bangladesh Rifles (BDR) and Border Security Force (BSF) of India will be held in Shiliguri town in India from September 6 to 9.

Deputy Director General (DDG) of BDR Brig Gen SM Golam Rabbani will lead a 9-member delegation while Inspector Generals (IGs) of North Bengal and South Bengal frontiers of BSF SR Tewari RK Panchanda will jointly lead a 13member Indian delegation at the

BDR is expected to raise the issues of killing of Bangladeshis by BSF troops, frequent intrusion into Bangladesh by BSF troops and

Indians, abduction of Bangladeshis, push-in, illegal erection of barbedwire fences, building of roads, bridges and other defence installations within 150 yards from demarcation lines, obstructions by BSF to renovation river banks, revetments, roads, mosques, bridges, Eidgah

Smuggling of Indian phensidyl, drugs, narcotics substances, arms, ammunition, explosives and other items, unauthorised stay of Indian trucks inside Bangladesh at land customs ports, setting up of boundary pillars along 35.5-km demarcated borders in Panchagarh, trafficking of women and children, frequent violation of Bangladeshi airspace by Indian fighter jets and other issues may come up for dis-

The BSF side is expected to raise issues like alleged border crimes, illegal infiltration of

Bangladeshis, smuggling and 'distortion of facts in news published in Bangladesh media.

Both sides are expected to raise the security issue along the common borders, the sources said.

BNP-Jamaat differences widen in Satkhira

A faction vows to 'resist' Jamaat MP in next polls

Rift in Satkhira BNP has widened further. The two rival factions separately observed the 27th founding anniversary of the party on Thursday.

Due to long standing internal feud in the Satkhira BNP, the two factions brought out separate processions and held rallies in the town marking the day. The separate programmes, held

by blocking roads in the town, created traffic jams from 3 pm to 7 pm on mostb of the thoroughfares in the town.

The rift in ruling BNP has also widened the differences between local leaders of BNP and its partner Jamaat-e-Islami. The difference became apparent when leaders of a BNP faction criticised Jamaat lawmaker Abdul Khaleg (elected from constituency) at a rally for what he called ignoring and undermining BNP leaders and activists. At the rally, the BNP leaders announced the name of Alipur Union Parishad Chairmna Abdur Rouf as their

candidate next general election from the Sadar thana constituency.

The BNP faction led by Satkhira district BNP General Secretary Ramatullah Palash brought a procession and held a rally at Shahid Alauddin square, blocking the Satkhira -Kaligoni road.

At the rally it was announced that BNP men will resist Jamaat leader Abdul Khaleque in the next parliamentary polls.

"We will not support the Jamaat candidate as four party alliance candidate for Satkhira Sadar constituency in the next general election", he said. Other speakers urged BNP leaders and activists to remain cautious about those who are "dividing the party" and to fight against all conspiracies.

The faction led by district BNP president Habibul Islam Habib MP held a rally in front of district BNP office, also blocking the Satkhira-Kaligonj road for about three hours.

The speakers criticised the other faction alleging that they were weakening BNP by doing anti party activities.

More areas flooded in Sirajganj: 3 drown

More 58 unions in nine upazilas in Sirajganj district have been flooded due to onrush of waters from the upstream and rains in the last three days.

Three persons drowned in floodwaters. The victims are Halima Khatun, 35, of Rawja village in Chowhali, Basu Deb, 56, of Khasrajbari in Kazipur and Tukku Mia,

28, of Azugopra in Belkuchi upazila. Over three lakh people have been marooned. The worst affected upazilas are Kazipur, Belkuchi, Sirajganj Sadar, Shahjadpur and Chowhali. In Shahjadpur, the old court area and a hospital have gone under

knee-deep water, official sources said. Thirteen unions in Kazipur upazila. seven unions in Sadar upazila, two in Kamarkanda, eight in Belkuchi, 10 in Chowhali, six in Raiganj, six in

Shahjadpur, two in Ullapara and four unions in Tarash upazila have been

Standing transplanted aman (Taman) paddy and jute on 25,000 acres of land have gone under water, according to sources in the Department of

Agriculture Extension (DAE) here,. Most of the flood victims have taken shelter on high land and flood control embankments. They are passing their days in misery as they are yet to receive relief from the government or any non-governmental organisations.
