### Beaten by rivals for joining party

Three persons including a Union Parishad chairman, who joined BNP on September 1, were seriously injured when attacked by a group of BNP leaders and activists for joining

The attackers had been opposing joining of the three persons to BNP, party sources said.

The injured are Sheikh Miraj Ali, chairman of Dargapur Union Parishad, Ganesh Chandra Banerjee and Kartik Chndra Mondal, all of Assassuni upazila. They were admitted to Satkhira hospital in a critical condition, hospital sources

Quoting local people police said, the three were attacked by miscre-ants led by local BNP leader Tariqul Hasan in front of Dargapur Madrasha when they were returning home from Baka Bazar in a motorcycle. They hit them with lethal weapons.

Local BNP leader Tariqui Hasan had contested the last UP election and lost to Sheikh Mirai Ali. an Awami League leader. Being defeated, Hasan and his men harassed Miraj Ali on several occasions

Miraj Ali joined BNP, apparently to take revenge, party men said. Tariqul Hasan opposed his joining but failed.

# Diarrhoea spreads in flood-hit Sirajganj

Diarrhoea and pneumonia are spreading in the nine flood affected upazilas of Siraigani district as water has started receding.

Two children died of diarrhoea and another from pneumonia in the last two days. About 200 people have been attacked with the diseases.

The dead were identified as Rahuli Khatun, 4, of Chowhali; Badsha, 2, of Kazipur and Hasna Khatun, 7, of Shahzadpur.

Of those afflicted with the diseases, 20 are in Sadar upazilla, 25 in Chowhali, 25 in Kazipur, 20 in Raiganj, 20 in Shahzadpur, 25 in Belkuchi, 30 in Tarash, 15 Kamar Kanda and 20 in Ullapara upazila. They have been admitted to different hospitals and health complexes.

Diarrhoea is spreading due to lack

areas, they said. Besides, saline and other medicines used to cure intestinal diseases are in short supply in the hospitals

Water Development Board (WDB) sources here said the water level of Jamuna marked slight fall yesterday. They hoped it will recede fast as there is no rain in the area and n the upstream.

Over 1.5 lakh people are still marooned in shoals of the Jamuna, Karotoa and Fhulzhar rivers.

Four boys drowned in the district in the current spate of flooding, the third in the season.

The worst affected areas are Meghai, Shuvogacha, Gandhail, Kuralia and Shimanto Bazar in Kazipur upazila; Rantankandi, Shimla, Khokshabari, Songacha, Bahuli and Ranigram in Sadar upazila; Bhuiganti, Nalka and Dhangara in Raigang upazila; Naogaon, Kachikata, Magura

Bindopur in Challan Beel area in Tarash upazila; Shalanga, Salop, Sreekhola, Mahonpur in Ullapara upazila; Baghabari, Talgachi, Chobila in Shahjadpur upazila; Zoknala, Tamai, Randhunibari, Shahbajpur, Chala in Belkuchi upazila; Betil, Enayetpur, Ghorjan in Chauhali upazila. Areas of Sirajganj, Shahzadpur, Kazipur, Belkuchi and Ullapara pourashava have also reeled under water.

At least 2000 weaving factories have been shut due to the flood. According to district relief and rehaoilitation office, at least 8000 houses have been damaged fully or partially by the flood that inundated Aman seedlings on 7,921 hectares of land.

# Land grabbing makes the poor landless

Political clout, muscle power, fake deeds are the weapons, survey report reveals

The number of landless people in Jamuna shoals in four upazilas of Gaibandha district is increasing as local influentials grab lands of poor peasants by using political clout and muscle power. This was revealed in a survey

conducted by a local NGO. The influentials, by resorting to 'fake deeds and tricks' have driven many poor peasants from their native shoals over the

years. They are now destitute. The NGO -- Samaj Kallan Sangstha (SKS)-- recently conducted a survey on 300 people who have taken shelter on the Brahmaputra flood cControl

embankment along the western bank of Jamuna in Shaghata and Fulchari upazilas. About 25 per cent of them were dispossessed of their lands by local influents, 45 percent became landless due to erosion by the river. The rest 30 became landless due to fragmentation of holdings, the survey

As per law landowners who become landless due to erosion should own newly emerged lands in the river in his area. But once lands emerge, local influentials grab the lands by any means, the survey said.

Fulchari upazila comprised seven unions earlier. Of those, Fazlupur, Arendabari and

Fulchari Sadar unions and a major part of Gajaria union were devoured by the river over the years. But when lands emerged in the river, those were grabbed by local influentials, making the original landowners landless About 80,000 in the areas are now fighting land grabbers, the

survey said. The land grabber first prepare fake deeds in connivance with a section of dishonest land administration employees and then capture newly emerged lands of poor and marginal farmers with the help of muscle power. Poor landowners can not go to court for legal help and ultimately turn

This correspondent also talked to some of the victims in remote Khanchapara shoal in Fulcharii union who were allegedly evicted from their lands by musclemen of influentials.

"I inherited one and a half

bigha land from my father in Char Pepulia. It disappeared into the river. But when the land emerged some influential people grabbed it", said Abdul Kader. He now stays in Khanchapara flood

Abdur Razzak said he possessed two bighas of land in Cha Pepulia few years back. He also became landless in the same

It is difficult to take back the grabbed lands from the influentials, said Rasel Ahmed Liton, an official of the NGO.

We are trying to create awareness among the people to fight grabbers, he added.

According to sources in the area. Nila, daughter of Mahiuddin of Chuadanga were married to Palash nine years ago. They had an affair.

Recently the couple rented a house and were living there. Bithi, sister-in-law of Nila, told this correspondent that she talked to her Monday noon. Everything appeared "At midnight (1am Tuesday),

Palsha phoned me to tell that Nila killed herself by hanging from a ceiling fan", she told this correspondent when contacted over cell phone But Nila's elder brother Nehal

Uddin said, "We found a scar on her

Being informed, a police team from the Sadar thana went to the spot and sent the body to Jhenidah Sadar Hospital.

A medical board yesterday performed autopsy of the body. The report will be available at least afte three days, the officer-in-charge (OC) of Sadar police station told this correspondent over cell phone.

When contacted. Jhenidah Police Superintendent Akram Hosain said he will go for action immediately if the postmortem report says it is a murder.

Nehal Uddin has filed a General Dairy (GD) with Sadar police.

Crime rate has remarkably declined in Brahmanabaria after the district administration started weekly crime review meetings last month and beefed by patrol and vigilance by law enforcers

No incident of dacoity, piracy, toll collecting, snatching, clash and abduction was reported in the district in the later half of August, official sources told this correspondent yesterday. In the previous 15 days, two incidents of abduction, two incidents of toll collection and snatching, four rapes, eight incidents of dacoity and piracy and some incidents of theft were recorded in the district.

The first weekly crime review meeting was held on August 14. When contacted, Police Superintendent ATM Tareque said in order to curb crimes, law enforcers held at least 14 meetings with locals in different areas

of the district during August. Police, joined by special teams patrol crime prone areas in the district and keep an eye on 'doubtful persons',

he said. In addition, mobile courts led by magistrates make regular visits to different areas, checking crimes and food adulteration, according to sources in the Additional District
