Kakrail Mosque was used to train Aug 17 bombers

JMB cadre says in confessional statement





The capital's Kakrail Mosque, widely regarded as the fulcrum of Tablig Jamaat, had been used to train the militants how to switch on the bombs that rocked the country on August 17, an arrested militant told a Dhaka court yesterday.

In a confessional statement before the Chief Metropolitan Magistrate's Court, Dhaka, JMB cadre Faisal Ahmed said he and three other Jama'atul Mujahideen Bangladesh (JMB) operatives, who were assigned to detonate a bomb at Rajarbagh Police Lines, stayed at the mosque for four days leading up to the serial blasts and took training necessary to operate a time bomb.

Faisal, who was arrested in Tangail on September 18, also said that JMB leader Uzzal had taken him and fellow JMB members Jahid and Habib to the Kakrail Mosque. Tablig Jamaat is a religious move-

'No' to Tuesday Group's meet on poll practices

The government has declined to permit Tuesday Group, a club of foreign diplomats in Bangladesh, to arrange a conference on 'the best election practices', saying that such move will amount to interference in the internal affairs of the country.

The message was conveyed to the Group when Canadian High Commissioner in Dhaka David Sproule and Norwegian Ambassador to Bangladesh Aud Lise Norheim called on Foreign Affairs Adviser Reaz Rahman yesterday afternoon.

The Tuesday Group comprises

the ambassadors and high commissioners accredited to Bangladesh from Australia, Canada, Denmark, France, Germany, Italy, Japan, the Netherlands, Norway, South Korea, Sweden, Switzerland, the UK, US, European Commission, and the

The grouping has been planning to hold a seminar in Dhaka sometime in November this year on "International Electoral Best Practices". They claimed that they would hold the conference to provide Bangladesh with necessary technical assistance to make sure

PRIVATISATION OF RUPALI BANK

WB may defer credit as no move to vacate stay

The complications arising out of the privatisation of Rupali Bank may further defer the World Bank's (WB) Development Support Credit (DSC)

The finance ministry and WB sources said although the government import tariff, the legal complications over the privatisation of Rupali Bank have turned out to be an obstacle to Bangladesh's getting the DSC loan.

The International Monetary Fund (IMF) too expressed dissatisfaction over the issue and questioned the government's sincerity in initiating moves to vacate the High Court's stay order over the privatisation process of Rupali


Bank, sources said. The privatisation of Rupali Bank has been a condition tagged by both the IMF and WB for releasing the Poverty Reduction Growth Facility and DSC loans.

The Privatisation Commission advertised Expression of Interest for selling 67 percent shares of Rupali Bank to private entrepreneurs on May 21 this year. But when a shareholder of the bank filed a writ petition on July 17 to stall the privatisation process, the High Court (HC) stayed the process until

Following the HC stay order the Privatisation Commission halted all procedures of selling the shares of Rupali Bank.

An IMF mission while visiting Bangladesh early this month to review the latest economic state of the country raised the issue of privatisation of Rupali Bank in its meeting with the finance ministry, Bangladesh Bank and the Privatisation Commission. Officials of the WB's Bangladesh chapter were also present in those meetings.

President Iajuddin Ahmed yesterday said corruption, inefficiency, governance problems and weak-nesses in institutional management are pushing up the cost of doing business in the country and hindering improvement of the standard of living of the people.

"Because of these reasons, we are not getting expected results in poverty alleviation despite allout efforts ... We need to conduct a baseline survey to identify the weaknesses, and continuously try to

come out of this situation,'

The president was speaking as chief guest at the launching cere-mony of Dhaka Chamber of Commerce and Industry's (DCCI) Vision -- 2021 for a Prosperous Bangladesh' at Bangladesh-China Friendship Conference Centre in the
