Mufti talks of more backing

Says several ministers promised to save him from case for attempting to kill Hasina

Mufti Abdul Hannan yesterday told a court that the law enforcers were not supposed to arrest him as some influential ministers of the government had assured him that he would be exempted from the charge of attempting to kill Sheikh Hasina.

"Soon after the coalition had assumed power, I submitted a mercy petition to the prime minister, home minister and some other ministers and in reply they assured me that they will let me off the hook," Hannan told the court in presence of a large number of lawyers, law enforcers, and newsmen.

He said the cases filed against him including the one for an attempt to assassinate Hasina are politically motivated. They had been filed with

Hannan, arrested on Saturday in the capital's Maddhya Badda, also told the court that he is a supporter of the four-

Clad in a lungi and a bullet-proof vest. Hannan was placed before the Chief Metropolitan Magistrate's Court, Dhaka at about 5:30pm amid tight security. Tejgaon police successfully netitioned the court for him to be taken on a 10-day remand.

He said, "When the Rab men arrested me I was told that I have been arrested in Kotalipara cases, but I was shown arrested in one of the August 17

2 die in Satkhira bomb attack

Bomb exploded in B'baria, leaflets found

Unidentified criminals carried out bomb attacks vesterday in Satkhira and Brahmanbaria that left two people

Two people were killed and three others critically wounded when some criminals threw five bombs on a fish depot at Daliva market in Tala upazila in Satkhira district, reports our corre-

Robin Mandol, 50, son of Haripada Mandol of Tikarampur upazila, died on the spot while Jaigir Sarder, 40, succumbed to his injuries on way to Satkhira Sadar Hospital.

The injured are Noor Mohammad

Sheikh, 50, Jahangir Sarder, 40, and Nuru Sarder, 50. All of them live in Tikarampur village

Sources said a gang threw the bombs one after another at about 7:30pm when people were gossiping at the Nur Mohammad fish depot.

Meanwhile, a bomb was exploded in front of the government mother care clinic in Brahmanbaria at 8:20pm.

Police recovered four batteries and leaflets that warned of further bomb attacks if hotels and restaurants were not kept shut during the Ramadan.

In Kishoreganj, police recovered two abandoned bombs near a house at the Mirzapur village.

BDR chief's comment makes Hasina worried

Leader of the Opposition and Awami League (AL) President Sheikh Hasina expressed her deep concern over defence and security of the country following Bangladesh Rifles (BDR) Director General Maj Gen Jahangii Alam Chowdhry's comments.

"Has the government made Bangladesh a subservient state of India or sold the country to India? Indians can intrude into Bangladesh, carry out bomb blasts across the country and get a safe passage back?' she posed the questions.

"The independence and sovereignty of the country is now at stake, she said while talking to newsmen at Zia International Airport returning from India after a five-day visit.

PHULBARI OPEN PIT COAL MINE

Asia Energy submits report on \$2b project

Gets environmental clearance

Asia Energy Corporation vesterday submitted to the government its feasibility study along with a plan to develop a \$2 billion open-pit coal mine at Phulbari in Dinajpur from next year.

Development of this mine would require the company to relocate 40,000 people of 9,000 households in the mining area in different phases over a 30-year lifespan of the mine. The

company will compensate the affected

At the same time, the 6,500 hectaremine is expected to stimulate economic activities, particularly in transport sector, railway, land and sea ports and infrastructure building in the western and northern Bangladesh. The mine will directly create 10,000 jobs.

Indian press twisted BDR DG's comment
