### Top IOJ leader killed in Ctg

Family suspects Jamaat link

Unidentified criminals on Saturday night brutally murdered a top Islami Oikva Iote (IOJ-Amini) leader Igbal Bin Yakub in Chittagong

Police recovered the body of the 32-year-old Chittagong unit IOJ convenor from the KB Abdur Sattar Road side, adjacent to the Goods Hill residence of Salauddin Quader Chowdhury, parliamentary affairs advisor to the prime minister, at around 11:45pm

Criminals bludgeoned the head of Iqbal, also the vice president of the Chittagong Shop Owners Federation. with heavy weapons before strangling him. Bruises were found on his head, inches SEE PAGE 15 COL 1

after the meeting held at the Jatiya Sangsad Bhaban.

The committee members observed the AFD is the continuation of the system that existed in the presidential form of government.

"The Armed Forces Division is the egacy of the system that existed during the martial law period after August 15, 1975. It has some flaws in its functioning," committee member and AL lawmaker Shawkat Ali told The
