# Diarrhoea spreading fast in Nilphamari

### 12 killed, 5000 attacked: Crisis of saline, drinking water

The diarrhoea situation deteriorated in Nilphamari as it claimed 7 more lives on Tuesday, raising the toll to 12. At least 5000 people have been attacked as the disease is spreading

alarmingly to fresh areas. Though a seasonal phenomenon, its intensity is greater this year as a fallout of late floods that caused crisis of drinking water and aggravated the

monga, officials said. Supply of oral saline is also not adequate in the affected areas

In Ding Ding Para village, 10 miles from the town, at least 200 out of about 1000 people are attacked with diarrhoea. It is hard to find a family without at least one diarrhoea patient, sources said. All members of a family being attacked with the disease is also not uncommon. On Tuesday. some villagers snatched IV saline injections from medical teams there for their sick relatives.

Deputy Commissioner Rabindra Nath Roy Chowdhury, Civil Surgeon In-Charge Dr Abdul Majid and Sadar UNO ATM Masuduzzaman visited Ding Ding village on Tuesday and assured the villagers of all possible

The Deputy Commissioner held a special meeting on Sunday with all Upazila Health and Family Planning Officers and officials of Public Health Department to find ways to combat diarrhoea. In the meeting, two ADC's were given emergency duty for monitoring the situation round the clock. A Rapid Response Team has been formed at the district headquarter to rush to any area on information.

Besides 72 medical teams now working in the district, one Emergency Team has been formed in each upazila to monitor the situation and take immediate steps, officials at the district control room said.

The Deputy Commissioner has allotted 45 tonnes of rice for worst affected areas because the disease is caused mainly due to shortage of food and pure drinking water. As poor people have no work now, they try to survive on uneatable things, which cause diarrhoea

The 12 victims are Parveen, 3 of Jhechu Para village, Abia, 6 and Rabeya, 8, of Dangapara village in Sadar upazila; Zabeda, 40, Jobeda, 55, Rozina, 25 and her five-day old son of Panger Motukpur village in Domar and monga affected Nilphamari

upazila; Abdul Majid Kalu, 40, of Guapara in Kishoreganj upazila and Chobidul, 35 of the same upazila: Abdul Mamud, 45 of Balapara cluster village in Jaldhaka upazila and Rekha, 4, of the same upazila and Fatema

Begum of Pochar Hat village in Dimla

The district control room however confirmed only two deaths from diarrhoea. Sources there said at least 2300 people took treatment at government hospitals and field treatment centres in four days till Tuesday. A total of 203 people went to hospitals only on Tuesday.

Unofficial sources however said the number of patients would be much more as many people in remote areas do not have any means to go to hospitals. They take treatment at

At some government hospitals, some patients alleged that the authorities released them though they were not fully cured.

Awami League lawmaker from Nilphamari Sadar constituency Asaduzzaman Noor at a press conference here on Sunday demanded of the government to declare diarrhoea district as a 'distress area'.

He said people are being attacked with diarrhoea after eating uneatable things as they have no food and work.

The situation is more serious than what the district officials say, he said. The district health department does not give an accurate picture of the situation. They give a low death toll only to save the image of the government, he alleged. He urged the Prime Minister to visit the affected areas.

Civil-Surgeon In-Charge Dr Abdul Majid, when contacted, told this correspondent on Tuesday that 72 medical teams were working in the affected areas across the district. Two temporary diarrhoea treatment centres have been setup in Gorgram and Chanderhat village in Sadar

He said UNICEF officials had inquired about the situation and requirement of IV saline and other medicine. He said there is a stock of 6,383 bags of 500 cc IV saline and 1,238 bags of 1,000 cc IV saline with the district health department. More 2000 bags of IV saline reached Nilphamari on Monday. He said the situation is still under control.

ATTACK ON KHULNA MAYOR

### Charge sheet submitted naming lone outlaw

Chargesheet of the case for grenade attack on Khulna city Mayor Shaikh Tayebur Rahman filed with Khulna thana under the Explosive Substances Act was submitted to the CMM court yesterday by investigating officer SI Shafiqul Alam.

Mashikul Islam Yoy, an alleged cadre of M-L faction of outlawed Purbo Banglar Communist Party (PBCP) has been named as the lone accused in the charge

Four other accused belonging to the same underground organisation and named in the FIR died last year in 'crossfire' at different times. They are Abdur Rashid alias Tapu, Jashim, Khalil and Raja Chowdhury.

Two FIR-named accused--Sajol and Shohag--have been exempted from the charge as their involvement could not be proved during investigation, sources said.

Khulna city Mayor came under a grenade attack at noon on February 29 last vear while he was on way to his residence after attending a seminar held at a club at KD Ghosh Road, organised by Islamic Welfare Centre

He survived the attack as the grenade did not explode.

The chargesheeted accused, Joy, was arrested in Dhaka in June last year.

He wrote a letter sent by post to OC of Khulna thana threatening to blow up the thana building for killing his associates Iashim and Khalil. The letter was received by the OC in May last year.

According to sources in Khulna district police, PBCP Janajuddha faction decided to include names of Amar Desh Journalists on the hit list for writing against its armed cadres based in Matomdanga area under Khanjahan Ali thana of Khulna city.

The hit-list was disclosed during interrogation of Janajuddho cadre arrested by DB of KMP in connection with the murder of BNP leader Manjir Ahmed

Khulna Bureau office of Dainik Amar Desh made published exclusive stories on PBCP operatives.

Of course, neither Khulna Bureau chief Kazi Motahar Rahman Babu nor staff correspondent Atiar Parvez has so far received any threat from the outlawed party. When contacted, they said they got the information from police source.

## Another 48 likely to get 'controversial' appointments at RU

The Rajshahi University authorities have completed the process for  $recruitment \, of \, 48 \, more \, teachers \, and \,$ officials, allegedly on political considerations.

Their appointment may be given after the Eid-ul-Fitr, sources said.

Eight persons will be appointed to the posts of section officer and 40 to become teachers in 12 depart-

The teachers to be recruited are two for the Mass Communication department, three for Zoology, two for Sociology, four for Political Science, three for Islamic History and Culture, two for Information and Communications Technology and seven for Fine Arts department.

A Syndicate meeting will be held on November 15 to confirm the

appointments, the sources said. Talking to this correspondent, a

pro-Awami League member of the RU Syndicate alleged that most of the appointments will be on political considerations. Meanwhile, allegations have it

that lobbying is going on for appointment of relatives of teachers loyal to Bangladesh Nationalist Party (BNP) and Jamaat-e-Islami Bangladesh. The fresh appointments are

being done while the 'controversial' appointments of 546 people are yet to be regularised.

The controversially appointed people now held demonstrations on the campus several times for regula $risation \, of \, their \, appointments. \, They \,$ also laid a siege to the Vicechancellor's office and announced that they would not allow any fresh

recruitment until their jobs are regularised.

They also formed a committee to press their demand. Its convenor Rafigul Islam Sadar yesterday told a group of newsmen that they would mount agitation if the authorities go for fresh appointments before confirmation of their jobs.

On the other hand, the Progressive Teachers Association (PTA) at RU has decided to protest 'irregularities in appointments'. It may launch a movement if the university authorities go for more appointments on political considerations, sources in the PTA told this correspondent.

When contacted Registrar Prof Abdus Salam said the fresh appointments are being made as per needs of the departments.
