#### HC asks cops not to torture ETV chairman's assistants

#### BDNEWS, Dhaka

The High Court yesterday directed the government and police not to torture Ziaur Rahman Zia and Faizul Karim, two assistants of Ekushev Television (ETV) Chairman Abdus Salam, during their remand.

After hearing two writ petitions filed by Ashraful Alam, brother of Abdus Salam, challenging the validity of their remand, the vacation bench of Justice SK Sinha also directed the chief metropolitan magistrate of Dhaka not to extend the remand period.

On November 5, Ramna police arrested Ziaur Rahman Zia and Faizul Karim under Section 54 of Criminal Procedure Code (CrPC). They were taken on a five-day remand the next day.

In the writ petitions, Ashraful Alam submitted that police have been inhumanly torturing Zia and Karim during the remand.

Dr M Zahir assisted by Barrister Taniib-ul Alam and Barrister Sarah Hossain moved the petition while Deputy Attorney General Karunamoy Chakma appeared for the government.

BSS, Dhaka Prime Minister Khaleda Zia yesterday directed the Bangladesh Export Processing Zone Authority (BEPZA) to fill up all the vacant posts under its jurisdiction soon.

She gave the directive while presiding over the 23rd meeting of BEPZA Board of Governors at the newly built BEPZA Complex at Dhanmondi in the

Earlier, she inaugurated the sixstorey BEPZA Complex constructed at a cost of about Tk 10 crore on 13.5 'kathas' of land at Dhanmondi in the city.

BEPZA Executive Chairman Brig Gen (Retd) M Zakir Hossain said more than 400 recruitments would be made following the Prime Minister's directive. Zakir was briefing the journalists after the meeting.

The Prime Minister said the BEPZA's proposal for creation of new posts would be sent to the ministries for establishment and finance for examination to take final actions in this regard.

The board meeting approved nine agendas, including the proposal for offering 20 percent cash incentive to attract investments in agro-based industries in the EPZs in Ishurdi, Mongla and Uttara (Natore).

The PM, who is also chairperson of EPZ labour tribunal, formation of EPZ the BEPZA, asked the authorities to labour appeal tribunal, and their ensure use of local items as raw materiorganogram and financial expenses.

### **DU teacher commits** suicide

A Dhaka University (DU) professor allegedly committed suicide yesterday, hanging himself from a ceiling fan at his residence

A security guard of the teachers' quarter found Prof Quazi Salamatullah of the Institute of Nutrition and Food Science hanging from the ceiling fan of his university residence when he went to call the teacher at about 8:00am.

Salamatullah in a suicide note on his departmental pad wrote, "I am leaving this world on my own." However, the second line of the note

SONIA SWAPNA MURDER One to die, 3 others get life **COURT CORRESPONDENT** 

A Dhaka court vesterday sentenced a vouth to death and three of his friends to life in jail for burning Sonia Swapna to death in Manikganj in November last year.

The convict with death is Aidhanath alias Adithva Chandra Sarker while Ranaul Haq Tutul, Hazrat Mollah and Jilon were given life in jail.

Judge Shahed Noor Uddin of the Speedy Trial Tribunal-1 handed down the sentence in presence of the convicts

The court fined Adithya Tk one lakh while the rest three were fined Tk 75,000 each, in default, three to suffer two years' more in jail.

A group of miscreants led by Adithya poured kerosene on Shahjadi Sonia Swapna, 21, a first year student of Nurul Haq Law College in Manikganj while she was sleeping at their house at about 10:15pm on November 22 last year

After fighting with life for eight days, Sonia breathed her last at Dhaka Medical College Hospital (DMCH) on November 30.

The victim gave a dying declaration to a magistrate disclosing the names of the culprits. They killed her following a feud over previous enmity with one Tutul, she said in the declaration.

Later, a murder case was filed under the Women and Children Repression Prevention Act against Adithya and three others

Victim's father Giuas Uddin, former upazila chairman of Manikganj Sadar, was present at the court during the delivery of the verdict and expressed his satisfaction over the judgement.

Special Public Prosecutor Abdul Latif Talukder appeared for the state while advocates Abdul Aziz, Abdul Mannan and Alauddin defended the accused

**Fugitive JCD** robber arrested **STAFF CORRESPONDENT** Detectives arrested a former Jatiyatabadi Chhatra Dal (JCD) leader, also a convict in a robbery case in Motijheel, from Jhenidah town in the early hours of vesterday. Acting on a tip-off, a team of Detective Branch (DB) of police arrested Ruhul Amin, former assistant genera secretary of JCD Dhaka College unit, with the help of Jhenidah police at 1:00am. Ruhul Amin was sentenced to jail for five years for robbing Tk 12 lakh from an employee of Uma Jewellers on June 19, 2005. Ruhul Amin along with two others --Golam Ohab Liton and Azizul Hakim -abducted Abul Kashem, employee of Uma Jewellers, on his way to Janata Bank at Purana Paltan. As the three were fleeing on a private car, Kashem cried for help when the car stuck in a jam at Nightangle crossing. The local people and police caught the two but Ruhul Amin managed to flee. DB police raided Ruhul Amin's room at Dhaka College and recovered Tk 10.04,900. A Dhaka court sentenced Ruhul Amin in jail for five years and two others for four years. Ruhul had been evading arrest since the incident. JCD sources said Ruhul Amin was expelled from the college committee a year ago for extortion and mugging.

In the letter, Prof Salamatullah requested his relatives to lay him at the Azimpur Graveyard. "Do not bother any of my relatives, friends, colleagues, domestic help or driver," it also said. Police recovered the body and the

suicide note but could not find any reasons behind the suicide immediately. Some police officials, however, said the professor might have committed suicide over family affairs.

The body of Salamatullah was sent to Dhaka Medical College and Hospital morgue for autopsy where the doctors found nothing unusual. Prof Salamatullah hailed from Natna under Ashashuni upazila of

Satkhira district and used to live in the flat alone. DU Vice Chancellor Prof SMA Faiz, Pro-VC Prof AFM Yusuf Haider, Proctor

AK Firoz Ahmed, Dhaka University Teachers' Association President Prof AAMS Arefin Siddique and its General Secretary Prof Mohammad Akhtaruzzaman visited the residence. Prof Siddique and Prof

Aktharuzzaman expressed deep condolence over the death of Prof Salamatullah.

The university authorities filed an unnatural death case with the Ramna police.

The namaz-e-janaza of Prof Salamatullah was held at the DU central mosque after Asr prayers and his dead body was buried at the Azimpur Graveyard at 10:00pm.
