Those who occupy the positions by virtue of their parties in power should also realise this. Previously, the Chairmen of a Hill District Council enjoyed the status of a Deputy Minister. The government withdrew the facility in

This correspondent also talked to Ching Keu Roaza, former chairman of Rangamati Hill District Council and Jotindra Lal Tripura of Khagrachari Hill District Council. They also demanded immediate election to the district councils so that they can regain their osition and pride

Stripping of the status of a deputy minister has annoyed the incumbent chairmen of the hill district councils.

Ma Mya Ching, Chairman of Bandarban Hill District Council, said this has further degraded the status of the council. She said she along with the chairmen of two other district councils held a meeting with the prime Minister and urged her to strengthen the councils by giving them more power. But she declined to make any comment when asked whether she demands election to

The election is not held due to controversy over voter list. The law Ministry says that as per provisions of the District Council Act, election should be held on the basis of a "separate voter list" based on local communities. The ministry also sent letters to the Election Commission (EC) to this effect in August

But the EC says that election rules, formulated in line with the Constitution, does not permit preparation of "separate voter lists" for any particular geographical area or people

The EC found the Law Ministry's suggestion "inconsistent" with constitutional provisions which provide for "a single voter list for any region irrespective of religion, race, caste of its citizens", the sources said.

Moreover, the local Bangalee communities oppose a separate voter list,

The councils were first introduced for a three-year term through a direct election, held on June 25, 1989. Since cils are run by government selected

bodies. The tenure of 1989 councils was extended thrice and they continued for

Subsequently, the councils were formed with people selected by the parties in power, which gave more importance to politics than develop-

Now, the bodies are also losing accountability as their chairmen can change their members, often done through lobbying with high-ups in the government.

Talking to this correspondent, a good number of local elite in the three hill towns also said these "arbitrary things" must stop for improvement of government's relations with people of the three hill districts.

They said running of the councils with selected bodies also violates provisions of the landmark CHT Peace Agreement signed in 1997 during Awami League rule.

Terming the Chittagong Hill Tracts Regional Council as a great achievement towards establishing sustainable peace and development in the hills, they said even the Awami League government violated the provisions by not holding

As per the peace agreement, the Chairmen and members of CHT Regional Council will be elected by the chairman and members of the three hill district councils. The Regional Council comprises a chairman and 21 members.

If the present situation is not changed and co-ordination geared up, peace in the area will be disturbed and people will be deprived more, they said.

Talking to this correspondent some local lawyers said continuation of the Chittagong Hill Tracts Regulation 1900 promulgated during the British rule alongside the Chittagong Hill Tracts Local Government Council Act of 1989 also creates problems in administration in the hill districts. The CHT Regulation 1900 does not provide for any elected local government.

Besides, the Municipality Ordinance 1977, Upazila Parishad Rule 1998 and Local Government (Union Parishad) Ordinance 1983 are also in force, which only complicates things, they said.

Such divergent provisions only create misunderstanding between the Chittagong Hill Tracts (CHT) Affairs Ministry and other ministries and among the local bodies, which hamper implementation of government steps in political, social and administrative fields in the area, they said.

UN team begins 15-day CHT tour today

A joint team comprising specialists from UN agencies and government of Bangladesh today begins a 15-day visit to the Chittagong Hill Tracts to assess economic potentialities of the region.

An official programme detailing the team's work plan has been sent to the local administrations and departments concerned, sources in the Chittagong Hill Tracts Development Facility (CHTDF) said here yesterday. The CHTDF is promotional project assisted by the UNDP (United Nations Development Programme).

The team will be led by ILO Specialist Hans Christian Haan. It will include ILO's Youth Employment and Marketing Specialist Pushpa Mathema, FAO's Agro-processing Specialist Narin Tongshiri, Tourism Specialist Ramesh Chandra of World Trade Organization (WTO), five specialists from World Food Programme (WFP) and three others from International Centre for Mountain Development (ICIMOD).

From the home side, the team will included former FBCCI president Abdul Awal Mintu; private sector resource person Mohammed Mamunur Rashid: Imran Shaukat of JOBS, an NGO and Erika Hoffman-

The team will examine growth prospects in different sectors, their needs and problems and assistance needed from donors and the government, the sources said.

The team, meantime, talked to Deputy Minister for CHT Affairs Moniswapon Dewan in Dhaka on November 9 and high officials of other ministries and government department concerned.

During the visit, they will exchange views with political leaders, officials, law enforcers, trade bodies, NGO officials and grassroots level people.

In Rangamati, the team will meet CHT Regional Council Chairman Jiotirindra Bodhipriya alias Santu Larma, CHT Development Board Chairman and lawmaker Abdul Wadood Bhuiyan, Chakma Circle Chief Devashish Roy, Hill District Council Chairman (HDC) Maniklal Dewan and Deputy Commissioner Gazi Md.

After concluding the visit, the team will hod a workshop in Dhaka to present its report.

'Punish killers of Papiya'

Rallies held, human chains formed in Barisal

Different socio-cultural, political and non-government organisations brought out processions in the city, formed two human chains in front of the Aswani Kumar Hall and held rallies there on Thursday demanding punishment to the killers of Dilruba Hug Papiya, a human rights activist.

The organisations also formed a Dabi Parishad to implement various agitation programmes for arrest and trial of the killers.

The rally was addressed by representatives of the different organisa-

They demanded immediate arrest of Papiya's husband hambub Morshed Tuhin, the alleged killer; and an impartial investigation into the incident.

They also demanded that Papiya's daughter Saptarshi be taken away from Tuhin's family and kept in a safe shelter, saying she could be the lone witness to the murder.

Earlier on the day, another human

chain was formed and a protest rally held at the same venue jointly by Bangladesh Legal Aid Services Trust (BLAST), Mahila Parishad and National Women Lawyers

They also brought out a procession in the city roads, followed by handover of memoranda to the Deputy Commission and the Police Superintended demanding proper investigation into the incident and arrest of the killers.

Papiya's elder sister Mahbuba Huq Kumkum in a case alleged that

she was killed by her husband. Papiya had started living with their mother in Dhaka as Tuhin often tortured her, she alleged.

Papiya was killed at Tuhin's Barisal city house on November 3 and the body was buried without autopsy.

Barisal police on Tuesday exhumed the body from a graveyard in the city and sent to hospital morgue for autopsy. The autopsy was done at Barisal Sher-e-Bangla Medical College Hospital morgue on the same day but the report is not yet available. Police said it will be available in two weeks.

Witnesses present at the grave said the exhumed body bore injurt marks on the face, eyes and neck.

Papiya's sister-in-law was also arrested on Tuesday.

SUNDARBAN TEXTILE MILLS

Opposition leaders protest anomaly in recruitment

Leaders of some opposition political parties at a rally yesterday threatened to call a hartal in Satkhira district on Sunday if action is not taken against the officials of Sundarbans Textile Mills who allegedly swindled 400 unemployed youths in the

name of giving jobs in the mill. They also demanded suspension of the on-going appointment process to announce a fresh date for selection so that the swindled youths can get the jobs they

were promised. Sources said that a section of the mill officials took Tk 10,000 to 15,000 from the youths, promising them to provide with jobs in different departments.

The rally, held at the mill gate with Satkhira district Jatiya Party Convenor Abdur Rahim in the chair, was addressed by, among others, Satkhira Pourasava

Chairman Sheikh Ashraful Haque, district Awami League General Secretary Md. Nazrul Islam, Workers Party Secretary Mustafa Lutfullah, JSD General Secretary Obaidus Sultan Bablu, Ashrafuzzaman Ashu, A. Ahmed, Sheikh Abu Nasim, SM Shawkat Hossain, Sudhangsu Sekhar Sarkar, Pourasava commissioners Shafiq Uddowla Sagar, Anis Khan Chowdhury Bakul and Marzina Khatun. Some labour leaders of the mill were also present. They alleged that a section of local

leaders of ruling parties were involved in thescam.

The mill authorities are going to appoint 400 labourers and their selection was scheduled for November 12. Some sources claimed that the selection date has been shifted in view of allegation, but could not say what date has been fixed.
