Outdoor ad business in mighty hands

An influential quarter very close to the top command of the ruling BNP has established a veritable monopoly in outdoor ad business in the capital in the name of its beautification.

For the last three years Advance AD and its unofficial partner Arkay Group have been in control of the most lucrative advertisement spots in the city, especially those owned by the government and Dhaka City Corporation (DCC), business

Some of the sources said the prime minister's sons are also the real, behind-the-scenes, owners of Arkay Group. The twin firms, according to them, have been enjoying every support from the DCC and other government authorities concerned in rearing and running the monopoly.

The sources said, driving other entrepreneurs and firms out of the $business, Advance\,AD\,alone\,has\,been$ pocketing the lion's share, over Tk

100 crore a year, of the roughly 150crore annual outdoor ad market of the city. Arkay has not been doing any worse either. Together, the pair bags around 80 percent of the capital's total outdoor ad revenue.

Of some 300 ad firms in the city, a number of decades-old ones have been forced to wound up their ventures in this area by the sudden and rapid rise of hegemony of Advance AD and Arkay, some SEE PAGE 15 COL 4

Hajj agencies agree Judge Killing to new fare, but plane crisis looms

The Haii Agencies Association of Bangladesh (Haab) has finally accepted the latest government offer

of \$1050 as hajj flight fare per pilgrim. The executive committee of Haab took this decision at a meeting yesterday afternoon.

The representative body of 363 hajj agencies, Haab was agitating for fixing the fare for 56,000 non-ballotee hajj pilgrims at par with 2,600 ballotee pilgrims at \$950 each.

The national flag carrier Biman Bangladesh Airlines which is in a bad shape with its dwindling fleet had

already expressed its inability to fly more than 18,000 hajj pilgrims (2,600 ballotee and 15,400 non-ballotee).

This left the overwhelming majority of indenting pilgrims in a state of uncertainty about performing hajj in January next year due to nonavailability of flights.

Representatives of foreign airlines including Saudi Arabian Airlines, Oatar Airways and Kuwait Airways, who had earlier agreed to fly pilgrims from Bangladesh at \$1150 per passenger, are now declining to carry them at the revised fare rate of \$1050 as decided by Biman's management SEE PAGE 15 COL 7
