Two brothers to die, 10 get life

A Dhaka court vesterday sentenced two brothers to death and ten others, including three brothers, to life in jail for killing Delwar Hossain, General Secretary of Keranigani Shop Owners $and \, Co-operative \, Society \, in \, July, 2001.$

The convicts with death are Mamun Shath and Omar Shath while three brothers Hanif Shath, Ali Shath and Aslam Shath and Selim, Jahangir, Babul alias Heroin Babul, Moktar, Abdul Mannan, Akmal and Anwar were given life in iail

Of them, Jahangir, Omar, Akmal and Anwar were present in the court during the delivery of the verdict while the rest were tried in absentia.

The punishment of the fugitives will be effective from the day of their arrest or surrender and the convicts with death can appeal to the High Court against the judgement within ven days from receipt of the judgement copy, the judge said.

Judge Mohammad Shamsul Haque of the Seventh Additional District and Sessions Judge's Court handed down the sentence at a packed courtroom.

Earlier, the prosecution and the defence completed their arguments and the court recorded statements of 15 prosecution witnesses.

According to the prosecution, Delwar, 35, was killed by a group of miscreants led by Mamun at about 7.45 pm on July 27, 2001 while he (Delwar) along with his friends was discussing about business. The victim was killed following a feud over previous enmity. Moreover, the victim protested the accused's extortion from the shops of Alam Shopping Plaza and other business institutions.

Thousands of people from Keranigani gathered on the court premises and chanted slogans demanding capital punishment to the

Victim's elder brother Abdur Rashid expressed his satisfaction over

Meanwhile, additional police forces were deployed on the court premises to avoid any untoward

Speakers at a memorial meeting yesterday paid tribute to MA Samad, a pioneer in insurance industry and patron of the arts, culture and literature, saving that he was a man o progressive outlook and amiable

Samad was the founder-managing director and chairman of Bangladesh General Insurance Company (BGIC), the first private insurance company in the country. He passed away on October 18 at the age of 82.

MA Samad Memorial Meeting Parishad organised the meeting at the Dhaka Ladies' Club, with National Professor Kabir Chowdhury in the chair. Singer Tapan Mahmud moderated the programme

Samad was known for his wit, liveliness and outspokenness, said Prof Kabir Chowdhury.

He had the ability to make people feel friendly within a very short time, said Mahfuz Anam, editor of The Daily

Born in Sylhet on January 1, 1923, MA Samad graduated from the Presidency College in Kolkata. He also worked in All India Radio in New Delhi as a Bengali newscaster.

MA Samad, who was the managing director of Jiban Bima Corporation, is considered as the pioneer in insurance education and training in the country.

Founder of the Bangladesh Insurance Academy, he authored a book titled 'Life Insurance Selling in Action and Successful Agency Building'.

His name is inscribed on the list of insurance experts of the United Nation's Conference on Trade and Development (UNCTAD).

Prof Serajul Islam Chowdhury, Language Movement veteran Mahbubul Alam Chowdhury, Dr Manjusree Chowdhury, Ramendu Majumder, Favez Ahmed and wife of MA Samad and President of Dhaka Ladies' Club Fowzia Samad and son Towhid Samad were also present at the memorial meeting.

Jatiya Adivasi Parishad, an organisation of plain land indigenous people, yesterday demanded return of the land grabbed from the indigenous people, taking legal actions against torture and deprivation done to them.

They also asked the government to arrange five percent quota for them in higher education and service, and primary education in their mother

At a press conference arranged by the Jatiya Adivasi Parishad at the Jatiya Press Club auditorium yesterday, its leaders also demanded that the government form a separate ministry for the plain land indigenous people and arrange 10 seats for their representatives in parliament.

Referring to the incidents of killings and rape, they said in independent Bangladesh, the indigenous people are undergoing torture and deprivation more severe than during the Pakistan

It also decided that a team of the Board led by its chairman will visit some district towns and divisional headquarters to assess the existing situation prevailing in the newspaper

RUBEL MURDER CASE

Hearing on appeal begins in High Court

Hearing on the appeal of Rubel murder case began in the High Court yesterday.

A division bench of the High Court omprising Justice Hassan Ameen and ustice Ataur Rahman Khan heard part of the submission of the counsels of the

Shamim Reza Rubel, a student of the Independent University, was killed in the custody of Detective Branch (DB) of police on July 23, 1998. The following day, on July 24, 1998, Abdur Rob Miah, father of Rubel, filed a murder case with Ramna police station against 14 accused, including, Assistant Commissioner (AC) Akram Hossain and Roksana Begum alias Mukuli Begum, a neighbour of Rubel.

The Metropolitan Sessions Judge Dhaka, on June 17, 2002, delivered judgement with life-term rigorous imprisonment to 13 convicts, including AC Akram, and one year to Mukul The 13 convicts who were awarded
