# Shantu places 6-pt demand to solve CHT problems

Full implementation of Chittagong Hill Tracts (CHT) peace accord is not possible without a secular and democratic government in the country, said Jyotirindra Bodhipriya Larma alias Shantu Larma, president of Parbatya Chattagram Jana Sanghati Samity (PCJSS).

He was speaking at a press conference at the National Press Club in the city yesterday to mark the eighth anniversary of CHT peace

accord signed on December 2, 1997. It was organised by the PCJSS to press the demand for full implementation of the CHT peace accord.

At the press conference, Shantu Larma placed a six-point charter of demand to solve the problems pre-

vailing in the hill region. These included holding of national and local elections following separate voter lists of the permanent inhabitants in the hill region, immediate withdrawal of temporary army camps and suspension of 'Operation Uttaran' conducted by the armed forces, activation of Chittagong Hill Tracts Land Commission and rehabilitation of all ethnic refugees.

He said, "Awami League government signed the accord but could not implement it fully. The present coalition government is working against the accord."

"Islamist militants have set up hideouts in the hill region. They have close links with their counterparts in Myanmar. These separatist militants have been providing training to Bangladeshi militants posing serious threat to the country," said Shantu Larma, a former guerrilla leader

He said different vested quarters are now engaged in various activities in a bid to deprive the hill people of their rights.

These are intrusion of Bangali settlers in the hill region, encroachment of Adivasi lands, attempt to increase the number of Bangali settlers to soar vote banks, creation of division between the Bangali and Hilly people, and encroachment of lands for setting up of military camps, he added.

Shantu Larma alleged that Sama Adhikar Andolon, an organisation of the settlers. and United People's Democratic Front (UPDF), a terrorist outfit, have been carrying out antitreaty activities with the assistance of the Armed Forces.

Jana Sanghati Samity General Secretary Laxmi Prasad Chakma,

Information and Publicity Secretary Mangal Kumar Chakma, Adivasi Forum leader Juhinal Khasia, Andrew Solemor, and Hill Women's Federation President Choitali Tripura were present at the press conference.

"You are still alive? You have no more time to live. Fat now whatever you would like to eat as your last food. Television will broadcast your death news soon," Musa Sadik quoted an unknown caller as saying

Sadik also informed the Gulshan Police of the latest threat.

### BSF alert at outposts after blasts

Concerned over Tuesday's suicide bomb attacks in Bangladesh. Border Security Force (BSF) has alerted all the 181 outposts along the 856 km-long porous border in Tripura, Mizoram and Cachar district of Assam.

"We have also strengthened our guards on the border, intensified patrol and are keeping a close vigil along the international border so that no one can sneak into our territory for sabotage," BSF IG SK Dutta, who is in-charge of Tripura, Mizoram and Cachar, told reporters in Agartala yesterday.

The BSF and its Bangladesh counterpart Bangladesh Rifles (BDR) have been conducting coordinated patrolling along the Tripura, Mizoram and Cachar borders for the last four months, he said.

"The BSF will now launch coordinated operations on the border along with other security agencies,"

"Now we will share our intelligence inputs with officer-in-charge of any police station near the border and also with other security agencies and then simultaneously launch operations which would be an effective step towards making the border foolproof," the IG said.
