As elsewhere in the country, Pakistani occupation forces launched a crackdown on innocent people in Moulvibazar on March 27 1971. The occupation forces faced the first resistance on that day in Srirainagar area on Dhaka-Sylhet highway about three kilometres away from Moulvibazar town.

Thousands of people with bamboo sticks blocked the highway to resist Pakistani army. When they were proceeding towards Srirainagar, a convoy of occupation troops came and opened fire on them, killing two farmers--Tara Miah of Shabandar village and Jomir Miah of Radhanagar village died on the spot. They were the first martyrs

The occupation army entered Moulvibazar town but within a week freedom fighters compelled them to

Later, in April, the occupation army again captured Moulvibazar town and set up a brigade headquarter at the primary training

On December 2, freedom fighters and allied forces attacked the Pakistani army base at Shamsernagar Airport. The occuparetreated towards Moulvibazar

town from Shamsernagar.

The final victory was won on December 8 after a fierce battle at Baratilla in which but 127 allied troops were killed

'Militant' Indian sent to jail

JMB suspect arrested in Barisal

Suspected militant Nawshad alias Akram Ali, 30, an Indian citizen, arrested from a residential hotel in Tangail town, was sent to the district jail on Tuesday

Earlier, Sadar thana pólice produced ram before a magistrate court. Police arrested the Indian citizen from

a hotel in bus stand area on Monday early In Barisal, a JMB suspect hailing from Panchagar was caught in Mehendiganj

Tuesday night and handed over to Barisal police yesterday. Our Tangail Correspondent reports:

Police sources said Akram told them that he was from Kharbali village in Sarbuk thanain Boropeta district of Assam.

He also told police that he was a student of Goalpara Madrasa and also performed the duty of an Imam at

Police said Akram entered Bangladesh illegally without any passport and other documents, reached Tangail on Sunday evening and boarded the hotel on the same night, hiding his real name and address. At the hotel, he registered himself as a resident of Roumary thana in Kurigram district in Bangladesh.

Police also recovered from his oossession some Islamic books and cell phone numbers of some people in Bangladesh.

Police said that during primary interrogation they suspected him to have links with militants and came to Tangail for subversive activities. "But we are yet to know about his real motive for illegally entering the country", a police official said

Tangail Sadar Police Station, told The Daily Star that the arrested Indian citizen is very cunning. "We are verifying his address in Kurigram he gave at the hotel"

He held a close-door meeting with high officials of Tangail district police at the olice Superintendent's office.

Ruling party men chosen for making new voter list

Magura opposition leaders allege

The names of supervisors and enumerators to prepare a new voter list in Magura have been finalised without consultation with opposition political parties, creating resentment among local leaders.

Most of the supervisors are supporters of either ruling BNP or Jamaat-e-Islami, Magura Awami League Secretary Md. Altaf Hossain claimed while talking to this correspondent on Wednesday.

They are teachers of nongovernment colleges and madrasas, chosen for the job on political links, he alleged.

He said officials of Magura District Election Office (DEO) did not consult with local opposition leaders before finalising the lists. "They have selected their men as part of a blue print to rig the election", he said.

The Election Commission (EC) is a constitutional body and it is supposed to work neutrally. "We are not interested to interfere in its activities and if it does anything out of biasness, it would be unfortunate for the nation", he said.

Central Joint Organising Secretary of Jatiyo Party (Ershad) Hasan Seraj Suja said, most of the listed supervisors are nongovernment college teachers. madrasa superintendents, and the enumerators are teachers of government primary schools, all appointed under political influence during the 4-party alliance rule. Neutral performance can not be expected from them, the JP leader

Both the AL and JP leaders said that protest would be lodged after getting reports from grassroots level during preparation of voter list.

When contacted, District Election Officer however said, "We had no option but to follow the criteria set by the EC in preparing lists of officials and workers to make a new voter list.

"We did not consult either opposition or ruling party leaders as we were not directed by the EC to do so", he said.

"It is not possible for us to know who among the appointed supervisors and enumerators are politically biased or not. We are committed to make a correct list of voters", the Election Officer said.

According to sources in Magura DEO, 1475 enumerators, 380 supervisors and 45 Assistant Registration Officers (AROs) have been recruited to prepare the voter

The DEO has recruited government and government primary school teachers as enumerators and upazila level officials, lecturers of non-government colleges, headmasters of government primary schools and madrassa superintendents as supervisors.

Training workshop of field level officials will be held next month. The work on preparation of voter list will begin on January 1.

Victory Fair cancelled in Manikganj
