2 more JMB dens busted

FROM PAGE 1 Rajshahi, a JMB bomber in Naogaon and 12 others in Mymensingh.

One of the IMB dens busted in Mymensingh is at Fulbaria and the other at Aqua in Morolpara. When a Rab team approached the Morolpara lair on RK Mission Road, the inmates put up such a stiff resistance by desperate shooting and blasting some 25 bombs that the crack crimebusting force was forced to retreat and the JMB operatives made a hasty

The Mymensingh haul includes four grenades, 12 bombs of different sizes including a light-sensitive one, a sub-machine carbine, 80 electric detonators, 20kg ammonium nitrate, gun powder, GI wire, lead azide, lead nitrate, electric circuits, batteries, fuses, snail shells and iron balls used in fishing nets. Besides, weighing and soldering machines and over 1,000 books on jihad were also recovered from the hornet's nests. The police and Rab in the town arrested a total of 12 people in this connection,

Rab sources said the Mymensingh operation was undertaken based on some information extracted by interrogators from detained IMB Military Commander Ataur Rahman Sunny now in Rab custody. The Rab took Sunny to Mymensingh at 1:00am yesterday and brought him back to the capital after he had shown the cops the Fulbaria and Morolpara dens.

On the intelligence that some JMB top guns may be residing at two or three JMB dens in Kotwali area of Mymensingh town, a Rab Intelligence Wing team led by Major Javed with the help of Rab-9 carried out the operation, said a Rab press release last night

Ahmed, a retired teacher of Nasirabad Collegiate School. He told the press Shaheed, aged around 35, rented the first floor of the

houseatTk2,000inApril. Rab members formed a cordon around the house and broke into the three-room flat around 2:30am. The tenants left the house on December 14, Khorshed told The Daily Star.

The elite force recovered 56 detonators, gun powder, electric circuits, wires, around 100 batteries, a monitor, a keyboard, different types of CDs, around 1,000 books on jihad and paper clippings on militancy.

A Rab team remained in the house, while other members set off to bust another den on RK Mission Road in Aqua Morolpara

did not notice any strangers visiting the house. The 'brothers' all on a sudden

shaved their faces two month ago. In reply to Kaiyum's question, Asaduzzaman said they did it to avoid harassment by law enforcers.

Khorshed's wife said the tenants were unsocial and unfriendly. "They never visited our house either as tenants or as neighbours," she

The Rab members out for the other JMB den cordoned off the house, Noor Mahal, and knocked on the single-floor tin-shed house around

In response, the tenants hurled a bomb at the raiding force through a window, said a Rab member, who took part in the drive.

"The militants started hurling grenades and bombs at us one after another, some of those blasted with huge bangs, rocking the entire area,"

Mohammad Mahbub, teacher of a nearby madrasa, told The Daily Star he woke up hearing footsteps close to his bedroom. He resides just opposite the house of the busted den.

"I peeped through the window to see what's going on and heard some people saying 'take position', 'we'll shoot you' and 'surrender' sort of

He immediately heard a huge bang and cowered down, Mahbub said, adding, "I found the rest of my family shaking in fear.

"A little later, I heard some gunshots and crawled towards my roadside room to have a look outside."

Major Javed told the press they did not open fire on the militants as the area was over crowded. "It was deep dark in the night and

there were possibilities of crossfire," he said, adding, they shot some fires in the airfor self-defence.

The militants fled from the scene hurling bombs. Some of them might have escaped through the gates in the rear of the house, while some others ran through the main road. The Rab could not chase them because of bombs on the road.

The Rab in the daylight yesterday counted 25 bombs, some of those including a powerful one did not

The Rab found a computer CPU burning on an oven inside the house. The CPU must have had secret information, the lawenforcers suspect.

Two of the three rooms were almost empty, while the third one had all the recovered goods including electric detonators, ammonium nitrate, gun powder, charcoal, batteries, chemicals, improvised fuses, a light sensitive bomb, different dies, time circuit, 10 chainless wrist watches, two weighing machines, an AC/DC metre, wire, electric circuits, blenders, shouldering iron, three knives, one saw, three militant books including one published by Revival of Islamic Heritage, and 50 snail shells.

Rab bomb experts said the bombs recovered from the spots are similar of those blasted in Gazipur and Netrakona.

One of them said the militants could have made a huge quantity of bombs using the seized materials. He said there was a light-sensitive bomb, which goes off when comes to light. LOCALSVERSIONS

Sayeeda Noor, a widow, told reporters Abul Kalam, 25, introduced himself as a small trader, and rented the three-room flat in April.

"I did not want him to rent the flat as he was a bachelor, but he influenced me, saying I could throw him out at his first misbehave," Sayeeda said, adding, he lived with two, sometimes three of his friends,

Humaira, another tenant, said she had no idea who lived in that flat. only learnt about them when Rab woke me up during the fazr prayers and asked me about them."

Police picked up her along with his two sons -- Jeyon and Hamman -around 8:00am.

Tarioul told the Rab he kept the remaining 4,000 detonators with one Rezaul of his village. The Rab team. rushed to Boarmari village and held Rezaul, son of another Ataur Rahman. "Rezaul admitted that Tariqul

asked him to keep the detonators and took the Rab men to Charnichu area. There he dug out a sack that contained 3,978 detonators," the release said.

Rab sources said the arrestees would be handed over to police soon. Meanwhile, Rajshahi

Besides, forcing the government to do or abstain from any act is also included in the category of terrorist acts. Meanwhile, the law ministry

has initiated a process to formulate another law styled Anti-Terrorism Act 2005, some clauses of which will deal with prevention of terrorist financing, said the finance ministry summary.

FARM SUBSIDIES

Trade ministers signed up yesterday to a compromise deal clearing the way to a global trade deal in 2006, agreeing to cut farm trade export subsidies in eight years and provide special breaks for the poorest nations.

A draft statement issued at WTO talks approved a European Union plan for agricultural export subsidies to be scrapped by 2013. The United States and key developing nations had been pushing for 2010.

Anti-poverty campaigners however condemned the draft agreement as a betrayal of the poor, but ministers from the main trading blocs welcomed it as at least a modest step forward.

"We agree to ensure the parallel elimination of all forms of export subsidies and disciplines on all export measures ... by the end of 2013," said the draft, which was to go before a plenary session for approval later Sunday.

EU Trade Commissioner Peter Mandelson said the text was "acceptable" after other countries had accepted the EU compromise on the date.

"We have demanded and received equivalent movement from the other countries. While the outcome of Hong Kong is not a great success, this move of ours is

The United States in turn welcomed the text, saying it had come to Hong Kong to build a solid platform to move forward global trade liberalisation.

Brazilian Foreign Minister Celso Amorim said the Group of 20 major developing countries also accepted the compromise. Anti-poverty campaigners were
