Dhaka's textiles to lose duty-free access

Says Altaf on return from WTO meet

Commerce Minister Altaf Hossain Choudhury made it clear yesterday that the textiles sector, which earns 76 percent foreign exchange for the country, is going to lose the privilege of duty-free and quota-free market access under the latest WTO deal.

He however said Bangladesh's henefit out of the WTO trade agreement reached Sunday would be clear after two follow-up meetings in Geneva and Washington to be held in a few months to decide the products that would lose duty-free sta-

"Few among the textile items could be exempted from the restriction during the meetings," he told the news agency at Zia International Airport, on his return from the World Trade Organisation conference in Hong Kong.

"We're hopeful that the follow-up negotiations would bring some positive results for us," the commerce minister added

The United States and Pakistan had made frantic effort in the early days of the six-day ministerial conference to drop Bangladesh, along with Cambodia, from the privilege of zero-tariff market access, giving a broad indication of the textile fate.

The first draft of the ministerial text had proposed to offer the LDCs (least developed countries) dutyfree and quota-free access for 95 percent of their products.

Eventually, the trade agreement offered LDCs, 32 of them members of the WTO, such benefit for 97

percent products. But it gave the rich countries prerogative to drop 3 nercent of poor nations' products, 339 or more, out of that special treatment.

"This is what we have been able to achieve from the negotiations, Altaf said. LDCs have been able to increase the tariff lines and negotiate to bring out the textiles of Bangladesh and Cambodia from the proposed embargo, he added

Asked why he did not use veto power as he had hinted earlier, even until Sunday afternoon, he said: "It was a burgeoning position.

Replying to another question, the minister said the government would sit together with the private

Meeting sources said the cabinet asked the law ministry to find out if there are overlapping or inconsistencies between the proposed Money Laundering and Terrorist Financing Prevention Law and the Anti-Terrorism Act 2005.

The draft Anti-Terrorism Act 2005 has already been submitted to the home ministry for its opinion, sources said.

The meeting chaired by Prime Minister Khaleda Zia, however, approved the draft law (amended)

As the guards challenged him at about 100 yards inside the Bangladesh territory, the man fled the scene leaving behind the bag.

The BDR then recovered the bag and found five pieces of explosives (power gel), each weighing 125grams, four detonators and nine fuses inside it. The explosive materials were kept hidden under oranges, the official said.

Shibir man admits to be JMB bomber

16 captured; families of Barisal charge-sheeted accused demand judicial probe

Rajshahi police yesterday arrested a bomb manufacturer of the outlawed Jama'atul Mujahideen Bangladesh (JMB), who claimed to be working actively for Islami Chhatra Shibir (ICS) simultaneously. The police also arrested 15 more suspected JMB cadres from across the country.

RAJSHAHI

The police yesterday chased five people and arrested a JMB bomb manufacturer also a suicide squad member Razzak alias Mahbub Ullah Jibon alias Suman alias Masud from Kashiadanga area near the Bornali Cinema intersection in the city, our Rajshahi correspondent reports. The other four including a high-ranking JMB leader managed to escape

Razzak admitted that he is an active member of ICS, Jamaat-e-Islami's student wing, at Meherchandi area, and that he also worked for JMB. Razzak said he was engaged in bomb-making and recently was included in the suicide His neighbours said he had close

relations with local ICS and Jamaat leaders. He was often seen in Jamaat processions and in skirmishes involving the organisation on Rajshahi University campus.

The Police however recorded his father's name as Belayet Hossain based on information from Razzak but his neighbours told reporters that his father's name is Abu Taleb Ali, who is deceased. Razzak's brother Sohrab is also a JMB cadre who was arrested two months ago.

Women held on non-bailable charge get bail

A Dhaka court yesterday granted bail to two women on a non-bailable charge filed under the Narcotics Control Act (NCA), triggering a mixed reaction among the lawyers on the court premises.

Mohammad Mujibur Rahman the First Additional Chief Metropolitan Magistrate granted bail to Saleha Begum and Rina Akhter, arrested for possession of heroin on November 16.

As per provision of the Criminal Procedure Code (CrPC), a lower court cannot grant bail to an accused arrested for a charge triable in the Sessions Courts. This case is triable in the Sessions Courts and punishable by death for possession of heroin.

According to the prosecution, a team of Narcotics Control Department (NCD) raided a house at Krishi Market at Mohammadpur on November 16 and arrested five women and recovered 175 grams of heroin from their possession. Later. a case under the NCA was filed with the Mohammadpur Police Station against them on the same day. A senior lawyer Mohammad


