#### Interrogation reveals

Arrested JMB (Jama'atul Mujahidin Bangladesh) Rajshahi 'divisional commander' Abul Kalam alias Shafiullah alias Tarique was involved with Ahle Hadith Juba Sangha, youth front of Ahle Hadith Andolon, Bangladesh (Ahab), led by Dr Asadullah Al Galib, a teacher of Rajshahi University.

He came in contact with JMB chief Shaikh Abdur Rahman when the later visited Satkhira in 1999, sources in

intelligence agencies said. "Later on, under the directive of Shaikh Abdur Rahman, he lured poor youths from neighbouring villages like Itagachha, Kharibila, Kamal Nagar, Baliadanga to join JMB to take part in Zihad for establishing Islamic rule. He recruited and trained JMB activists", one source said.

JMB chief Shaikh Abdur Rahman often visited Satkhira and took part in ecret meetings, held at mosques and

Abul Kalam alias Shafiullah formed 'Ketal Bahini' in Satkhira under the directive of Shaikh Abdur Rahman in 1999, police said.

Shafiullah was arrested on December 17 from Raishahi.

He was driven out from their Itagachha house in Satkhira town six years ago by his father Abdur Rahman, a retired teacher at Satkhira Primary Teachers Training Institute Abdur Rahman is also chairman of Bakal Ahle Hadith Madrasha, established by Dr. Galib, said an elderly man eking anonymity.

Before taking charge as JMB Raishahi 'divisional commander' Shafiullah was chief of 'Ketal Bahini' in Satkhira district, said intelligence

Talking to this correspondent, some local people in Itagachha, a stronghold of JMB in the town, said, Shafiullah's family members belong to Ahle Hadith sect and are followers of Dr. Galib who hails from Alipur village in Satkhira Sadar upazila.

On contact, Shafiullah's father said, his son's actual name is Abul Kalam. He (Shafiullah) changed his name as Shafiullah alias Tarique after ioining JMB, "I drove him (Shafiullah) out from my house when became involved with JMB. He also demanded punishment to JMB bombers who are

Locals said JMB chief Shaikh Abdur Rahman joined a meeting of its activists held at a mosque at Kharbila in the name Islami Jalsa in July this

A police official said, they have prepared a list of JMB activists in the district and are hunting for them including its suicide squad mem-

## JMB suicide bomber on 10 days' remand

JMB suicide bomber Mamun Ali who killed two judges in Jhalakathi on November 14 was taken on 10 days' remand when he was taken to Jhalakathi yesterday from Dhaka

He was treated at Dhaka Medical College Hospital for injuries he sustained during the bomb attack.

Sohrab Hossain, Investigation Officer of the cases and Officer-in-Charge of Jhalakati Sadar police station prayed for 14 days' remand, court sources in Jhalakathi said when contacted over telephone Jhalakati Sadar Upazila Magistrate Ismail Hossain granted 10 days'

Senior Assistant Judges Shahid Sohel Ahmed, 35, and Jagannath Pandey, 38, were killed, one at the spot and the other on way to Barisal SBMCH in the suicide bomb attack. The judged were inside their

microbus, just before leaving their Chandkati residence in Jhalakati town at about 9 am when two bombs went off, killing them and blowing up

JMB (Jama'atul Mujahideen, Bangladesh) suicide squad Mamun Ali, 23, milk seller Badsha Mia, 45, judge court peon Abdul Mannan 40 and Lokman, 13, a student of class six were injured in that blast.

Mamun Ali was caught by local people and handed over to Rab (Rapid Action Battalion). He is the son of Qamruzzaman, a 4th class employee at Rajshahi University.

## Kushtia daily Editor jailed Crisis deepens as for ignoring court order

The Editor of a local daily in Kushtia was sent to jail yesterday for disobeying an order to appear before

Sakhawat ibn Moyeen Choudhury, Chief Editor of local daily Shikol, faced an extortion case, filed by a freedom fighter. He was arrested as he did not abide by an order to appear before the court, sources said.

According to court sources, one Munshi Nurul Islam, a freedom fighter, filed an extortion case against Sakhawat ibn Moyeen

Choudhury on April 23. The sources claimed that Shakhwat on April 12 demanded Tk 20,000 from Nurul Islam, father of Munshi Tarikul Islam, Kushtia correspondent of ntv and daily Samakal published from Dhaka. The editor also threatened to publish a story in his paper against Nurul Islam that he was a fake freedom fighter.

As the freedom fighter declined

to pay, the Shikol published a report on April 14 that he was a fake freedom. The news item also tried to brand his son journalist Munshi Tarikul Islam as an 'outlaw'.

Next day, the freedom fighter went to the editor and requested him to publish a rejoinder with documents that he was a freedom fighter. The editor demanded Tk 20.000

for publishing a rejoinder and threatened to publish more defamatory news items for non-payment. On April 23, freedom fighter

Munshi Nurul Islam filed a case

against Shikol Editor Sakhawat Ibn Moyeen Choudhury, publisher Hasina Sakhwat and one Shamsul Alam with Magistrate court. The court ordered Sadar thana

police to investigate the matter and submit a report. Police after investigation submit-

ted a report on November 27 accusing the three persons. The curt on December 5 issued arrest warrant against the three

persons and ordered attachment of

their property. The Shikol editor

On Tuesday, when the editor came to court to appear in another case which he filed against three other editors in Kushtia, police arrested him.

Yesterday, the court rejected his bail prayer and sent him to jail.

When contacted in the court compound yesterday, the Shikol editor told local journalists that the "whole thing is a conspiracy to throttle his newspaper".

# fertiliser trade stops in Nawapara

No ferttiliser was traded in Nawapara. the biggest fertiliser wholesale market in the country, in last three days due to the indefinite strike called by Bangladesh Fertiliser Association

Retailers and dealers from different districts including those in the northern part of the country who came with trucks to buy fertiliser from Nawapara wholesale market had to go back empty handed.

Over 300 dealers and wholesales in the market did not sell a single bag of fertiliser in the last three days in response to the strike call given by BAF, sources in the market said.

The BFA enforced the strike to realise fertiliser importers' Tk 300 crore arrears from the government due as

Importers said the government

declared 25 per cent subsidy on imported fertilisers in 2004, which amounts to Tk 600 crore. The agriculture ministry also declared rules and regulations to handle subsidised fertilisers. Till July this year, the government did not pay Tk 100 crore to importers, due as subsidy. The amount rose Tk 300 crore till December, sources in BAF here told this correspondent. Meanwhile, the strike pushed

prices of all types of fertiliser in retail markets in districts in the current peak period of Rabi crop cultivation, reports reaching here said

Urea is selling at between Tk 280 and Tk 300 in rural areas against its government fixed price of Tk 260 per 50 kg bag, farmers said.
