

Diesel price goes up in northern districts

Balashi depot in Gaibandha empty: Barges stranded on rivers

Price of diesel has increased in retail markets in northern districts due to alleged short supply, affecting irrigation of IRRRI-Boro lands.

Diesel is selling at Tk 35-37 a litre against Tk 32-35 a week back, according to retailers and farmers.

Fuel dealers in the region alleged short supply from oil depots at Chilmari in Kurigram, Balashi in Gaibandha and Baghabari in Sirajganj as four barges got stuck on the Brahmaputra and the Jamuna for some days due to less flow of the river.

Officials of Padma, Jamuna and Meghna oil companies at the depots said yesterday supplies to dealers are being maintained through railway tankers.

Our Rangpur Correspondent reports: The Chilmari floating depot of Jamuna Oil in Kurigram has run out of stock as the barge Taposh with four lakh litres of oil is stagnated on the Bhramaputra at Nakalia in Bera upazila in Pabna district, sources at the depot said.

The depot-in-charge, Abdul Majid, when contacted over phone

admitted that there been no supply as the barge is stranded on the Brahmaputra.

But he denied that there was shortage of diesel at dealers' level because all oil companies are maintaining supplies through alternative ways.

Majid said railway oil tankers with seven lak litres of diesel were brought to Rangpur from Chittagong and fuel is being supplied to depots in Chilmari and Balashi Ghat.

He said dealers are manipulating the prices after the news spread that oil-carrying barges were stranded on the Brahmaputra.

The Chilmari floating oil depot supplied fuel to dealers in Kurigram and Lalmonirhat districts.

Our Gaibandha Correspondent reports: Balashi floating oil depot is dry for about one month as no oil barge could reach it due to loss of navigability of the Brahmaputra in the region, its manager Motiur Rahman told this correspondent yesterday.

He said the last supply to dealers from the depot was made on December 22.

Three oil barges are now stranded at Patchkhola and Char Shafuria on the Jamuna river in Pabna for three days. It is uncertain when the barges will float again, he said.

However, manager of a filling station in Gaibandha town -- Kadir and Sonssaid, "We are collecting kerosene and diesel from Bagabari depot since the Balashi floating depot went dry about two months back".

Fuel dealers in Kurigram and Lalmonirhat are also lifting diesel from Baghabari depot now as the Balashi depot is dry, he claimed. This adds to their cost.

There may be crisis if supplies can not be maintained through railway tankers, said Shahajada Anwarul Kadir, President of Rajshahi Divisional Oil Distributors Association.

Our Nilphamari Correspondent reports: Fuel dealers in Nilphamari said about 80 per cent of diesel in the district is supplied from Baghabari oil depot and the rest 20 per cent from Parbatipur oil depot in Dinajpur.

Diesel is supplied by Padma, Meghna and Jamuna oil compa-

nies to Baghebari from Chittagong and Khulna, which is now seriously affected as the flows of Jamuna and Brahmaputra have reduced.

Bappy Bhoomik, a dealer of Meghna and Jamuna oil companies said he got two lorries of diesel from Parbatipur on Wednesday though he wanted three lorries.

He also informed that high officials of Meghna and Jamuna oil companies informed him that due to navigability problem in the river Jamuna, they would bring additional fuel to Parbatipur through rail route.

Our Sirajganj Correspondent reports: An official at Bhaghabari depot when contacted yesterday said fuel supply from the depot will stop 'within a short period' if the barges now stuck up on the river do not reach Bhaghabari ghat.

Officials of Bangladesh Petroleum Corporation (BPC) said they are supplying fuel to northern districts by using railway tankers. Dealers will get fuel from Rajshahi, Parbatipur and Natore if supplies through river routes can not be maintained, they said. But this many not be sufficient, other sources said.

RCCI demands 4-lane highways in N-dists

Concern at death of 3437 in road accidents in country last year

Expressing grave concern at loss of numerous lives in road accidents in northern districts, the Rangpur Chamber of Commerce and Industry (RCCI) yesterday reiterated its demand for implementation of its suggestions put forward three years ago to reduce mishaps.

At least 3,437 people were killed in 2,122 road accidents in the country last year, most of them on highways in northern districts, RCCI President Mostafa Azad Choudhury Babu said at a view exchange meeting with journalists, held at the RCCI auditorium here.

He quoted from the annual report of Human Right Bureau to say that deaths from accidents are increasing every year.

Loss of so many lives in road accidents is only due to government's negligence in checking those and corruption in issuing fake driving licences, he said.

The RCCI president regretted that they put forward suggestions to the communication ministry three years back to control road accidents in northern districts but the government has not taken a any step to implement those.

The proposals include construction of four-lane highways with road dividers, eviction of illegal structures and markets from roadsides, training for drivers at vocational institutes, steps against wreckless driving and punishment for offenders.

The chamber leaders said that most of the road accidents in the

country occur due narrow highways without concrete dividers.

There is no other alternative to building four-lane highways to avoid head-on collusion of vehicles.

Mostafa Azad said, the number of accidents is more in the northern districts as most of the roads and highways there are narrow and have no dividers.

If there is fund constraint, the

government can allow construction of four-lane highways by big Bangladeshi and foreign transport companies on build-operate-transfer basis, he suggested.

The companies would realise their investment from toll collected from vehicles, he said.

RCCI leaders Sha Mohammed Salekh, Shahajahan Babu, and Mostafa Ahmed also spoke at the meeting.

30 fishermen buy freedom

Thirty fishermen abducted by pirates two weeks ago in the Sundarbans were released yesterday on payment of Tk 3 lakh.

The fishermen were held hostage in Puspakati, Kaliachak, Fatiker Dune and Jalghata areas.

They were abducted in deep forest by two gangs of pirates, one led by Motaleb and the other by Sakawat.

Earlier, the pirates failed to realise Tk 15 lakh as ransom from relatives of over 100 wood cutters they abducted from Arangkona, Baluichaki, Chora Meghna, Jalghata and Puspakati areas in the Sundarbans.

The pirates released Daud Dhali, Razzak, Nazrul Mizanur and Jalil of Burigoalini village in Shyamnagar upazila and Shahidul Gazi of Fatepur village in Paikgachha upazila in Khulna asking them to tell the abducted fishermen's relatives to pay ransom, otherwise the pirates threatened to kill them.

The victims informed the matter to local lawmaker Gazi Nazrul Islam and the police authorities.

Journalist Balu murder trial uncertain

The fate of Journalist Humayun Kabir Balu Murder Case has become uncertain due to framing of faulty charge and lack of clue for further investigation.

Inspector of Detective Branch (DB) of police Abdul Hamid who is the Investigation Officer (IO) of the case, framed charges against eight outlaws on June 28 last year.

The trial began at Khulna Speedy Trial Tribunal on October 25 last year. Afterwards, statements of 11 Prosecution Witnesses (PWs) were recorded. But their statements did not confirm punishment of any accused.

This is because of improper investigation and framing of faulty charge, said Public Prosecutor (PP)

Advocate Abu Zafar.

Meanwhile, Tribunal judge Abdus Samad ordered an investigation into the case on January 4 after a prayer made by Public Prosecutor (PP) Advocate Abu Zafar.

When contacted, Investigation Officer (IO) Hamid said, 'I have no clue for further investigation.

The case docket of the murder is also yet to reach the IO from Khulna Speedy Trial Tribunal for further investigation.

Two out of eight charge sheeted accused, Shoib and his younger brother Shumon of Purbo Banglar Communist Party (PBCP-Janajuddho) died in encounters with members of Rapid Action Battalion (Rab) in October and December last year.

4 JMB suspects held in Tangail

Tangail police arrested four JMB (Jama'atul Mujahideen, Bangladesh) suspects from Delduar upazila in the district Tuesday night.

Police said the arrestees are activists of the banned Islamist organisation. They are being quizzed in police custody.

Anti-drug campaign
