Glitch in tender process delaying award of contract

A delay in awarding contract for the construction of Mohara Water Supply Project of Chittagong Water and Sewerage Authority (CWASA) is lingering the plight of about 40 lakh residents of the port city reeling under an acute water crisis.

The government financed Tk 197.96 crore project was taken up since CWASA with its present water producing capacity of 180mld (million litres per day) is not being able to meet the demand for over

500mld of water.

The new plant would ease the water crisis by producing an additional 90mld of water.

Having the project on the government's priority list the Executive Committee of National Economic Council (Ecne) approved it in September 2003 and Prime Minister Khaleda Zia laid the foundation at the project site on October 6, 2003.

The project has been caught up in a bureaucratic tangle resulting from the tender invitation and evaluation process, since it was placed

before the Cabinet Purchase Committee meeting held in the capital on February 1 this year, sources said.

The technical evaluation committee (TEC) of the project sent the bids to the Cabinet Purchase Committee in late January this year after the pre-qualification and two other stages of the tendering process that started in May last year.

TEC recommended accepting the lowest bid offered by

Hearing to frame charges against Sunny deferred for fifth time

A Dhaka court could not frame charges against military commander of banned Jama'atul Mujahideen Bangladesh (JMB) Ataur Rahman Sunny and 10 others in two cases as five accused, including Sunny, were not produced before it yesterday.

The two cases were filed with Paltan and Khilgaon police stations under the Explosive Substances Act at different dates last year.

Judge Mohammad Shamsul Alam Khan of the First Additional Metropolitan Sessions Judge's Court fixed June 8 for framing charges against the accused and directed the authorities concerned to produce Sunny and others before it on that day.

HEROIN SMUGGLING

Probe team plans foolproof report

The five-member probe team into the heroin smuggling to the UK is preparing a detailed report to submit along with ample evidence to the home ministry to make it impossible for the traffickers to evade punishment.

"We intend to prepare a comprehensive report, so that officers who will investigate the case later cannot mislead it and the real culprits are duly punished," said a member of the CID-led team on condition of anonymity.

The investigation report was scheduled to be submitted yesterday. But the team missed the deadline, as it is still working on the report.

However, the probe team member said they do not have to seek a time extension from the home

WB for free NGO body, public disclosure of audit reports

The World Bank has suggested setting up an independent NGO Commission, making public disclosure of their audit reports and forming a uniform regulatory framework for them.

The bank made the suggestions in a report titled "Economics and Governance of NGOs in Bangladesh" that was released yesterday at the bank's Sher-e-Bangla Nagar office in Dhaka.

"We have proposed establishing the commission as an effective

option to regulate NGO activities," said Dr Shantayanan Devaranjan, chief economist of the WB's South Asia region.

The WB report praised the NGOs' contributions to health, education, women empowerment and many other sectors in Bangladesh over the last two decades or so.

Chief author of the report Hasan Zaman who presented the report later told reporters that the NGOs should not get involved in politics.

US resumes full ties with Libya

The United States restored full diplomatic ties with Libya on Monday, rewarding the longtime pariah nation for scrapping its weapons of mass destruction programmes and signalling incentives for Iran and North Korea if they do the same.

Culminating a years-long rapprochement with the Opec member, Washington will reopen an embassy and remove Libya from a list of state sponsors of terrorism within 45 days.

US-Libya relations turned around after Tripoli decided in December 2003 to give up its weapons programme, and the two
